In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Amalgamated National Health Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Fund amendments; administering the Fund; and determining that the Fund's transactions that are presented and disclosed in the financial statements are in conformity with the Fund's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Fund's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Report on Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The Schedule of Assets Held at End of Year and Schedule of Reportable Transactions together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year and Schedule of Reportable Transactions represent supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Fund's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1. DESCRIPTION OF THE FUND

The following brief description of the Amalgamated National Health Fund (the Fund) is provided for general information purposes only. Benefits and eligibility are determined in accordance with the Fund documents. Participants should refer to the Fund documents for a complete description of the Fund's provisions. The agreement and declaration of trust document was amended and restated effective as of January 1, 2016.

**General** - The Fund was formed to provide eligible participants, who are located throughout the United States, with life insurance, disability, health benefits (including hospitalization and surgical/medical benefits) and vacation benefits and to provide certain of these benefits for the eligible dependents of some such participants. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Benefits** - The Fund provides inpatient hospital benefits and other health care benefits which are administered through Amalgamated Employee Benefits Administrators, Inc., a related party. The Fund purchases life insurance coverage for participants under a group insurance policy issued to the trustees of the Fund and purchases disability insurance which is administered through Amalgamated Life Insurance Company (ALICO), a related party of the Fund. The Fund also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Fund utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Fund based on the Fund's actual utilization pattern of specific drugs.

**401(h) Account** - During 2000, the trustees of the Legacy Plan of the National Retirement Fund (the NRF) amended the plan to include a medical-benefit component in addition to monthly retirement benefits to fund a portion of the postretirement obligations for certain retirees and their beneficiaries in accordance with Section 401(h) of the Internal Revenue Code (IRC). A separate account has been established and maintained in the NRF for the net assets related to the medical benefit component (the 401(h) account). In accordance with IRC Section 401(h), the assets in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The related obligations for health benefits are not included in the NRF obligation, but are reported as obligations in the accompanying financial statements of the Fund.

## **NOTE 1. DESCRIPTION OF THE FUND (continued)**

**Contributions** - The Fund receives contributions as follows:

1. By employers under collective bargaining agreements with (i) UNITE HERE, (ii) Office and Professional Employees International Union, Local 153, AFL-CIO and (iii) Workers United, an SEIU affiliate, and/or their affiliates and former affiliates, for all the workers covered by the applicable agreements based upon:
  - A stated percentage of the weekly payroll;
  - A lesser percentage of the gross amounts paid by them to each of their contractors; or
  - A flat rate per worker (per capita)
2. By contractors under collective bargaining agreements with (i) UNITE HERE and (ii) Workers United, an SEIU affiliate, and/or their affiliates and former affiliates, for work performed by nonaffiliated employers and for which employers do not have responsibility to make payments.
3. By participants whose contributions consist of co-premiums for benefits and COBRA coverage.
4. Certain retirees are required to make contributions to the Fund in accordance with Fund documents.

These agreements are generally negotiated for multi-year periods with varying terms and employer contribution rates. Employer contributions are used to cover general and administrative and benefit expenses.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Fund's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported (IBNR), claims payable, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The investments of the Fund are managed by independent investment managers. Investments are carried at fair value. The valuation for mutual funds are carried at fair value which generally represents quoted market prices or the net asset value of the fund as of the last business day of the year as provided by the custodian. The investments in limited partnerships are carried at estimated fair value as determined by the partnership. The 103-12 investment entity and hedge funds of funds are carried at estimated fair value as determined by the investment managers. The investments in the common collective trust and housing investment trust are valued at their market value on the last business day of the year as established by the trusts. Short-term investments are carried at cost which approximates fair value.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Purchases and sales of securities are recorded on a trade date basis. Interest and dividends are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Hedge funds of funds, 103-12 investments entity: Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. These funds are subject to a third-party annual audit which provide NAV in their audited financial statements. These financial statements, and NAV, are confirmed during the plan's outside audit process. Some of these funds have various lock up periods and they are not immediately liquid investments.

**Securities Purchased or Sold and not Settled** - This represents the amounts due to or from the custodial bank for the purchase or sale of securities with trade dates prior to year end and settlement dates after year end.

**Allowance for Doubtful Accounts** - Employer contributions receivable includes receivables related to payroll audits conducted by the Fund to ensure that employers are remitting the correct amount of contributions in accordance with the applicable collective bargaining agreements. These receivables have been recorded net of management's estimate of what is deemed uncollectable. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was \$4,669,902 and \$5,084,667, respectively.

**Payment of Benefits** - Benefits are recorded when paid. Amounts for claims in the current year that were not paid as of year-end are included in total benefit obligations in the accompanying statements of benefit obligations and net assets available for benefits.

**Administrative Expenses** - Administrative expenses are paid from the Fund assets.

**Refunds** - Refunds due from the Fund's Pharmacy Benefits Manager (PBM) are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$12,721,848 and \$11,010,473 have been netted with claims paid in the accompanying statements of changes in benefit obligations and net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

**Claims Incurred but not Reported** - Fund obligations at December 31 for claims incurred but not reported are estimated by the Fund's actuary in accordance with accepted actuarial principles based on claims data provided by the Fund's administrators. These amounts are paid by the Fund only if claims are submitted and approved for payment.

### **NOTE 3. FUND TERMINATION**

Although the Trustees have not expressed any intention to do so, the Trustees have the right, under the Trust Agreement, to modify or reduce the benefits provided and/or to terminate or partially terminate the Fund subject to the provisions set forth in ERISA. If the Trustees terminate or partially terminate the Fund, or reduce benefits, some benefits may be fully or partially provided for by the then existing assets.

### **NOTE 4. TAX STATUS**

The Fund received an exemption letter in May 1945 in which the Internal Revenue Service stated that the Fund, as then designed, was in compliance with the applicable requirements of the IRC and was, therefore, exempt from federal income taxes under the provisions of Section 501(c)(9). The Fund has been amended since receiving the exemption letter. The Fund's administrator believes that the Fund is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Fund management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, fund tax years will remain open for three years; however, this may differ depending upon the circumstances of the Fund.

### **NOTE 5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

#### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 5. FAIR VALUE MEASUREMENTS (continued)**

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

- (a) The investment objective of the Housing Investment Trust is to generate competitive risk-adjusted total rates of return by investing in fixed-income investments, primarily multifamily and single family mortgage-backed securities and mortgage-backed obligations.
- (b) The investment objective of the fund is to produce attractive long-term risk-adjusted returns with low volatility and downside protection qualities, by allocating and reallocating the assets of the fund among a select group of non-traditional portfolio managers that invest or trade in a wide range of securities and other instruments including, but not limited to, equities and fixed income securities, currencies, commodities, futures contracts, options and other derivative instruments which may be listed or unlisted and rated or unrated.
- (c) The investment fund invests in a portfolio of defaulted bonds issued by the Republic of Peru. The investment fund is illiquid and can only be redeemed subject to the determination of the investment manager considering the investment fund's settlement with the Peruvian government.

## **NOTE 5. FAIR VALUE MEASUREMENTS (continued)**

- (d) The portfolios in which the fund may invest are generally expected to be highly illiquid. The fund expects to invest in a limited range of investment vehicles, including, but not limited to, distressed strategies funds, leveraged and whole loan funds, real estate related strategies funds, activist oriented strategies funds, and collateralized debt obligation recovery funds.
- (e) Shareholders have the right to redeem all or a portion of the applicable shares to the maximum extent permitted by the terms related to the fund's investments in underlying investment vehicles. The fund will not invest in any fund or investment vehicle that has an initial lock-up period of more than five years. Redemption, once permissible, shall take place as of the close of business on the last business day of any calendar quarter, or any other date determined by the Board. In order to effect a redemption, a shareholder shall be required to provide not less than 95 days' prior written notice of any such redemption request. Given the highly illiquid nature of the fund's investments, there can be no assurances that the fund will be able to obtain the proceeds necessary to fund a redemption on any applicable redemption date, particularly in the early years of the fund. There may be instances when the fund cannot effect a complete redemption from an underlying investment vehicle, in which case shareholders would receive a pro rate portion of a redemption request.
- (f) The investment objective of the limited partnership is to invest in financial instruments, majority of which is composed of domestic and foreign common stocks.
- (g) Redemption notice can be waived at manager's discretion.

## **NOTE 6. BENEFIT OBLIGATIONS**

The liability for claims payable, which includes claims incurred but not reported, is determined using case-basis evaluations and statistical analyses and represents estimates of the ultimate net cost of all claims incurred through December 31 of each year. Although considerable variability is inherent in such estimates, management believes the liability for claims payable is adequate. These estimates are continually reviewed and adjusted as necessary, as experience develops, or new information becomes known. Fund obligations at December 31, 2024 and 2023 for health claims incurred by active participants and covered dependents but not reported at that date and for eligibility credits of participants are estimated by the Fund's actuary in accordance with accepted actuarial principles.

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to participant coverage to December 31 (valuation date), reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired participants and (2) active participants after retirement. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's coverage by the Fund to the valuation date.

**NOTE 6. BENEFIT OBLIGATIONS (continued)**

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary from Cynomys, Inc. and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following were other significant assumptions used in the valuations as of December 31, 2024 and 2023:

**NOTE 7. TRANSACTIONS WITH RELATED PARTIES**

Certain members of the Board of Trustees are also board members of Alico Services Corporation which owns three subsidiaries: ALICO, Amalgamated Employee Benefits Administrators, Inc. and Amalgamated Medical Care Management, Inc. ("AMCM").

Accident and health benefits are administered for the Fund by Amalgamated Employee Benefits Administrators, Inc. Fund service expenses of \$29,400,000 and \$28,537,000 represent amounts charged by Amalgamated Employee Benefits Administrators, Inc. for administrative services conducted on behalf of the Fund for 2024 and 2023, respectively. The Fund also reimbursed Amalgamated Employee Benefits Administrators, Inc. for certain printing expenses in the amount of \$2,043 and \$4,842 in 2024 and 2023, respectively.

**NOTE 7. TRANSACTIONS WITH RELATED PARTIES (continued)**

Included in premiums paid are group life insurance premiums paid to ALICO of \$1,365,549 and \$1,543,592 for 2024 and 2023, respectively, and disability insurance premiums paid to ALICO of \$978,630 and \$1,118,364 for 2024 and 2023, respectively. Claims paid include fees for cost containment which are paid to Amalgamated Employee Benefits Administrators, Inc. and AMCM of \$5,768,370 and \$5,700,356 for 2024 and 2023, respectively.

The Fund receives administrative services from entities affiliated with UNITE HERE and Workers United, an SEIU affiliate. The Fund paid \$420,371 and \$214,506 to entities affiliated with UNITE HERE and Workers United, an SEIU affiliate, during 2024 and 2023, respectively.

Workers United, an SEIU affiliate, Office and Professional Employees International Union, Local 153, AFL-CIO, and various contributing employers have entered into participation agreements with the Fund pursuant to which they pay monthly premiums to the Fund and the Fund provides health and welfare benefits to certain active employees and, in some circumstances, retirees.

The Union Health Center (UHC) provides medical services for certain Fund participants and their dependents. UHC is an exempt organization under Section 501(c)(3) of the IRC, and its Board of Directors includes members of the Board of Trustees of the Fund. Payments are based on a flat monthly capita fee per member per month for medical services.

The Fund maintains a banking and custodial relationship and invests in various products sponsored by the Amalgamated Bank (the Bank). The Bank is a party in interest to the Fund and certain members of the Board of Directors of the Bank serve as union trustees of the Fund. The business between the Bank and the Fund is reviewed by an oversight committee of employer trustees of the Fund.

Included in due to affiliates is \$448,373 and \$398,584 owed to the Legacy Plan of the National Retirement Fund at December 31, 2024 and 2023, respectively. Also included in due to affiliates is \$171,140 and \$185,333 owed to the Adjustable Plan of the National Retirement Fund at December 31, 2024 and 2023, respectively.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 8. 401(H) ACCOUNT**

A portion of the Fund's obligations are funded through contributions to the NRF in accordance with IRC Section 401(h). The following table presents the components of the net assets available for such obligations and the related changes in net assets available.

**NOTE 10. FEES MANDATED BY THE PATIENT PROTECTION AND AFFORDABLE CARE ACT**

The Fund is subject to certain fees mandated by the Patient Protection and Affordable Care Act. Fees payable to the Patient-Centered Outcomes Research Institute (PCORI) are equal to \$3.47 and \$3.22 per covered life for the 2024 and 2023 calendar years, respectively. For the years ended December 31, 2024 and 2023, the Fund paid \$59,622 and \$56,195, respectively.

**NOTE 11. RISKS AND UNCERTAINTIES**

The Fund invests in various investments. Investments are exposed to various risks such as economic, interest rate, market and sector risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 12. SUBSEQUENT EVENTS**

The Fund's management has performed subsequent event procedures through October 13, 2025, which is the date the financial statements were available to be issued, and there were no other subsequent events requiring adjustment to the financial statements.
