Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of Plan

The following description of the Advanced Composites, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution (salary deferral) plan, covering all full-time employees of Advanced Composites, Inc. (the Company) who are age 18 or older and who have completed at least 90 days of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (the Code).

Contributions

A participant can elect to defer annually up to the amount allowed under the current Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan. The Company has adopted a safe harbor provision, which requires the Company to match 100% of the first 4% and 50% of the next 2% of a participant's contribution percentage. Company contributions are allocated to the participant-directed investment options pro-rata to participant contributions. The Company may also elect to make an additional discretionary match.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the employer's contribution and Plan earnings, and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may elect to receive investment advice or have their accounts managed by an investment advisor and their accounts are charged a fee for these services.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching contribution, plus actual earnings thereon. Vesting in the Company's matching contributions prior to January 1, 2016 and any additional discretionary Company contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 50% vested after the second year, 75% vested after the third year, and 100% vested after the fourth year. Participants terminating before then forfeit the right to the non-vested portion of the Company's matching and discretionary contributions and related earnings.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested interest, but not less than \$1,000, only for hardship or financial necessity. The loans are secured by the balance in the participant's account. The loan interest rate is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Note 1. Description of Plan

Payment of Benefits

On termination of services due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of services due to any other reason, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Withdrawals

A distribution may be made on account of an immediate or heavy financial need of the participant only if the distribution is on account of expenses incurred or necessary for medical care; purchase (excluding mortgage payments) of a principal residence for the participant; payment of tuition and related educational fees for the next 12 months of post-secondary education of the participant, their spouse, children, or dependents; or the need to prevent the eviction of the participant from their principal residence or foreclosure on the mortgage of the participant's principal residence.

Forfeited Accounts

Forfeited, non-vested account balances may be used to pay administrative expenses, reduce the Company matching contribution, or may be allocated as an additional matching contribution. Total forfeitures available for future use at December 31, 2024 and 2023 were \$279,734 and \$223,114, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes, and the disclosure of commitments and contingencies. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the Guaranteed Portfolio Income Fund (the Fund), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchase and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as contract administrator fees and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Note 2. Summary of Significant Accounting Policies

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participants may elect to receive investment advice or have their accounts managed by an investment advisor and their accounts are charged a fee for these services. The fees associated with this are included in the quarterly fund expense. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in contract administrator fees. Investment-related expenses are included in net appreciation in fair value of investments.

Note 3. Certification

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained from data that was prepared and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan.

- Investments at fair value (2023 only)
- Investments at contract value
- Net change in fair value of investments
- Interest
- Dividends
- Interest income on notes receivable from participants

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Note 4. Fair Value Measurements

The investment in the registered investment companies is valued at the daily closing price as reported by the funds. These funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The investment in the Fund is a group annuity contract stated at contract value, which is the amount a participant would receive upon withdrawal due to retirement, death, total or permanent disability, termination of employment, a participant loan, or attainment of age 62.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Guaranteed Portfolio Income Fund

The Fund is a group annuity contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is included in the statements of net assets available for benefits at contract value, which, according to Empower, approximates fair value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Empower. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable. However, there is a provision in the contract that prevents the immediate and full payout of the contract value for Plan-initiated transactions.

Note 6. Related Party and Party-in-interest Transactions

For the year ended December 31, 2024, Empower was paid \$307,385 in contract administrator fees. Empower is the recordkeeper for the Plan; therefore, this transaction qualifies as a party-in-interest transaction. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments because they are paid through revenue sharing rather than a direct payment.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan under the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8. Tax Status

The Plan adopted a prototype form of a plan sponsored by Empower Trust Company, LLC. The Company has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan.

Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Note 8. Tax Status

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Should the Plan incur penalties or interest, they would be included as such on the statement of changes in net assets available for benefits. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to IRS examination for years prior to 2021.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Transfer of Assets

During 2024, the Plan elected to change recordkeepers and custodians, which resulted in the transfer of Plan assets from Empower Trust Company, LLC (Empower) to Fidelity Management Trust Company (Fidelity). On December 31, 2024, the Plan's assets were liquidated and transferred from Empower to Fidelity, and on December 31, 2024, \$39,386,730 of investments at fair value and \$892,346 of loans were received by Fidelity. The remaining plan assets were held in a non-interest cash bearing account. Between January 2, 2025 and January 10, 2025, the remaining \$12,875,982 of assets were received by Fidelity and reinvested and allocated to the participants' accounts. Such amounts have been reported as uninvested cash on the statement of net assets available for benefits at December 31, 2024.

Note 11. Reconciliation with Form 5500

A distribution is a "deemed" distribution for Form 5500 purposes only if, under the terms of the Code, the Plan is unable to make a loan-offset distribution. The Code prohibits or limits in-service distributions to an active employee. Thus, the Plan may not offset an active employee's elective deferral account before the participant attains age 59 ^{1/2}. A reconciliation of the Form 5500 to the statements of net assets available for benefits as of December 31, 2024 and 2023 and the statement of changes in net assets available for benefits for the year ended December 31, 2024 for "deemed" distributions for Form 5500 purposes only is as follows:
