Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bennett, Bricklin & Saltzburg LLC 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Plan Description

The following brief description of the Bennett, Bricklin & Saltzburg LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and operates under Section 401(k) of the Internal Revenue Code (IRC). The Plan was established on September 1, 1992, amended and restated effective January 1, 2021, and covers all eligible employees (as defined) of Bennett, Bricklin & Saltzburg LLC (Company or Employer). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility

Every employee who is age 18 or older, except for temporary employees (as defined), is eligible to enter the Plan on the first day of employment. Participants are eligible to receive employer matching contributions and profit-sharing contributions.

Contributions - Participant Salary Deferral

Participants in the Plan may make pre-tax and Roth contributions at a discretionary amount of their annual compensation and bonus provided that the participant's contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (IRS) each year, which was \$23,000 for the year ended December 31, 2024. Employees 50 years or older may elect to defer additional amounts called "catch-up contributions," also subject to IRS limitations, which were \$7,500 for the year ended December 31, 2024, to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans called rollover contributions. In addition, the Plan has an automatic enrollment feature whereby participants who have not completed an enrollment or opt out form are automatically enrolled into the Plan with a 2% deferral once they meet eligibility requirements. Automatically enrolled employees may subsequently elect not to defer compensation under the Plan and may request a refund of their contributions if certain IRS requirements are met.

Employer Contributions

The Employer matches 100% of participants' elective contributions with a maximum annual match of \$500. The Plan allows for discretionary profit-sharing employer contributions. The Company did not make any profit-sharing employer contributions for the year ended December 31, 2024.

Vesting

Participants are immediately 100% vested in their own contributions and employer matching contributions plus actual earnings thereon. A participant vests in profit sharing contributions and earnings thereon 20% after two years of credited service and 20% per year for each additional year of credited service and is fully vested after six years of credited service. A year of credited service is earned for each plan year in which the participant completes at least 1,000 hours of service.

Forfeitures

A participant who terminates employment and is less than 100% vested in their account balance forfeits the non-vested portion of their account. Forfeitures are used to pay plan expenses or to reduce matching contributions of the Employer.

Participant Accounts

Individual participant accounts are credited with applicable participant contributions and related employer matching contributions and allocations of 1) employer profit sharing contributions and 2) plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Benefit Payments

The Plan provides benefits upon termination of employment, termination of service due to death, disability or retirement, or attainment of age 59½ while still employed. Generally, a participant may elect to receive the value of their vested interest in his or her account in either a lump-sum amount or a rollover to an eligible retirement plan. Plan provisions allow for involuntary distributions when a benefit election is not made as follows; participants who are no longer employed by the Company and who have a vested balance less than \$1,000 will receive a lump-sum payment, and participants who have balances between \$1,000 and \$5,000 will have their balances rolled into an Individual Retirement Account (IRA). Hardship withdrawals are available, as defined in the Plan Documents.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the federal prime rate plus 1% at the date of the loan. Loans, other than those used for the purchase of a principal residence, must be repaid within a period not to exceed five years. Principal and interest are paid through payroll deductions. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024.

On March 27, 2020, the "Coronavirus Aid, Relief, and Economic Security (CARES) Act" was signed into law. The CARES Act includes several relief provisions available to the Plan and its participants. Plan management has evaluated the relief provisions available to plan participants under the CARES Act and has implemented the following provisions:

- Loans taken during the 180-day period (between March 27, 2020, and September 22, 2020) related to COVID-19 will have an increased limit of the lesser of \$100,000 or 100% of participant's vested account balance.
- Special coronavirus distributions up to \$100,000. Such distributions must be processed and distributed by December 31, 2020.

Plan management intends to formally amend the Plan for these relief provisions no later than December 31, 2025.

Note 2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded (deemed distribution).

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results may differ from those estimates.

Subsequent Events

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC (John Hancock), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value of measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value fall into one of the three levels of the fair value hierarchy below and are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The following is a description of the valuation methodology used for assets measured at fair value:

- Pooled Separate Accounts: Valued at fair value based on the underlying assets, which represent the net asset value, of units held by the pooled separate accounts.
- Mutual Funds: Mutual funds are valued at quoted market prices in an active market.

There have been no changes in the methodology used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by John Hancock. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 8. Party-in-Interest Transactions

John Hancock is the trustee and record keeper, as defined by the Plan. Fees paid by the Plan for the investment management and administrative services to John Hancock were \$38,734. In addition, the Plan paid \$48,093 for investment advisory services to AXA Network, LLC for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt under the prohibited transactions rules.
