

For information included in the supplemental schedule that agreed to or is derived from the certified

investment information, we compared such information to the related certified investment information.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Hanceville Nursing & Rehab Center, Inc. 401(k) Plan (the “Plan”) provides only general information. Refer to Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Hanceville Nursing & Rehab Center, Inc. (the “Company”, “Sponsor”, “Employer”, or “Plan Administrator”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan. The Plan’s Trustees and management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services. Plan assets were held and managed by Nationwide Trust Company, FSB, the custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Plan management and Trustees and provides certain recordkeeping services. Economic Group Pension Services, Inc. acts as a third-party benefit and tax compliance consultant for the Plan, which performs certain plan Administrator and annual ERISA compliance testing.

Transfer to Principal Ease 401(k) Plan

During 2024, the Plan administrator approved the merger of this Plan into the Principal Ease 401(k) Plan, effective July 2, 2024. As a result, all investments were transferred from the Plan into the Principal Ease 401(k) Plan on that date. As a result, the Plan was effectively terminated. At the time of the transfer, there were outstanding employee and employer contributions due to the Plan. Following the transfer, these amounts will be remitted to the Principal Ease 401(k) Plan.

The plan obligations are not being settled with the participants, rather the plan assets and obligations are being transferred to another Plan. Accordingly, the Plan merger is not accounted for using the liquidation basis of accounting.

Eligibility

The Plan covered substantially all full-time employees excluding non-resident aliens who have not earned income from sources within the United States, union employees, leased employees, independent contractors and illegal aliens. The employees were required to also meet other requirements such as reaching twenty-one years old with a year of service. They then become eligible for participation in the Plan on the first entry date following the date the eligibility requirements are met. Entry dates were the 1st day of each plan quarter, coincident with the date the requirements are satisfied.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Contributions

Each year, participants may defer a percentage of pretax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a 401(k) Safe Harbor Plan. For each participant who made contributions during the plan year and was employed during the plan year, the employer will make a safe harbor matching contribution equal to 100% of the participant's deferral, not to exceed 4% of total compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company's Trustees and Plan Administrator.

During the period January 1, 2024 through July 2, 2024 (Date of Transfer), the Company contributed \$76,876 in employer matching contributions. There were no additional profit-sharing contributions for the period January 1, 2024 through July 2, 2024 (Date of Transfer). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's profit sharing or matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Safe Harbor matching contributions plus actual earnings thereon. Vesting in the Employer's discretionary non-safe harbor matching contribution account and profit-sharing contributions account is based on years of continuous service and the years of vesting service schedule as follows:

Years of vesting service	Vesting Percent
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

A participant's account becomes fully vested upon the participant's death, total disability, or attaining normal retirement age.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Benefit Payments

On termination of service due to disability or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Individuals entitled to receive a death benefit may elect to receive a lump sum payment or over the life or period of time not greater than the life expectancy of the beneficiary or time periods based on require minimum distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments generally are reported at fair value but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See notes 4 and 5 for further discussion of fair value measurements and contract value. The Plan's Trustees and management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and trust company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses attributable to the general Plan Administrator were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Employer.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

NOTE 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB, the qualified institution:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at July 2, 2024 (Date of Transfer) and December 31, 2023.
- b) Investment income information included in the statement of changes in net assets available for benefits, for the period January 1, 2024 through July 2, 2024 (Date of Transfer).
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All amounts included in Note 5, *Investments Reported at Contract Value*.

NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4: FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 2, 2024 (Date of Transfer) and December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. A fair value hierarchy table is not presented for the period ended July 2, 2024 (Date of Transfer) due to all investments being transferred out of the Plan.

NOTE 5: INVESTMENTS REPORTED AT CONTRACT VALUE

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract through Nationwide Trust Company, FSB, with no balance at July 2, 2024 (Date of Transfer) and totaled \$557,716 December 31, 2023. Nationwide Trust Company, FSB, maintains the contributions in a general account of Nationwide Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.5% gross interest rate. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5: INVESTMENTS REPORTED AT CONTRACT VALUE (Continued)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide Trust Company, FSB, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6: TAX STATUS

On June 30, 2020, the IRS stated in an opinion letter that the preapproved profit-sharing plan adopted by the Plan, as then designed, qualifies under IRC Section 401. The preapproved profit-sharing plan has been amended since receiving the opinion letter and the Plan has not received a determination letter specific to the Plan itself. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Nationwide Trust Company, FSB (Nationwide). Nationwide is the Trustee and record-keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid certain expenses related to Plan operations and investment activity to various service providers, as described in Note 1 and 2. These transactions qualify as party in interest transactions under ERISA.

NOTE 8: PLAN TERMINATION

As of July 2, 2024, the Plan transferred to the Principal Ease 401(k) Plan. See Note 1.

Note 9: NON-EXEMPT TRANSACTION

In eighteen instances during 2024, the Company experienced unintentional delays in the remittance of withheld participant contributions to the Plan which was not considered timely in accordance with the plan asset provisions of the Department of Labor (DOL) Regulation 2510.3-102, resulting in a prohibited (or a non-exempt) transaction. The aggregate amount of participant contributions in the late remittance was \$125,589. The accompanying Schedule of Delinquent Participant Contributions discloses this non-exempt transaction in accordance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is evaluating this non-exempt transaction, with consideration being given to the DOL's Voluntary Fiduciary Correction Program and funding the impacted Plan participants' accounts for earnings that would have been credited to the participants' accounts if the late remittance had been made on a timely basis.
