## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Trustees of  
ECI/CD 401(k) Plan  
Omaha, Nebraska

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ECI/CD 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ECI/CD 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ECI/CD 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ECI/CD 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## **ECI/CD 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the ECI/CD 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Engineered Controls, Inc. (The "Company"), who are at least 18 years old. Employees who meet the minimum age requirement are auto-enrolled in the Plan unless they opt to not participate. The Plan was established under Section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has established a Board of Trustees that is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### ***Contributions***

Participants may contribute a percentage of their eligible compensation to the Plan in the form of a payroll reduction up to the maximum percentage allowable by certain Internal Revenue Service Code Sections. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants that do not select a specific deferral percentage are auto-enrolled at a deferral rate of 6 percent of eligible compensation.

The Company made safe harbor matching contributions of 100 percent of the salary deferrals up to 3 percent of compensation, plus 50 percent of the salary deferrals that exceeds 3 percent up to 5 percent of compensation for all eligible participants for the year ended December 31, 2024. The Company may make discretionary profit-sharing contributions to the Plan as determined annually. Participants will receive an allocation of the Company's discretionary profit-sharing contribution based on the participant earnings. The Company made safe harbor matching contributions of \$445,697 and \$405,028 for the years ended December 31, 2024 and 2023, respectively. The Company did not make a discretionary profit-sharing contribution for the years ended December 31, 2024 and 2023.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's safe harbor matching and discretionary profit-sharing contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Plan expenses are calculated as a percentage of the value of the participant's account balance or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to make their own investment elections from the investment choices offered by the Plan. If a participant does not designate any investment options, all contributions to their account will be deposited into the Vanguard Target Retirement Funds based on the participant's birth year and an assumed retirement age of 67.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant will fully vest in the safe harbor matching contributions after two years of services. A participant will vest in the profit-sharing contributions on a six-year graduated vesting schedule. Participants will also fully vest in Company contributions if they terminate employment due to total and permanent disability or death.

## **NOTE 1 - DESCRIPTION OF PLAN (Continued)**

### ***Hardship Withdrawals***

Hardship distributions are permitted from accounts which are 100 percent vested.

### ***Forfeitures***

Any forfeiture arising under the Plan can be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the plan. Forfeitures of \$9,685 and \$7,216 were used to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively. There were unused forfeitures of \$8,271 and \$0 as of December 31, 2024 and 2023, respectively.

### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000, or 50 percent of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The term of the loan may exceed five years for loans used to acquire a principal residence. Participants may have maximum of two loans outstanding at a time.

### ***Payment of Benefits***

On termination of service, a participant may elect to receive either a single lump-sum payment, an installment payment over a period of not more than their assumed life expectancy, or partial withdrawals. The amount paid is equal to participant's contributions and earnings thereon plus their vested share of the Company's contributions and earnings. If no election is made by the participant upon termination, accounts with a vested balance of less than \$5,000 will be distributed regardless of whether the participant consents to receive it or not.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ significantly from those estimates.

### ***Investment Valuation and Income Recognition***

The investments in all of the funds are presented at fair value, based on the quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion regarding the valuation methodology used by the Plan.

The net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses on the fair value of the investments held by the Plan during the year. Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued as it is earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Payments of benefits are recorded when paid.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions in accordance with the terms of the plan agreement. For Department of Labor reporting on Form 5500, the receivables are still included as investments and titled Participant Loans. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

## **NOTE 3 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

John Hancock Life Insurance Company held the Plan's investment assets and executed investment transactions. John Hancock Life Insurance Company also manages investments inside the Plan and receives compensation for these management services. Benefit Plan, Inc. acts as the third-party administrator and the Plan uses their fiduciary services. The Plan Trustee is set forth in the Plan Adoption Agreement. The Plan uses the services of an outside investment consultant, WealthPlan Partners, LLC and Wealth Plan Investment Management, and incurs fees related to investment consulting. These transactions qualify as exempt party-in-interest transactions. The total fees paid by the Plan for these administrative and investment-consulting services amounted to \$39,580 and \$33,457 for the years ending December 31, 2024 and 2023, respectively.

The Plan also incurs fees for the annual audit. The Plan Sponsor, Engineered Controls, Inc., pays these fees. These transactions qualify as exempt party-in-interest transactions.

## **NOTE 4 - TAX STATUS OF THE PLAN**

The Plan has adopted a volume submitter plan that was sponsored by Benefit Plan, Inc. The volume submitter plan has received an opinion letter from the Internal Revenue Service as to its qualified tax status, and is, exempt from federal income taxes. The volume submitter plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since, the plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the income tax code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### NOTE 4 - TAX STATUS OF THE PLAN (Continued)

The Plan's policy is to include penalties and interest associated with income taxes as income tax expense and interest expense, respectively. The Plan did not incur any penalties, interest, or income taxes for the periods being reported.

#### NOTE 5 - INFORMATION CERTIFIED BY THE CERTIFYING ENTITY (UNAUDITED)

The Plan's investments were held by John Hancock Life Insurance Company. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by John Hancock Life Insurance Company as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

John Hancock Life Insurance Company also certified to the completeness and accuracy of \$1,604,475 and \$1,599,758 of net appreciation, respectively, in fair value of investments, and \$21,670 and \$12,317 of interest on notes receivable from participants related to the aforementioned assets for the years ended December 31, 2024 and December 31, 2023, respectively.

#### NOTE 6 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 6 - FAIR VALUE MEASUREMENTS (Continued)**

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

Registered investment companies/mutual funds held in pooled separate accounts

The Plan’s interest in each of the pooled separate accounts is evidenced by “units”. Units of a separate account function and perform in the same way as shares in a mutual fund in that the unit values fluctuate up or down in accordance with the value of the underlying investment, cash-flow into or out of the separate account, increases or decreases in the number of units, not the underlying value of the investment directly. The unit value is calculated by dividing the total value of the assets in the separate account by the number of units in the separate account. In addition to the unit value fluctuating due to changes in the value of the separate accounts underlying investments, it is affected by dividends and capital gain distributions from the separate account’s underlying investments and other charges such as expenses related to the administration and investment management of the separate account.

The preceding methods may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 - STABLE VALUE ACCOUNT**

John Hancock Stable Value Fund (the Fund) is an investment option within the Group Annuity Contract. The fund's subaccount is invested into John Hancock Stable Value Fund Collective Investment Trust (JH CIT). It should be noted that the JH CIT may, in some cases, defer payment and may not necessarily redeem its units at \$1 per unit in all cases. The JH CIT is fully benefit responsive and because that is the sole investment of the John Hancock Stable Value Fund, the Fund is also considered fully benefit responsive by the Plan.

**NOTE 8 - JOHN HANCOCK LIFE INSURANCE COMPANY GROUP ANNUITY CONTRACT**

In 2017, the Plan entered into a qualified retirement plan that is funded with a group annuity contract (the contract) issued by John Hancock Life Insurance Company. The contract offers participants the opportunity to invest in subaccounts or separate accounts. Under the contract it is possible to make transfers between the various subaccounts and to redirect the investment of future contributions as specified by the governing Plan document and contract provisions.

Amounts allocated to a subaccount within John Hancock USA separate account are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of business each day and is directly related to the net asset value of the shares of the underlying investment adjusted for any dividends or distributions received and the daily equivalent of any fee charged pursuant to the contract. The value of each accumulation unit is published each business day. Each investment account is invested exclusively in the shares of a specific mutual fund or several mutual funds. The contract value is equal to the value of the accumulation units of that investment account that are credited to the participant's account.

The group annuity contract is not fully benefit responsive and therefore is reported at fair value.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the employer accounts of each affected participant would become fully vested.
