Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Employment Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Employment Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Employment Services 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Employment Services 401(k) Plan (the “Plan”) only provides general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and has no material subsequent events to report.

General

The Plan is a defined contribution plan covering all eligible employees of Employment Services, LLC (formerly Employment Services, Inc.) and its affiliates (Company, Employer, or Sponsor). The Plan is qualified under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all full-time employees of the Company who have completed one year of service and attained age 21.

Contributions

Participants may make pretax contributions and Roth contributions to the Plan up to the maximum percentage allowable by the IRC. Plan limits are indexed to follow changes in the federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Roth deferrals are also permitted by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and a guaranteed interest account as investment options for participants.

The Employer may elect to make a flexible discretionary matching contribution to the Plan for all eligible employees, excluding highly compensated employees. Discretionary contributions, if any, are determined annually by the Employer. Each participant’s share of the flexible discretionary contribution is equal to a percentage of the participant’s salary deferral. During 2024, the Employer’s flexible discretionary match was 38% for the first 8% of the employee’s salary deferral.

The Employer may also elect to make a profit-sharing contribution to the Plan for all eligible employees, excluding highly compensated employees. Profit-sharing contributions, if any, are determined annually by the Employer. The employee’s share of the profit-sharing contribution is based on the proportion of the employee’s compensation to the total compensation for all eligible participants. During 2024, the Employer did not make any profit-sharing contributions to the Plan.

Participant Accounts

Each participant account is credited with the participant’s contribution and an allocation of (a) the Employer’s flexible discretionary matching contribution, if any, (b) the Employer’s profit-sharing contributions, if any, (c) Plan earnings (losses), based upon investment options selected by participants, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and associated earnings thereon. Vesting in Employer profit sharing and matching contributions are based on years of service. A participant must have at least 1,000 hours of service during a Plan year to earn a year of service. Each participant's vesting schedule in the Company's discretionary profit-sharing is as follows:

Notes Receivable from Participants

The Plan allows for participant loans. The maximum amount of any loan is the lesser of: (i) 50% of the participant's vested account, reduced by any outstanding loan balance or (ii) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Loans must be repaid in level payments through payroll deductions over a five-year period unless for the purchase of a principal residence, in which case the note repayment period shall be limited to a 30-year period. Participant loans outstanding at December 31, 2024 have interest rates of 4.00% to 8.50%.

Payment of Benefits

Participants receive benefit payments based on the vested portion of their account balance upon death, retirement or attainment of age 59½, disability, or termination of employment. Benefit payments in amounts defined by law as "required minimum distributions" must commence by the latter of age 73 or retirement. All benefits other than "required minimum distributions" may be paid in the form of a lump sum, or in installment payments over a period not to exceed the participant's and beneficiary's expected life expectancies.

Participants may request a distribution of a portion of their contributions in the event of a documented financial hardship. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law.

Forfeited Accounts

Forfeited accounts will first be used to reduce future Employer contributions. Any excess remaining will be used to pay Plan Administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,657 and \$685, respectively. During the year ended December 31, 2024, \$35,937 and \$99 of forfeitures were used to reduce employer contributions and pay Plan administrative expenses, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's guaranteed interest account is deemed to be fully benefit responsive at December 31, 2024, and 2023.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Investment Income

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are determined on the basis of specific identified cost. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Participant loans are presented at their unpaid principal balance plus accrued interest. Interest income is recognized monthly on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Loans are deemed in default if any scheduled loan repayment is made by the end of the calendar quarter following the quarter in which the missed payment was due.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Plan's custodian and third-party administrator charge various administrative fees relating to recordkeeping services performed under contract to the Plan. Under no circumstances will compensation be paid by the Plan to the Employer for services rendered as administrator. Certain expenses of maintaining the Plan may be paid by the Employer. The Employer paid approximately \$16,000 in operating expenses on behalf of the Plan during the year ended December 31, 2024.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Codification Topic 820 are described as follows:

Level 1 - Inputs in the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

Quoted prices for similar assets in active markets.

Quoted prices for identical or similar assets in inactive markets.

Inputs other than quoted prices that are observable for the asset.

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Pooled separate accounts: Valued at unit value calculated based on the net asset value of the underlying investments. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

NOTE D - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a benefit-responsive guaranteed interest account with Principal Life Insurance Company (Principal) through a group annuity contract. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Principal considers this investment option to be fully benefit-responsive notwithstanding the liquidation value events (see below) under the contract that limit the ability of the Plan to transact at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. As of December 31, 2024 and 2023, the crediting rates were 4.35% and 5.55%, respectively. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. Consult the Plan's group annuity contract for further information. The Plan administrator believes that it is not probable that events may occur that will limit the ability of the Plan to transact at contract value with the issuer.

NOTE E - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and its affiliates, qualified institutions, have certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

NOTE F - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer may discontinue its contributions to the Plan at any time and terminate the Plan subject to regulations under ERISA. In the event of a Plan termination, participants will become 100% vested in their entire account balance.

NOTE H - COMMITMENT

The Plan's investments include \$2,312,612 allocated to participants who have withdrawn from the Plan as of December 31, 2024 but have not yet been paid. These participants may elect to withdraw their vested balances at any time.

NOTE I - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRS. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE J - PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are managed by the Principal Life Insurance Company and its affiliates, which is the custodian and record keeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions.
