Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CSAT Solutions LP 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of CSAT Solutions LP 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan was established on August 14, 1995, by Peripheral Computer Support, Inc., subsequently renamed to CSAT Solution LP (the Company) to provide benefits to eligible employees, as defined in the plan document. The Plan is a defined contribution plan available to all employees upon joining the Company, who are 21 years of age or older and who are not nonresident aliens, leased employees, independent contractors or employees of an independent contractor or members of a collective bargaining agreement. On December 30, 2022, USOC Biomedical, LLC, an affiliate of the Company, adopted the Plan upon the merger of the USOC Biomedical, LLC 401(k) Plan into the Plan. The Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and certain provisions of the Internal Revenue Code (IRC).

Contributions: Participants may elect to defer and contribute to the Plan up to 100% of their eligible compensation, subject to a limitation imposed by the IRC. Participant salary deferral contributions can be made either on a pretax basis or as Roth elective deferrals on an after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make additional tax deferred catch-up contributions to the Plan. Effective January 1, 2024, the Plan was amended to disallow highly compensated employees from making elective deferrals into the Plan and receiving employer match. An exception was made for highly compensated employees age 50 are older who are allowed to make elective deferral catch-up contributions. The amount of a participant's annual compensation which may be taken into account for purposes of determining the amount of the employer match or for any other purpose under the Plan shall not exceed the amount permitted annually by Internal Revenue Service (IRS) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). All eligible employees are automatically enrolled in the Plan at a contribution rate of 6% of their eligible compensation within 60 days after initial satisfaction of eligibility requirements. The employer match is discretionary and allocated as a uniform percentage of employee contributions. For the plan year ended December 31, 2024, the Company matched 100% of an employee's deferral up to 3% of their eligible compensation plus 50% of an employee's incremental deferral up to 5% of their eligible compensation.

Investment options: Upon enrollment in the Plan, participants may direct the investment of their account balance into various mutual funds available through the Empower Trust Company, LLC.

Participant accounts: Accounts are separately maintained for each participant. Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contributions, (b) plan investment earnings or losses and (c) administrative expenses that are paid by the Plan. Allocations are based on participant contributions, earnings, account balances, of specific transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of the Plan (Continued)

Vesting: Participants are immediately vested in their voluntary contributions, rollover contributions and safe harbor match contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary matching contributions plus actual earnings or losses thereon is based on years of continuous service. The vesting schedule is as follows:

Eligible employees of USOC Biomedical, LLC who were eligible to participate in the Plan as of January 1, 2023, are 100% vested in their employer accounts.

Payment of benefits: Participants are eligible to receive distributions from the Plan upon reaching normal retirement age, termination of service or death. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed.

Forfeitures: Forfeited accounts are used to pay administrative expenses and or fund future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$12,782 and \$9,266, respectively. During 2024, \$15,080 was used to fund employer matching contributions and \$52,362 was used to pay administrative expenses.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Participants will only be allowed to have one outstanding loan at any time. The loan is secured by the vested balance in the participant's account and bears fixed interest at the available market financing rates for similar loans from commercial lending institutions at the date of loan. Principal and interest are paid ratably through semimonthly payroll deductions and any outstanding loan will become due and payable upon termination of employment. The loan term must not be longer than five years unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be longer. All interest paid to the Plan with respect to a note is credited to the borrower's account balance. Principal and interest are paid ratably through payroll deductions. Interest rates on notes outstanding at December 31, 2023 and 2024, range from 4.25% to 10.50% and mature through August 2031.

Administrative expenses: Certain administrative functions are performed by officers or employees of the Company. However, such employees and officers receive no compensation from the Plan. Certain other administration expenses are paid directly to the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on an accrual basis of accounting.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are recorded as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions: Participant contributions and matching contributions on participant contributions are recognized in the period the participant contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

During the year ended December 31, 2024, the Plan made corrective distributions totaling \$156,010 to employees in connection with failed Actual Contribution Percentage (ACP) nondiscrimination tests for the plan years ending December 31, 2018 through December 31, 2023. The corrective distributions included both excess contributions and attributable earnings, calculated in accordance with IRS guidelines. These amounts are reported as benefits paid to participants in the statement of changes in net assets available for benefits.

Subsequent events: The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 13, 2025, the date the financial statements were available to be issued.

The trustee also certified to the completeness and accuracy of \$1,374,929 of net appreciation in the fair value of mutual funds, \$494,154 of dividends and interest, and \$17,171 of interest income on notes receivable from participants related to the aforementioned assets for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy as defined by ASC 820 are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 1.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 6. Related-Party and Party-In-Interest Transactions

Parties in interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the Company and certain others. As such, transactions conducted with the Company and the trustee qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions. The Plan has administrative expenses amounting to \$34,239 that have been paid out to the trustee during the year.

Note 7. Income Tax Status

The Plan adopted a nonstandardized form of a preapproved plan sponsored by California Retirement Plans Inc. The preapproved plan has received an opinion letter dated June 30, 2020, from the IRS as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.
