INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Therm-Tech of Waukesha, Inc. 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Therm-Tech of Waukesha, Inc. 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplementary information, which comprise the supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of delinquent participant contributions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Therm-Tech of Waukesha, Inc. 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include the plan administrator's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 11, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Therm-Tech of Waukesha, Inc. is the plan sponsor, employer and plan administrator. Throughput Consulting, Inc. is a participating employer. EPIC Retirement Plan Services ("EPIC") is the third party administrator that maintains participant records and plan documents, and tax counsel that performs various compliance tests. Matrix Trust Company ("Matrix") is the trustee of the plan that holds custody of plan investment assets and maintains plan records. Cleveland Hauswirth Investment Management, Inc. is the investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings from investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Descriptions of the valuation methodologies used for investments measured at fair value are as follows:

Money market and mutual funds - Valued at the daily quoted market prices as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trust - The common/collective trust held by the plan is a direct filing entity and is valued at its NAV. The NAV is used as a practical expedient to estimate fair value and is generally based on the fair values of the underlying investments held by the common/collective trust less its liabilities. The practical expedient would not be used if it is determined to be probable that the common/collective trust would sell the investment for an amount different from the reported NAV.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

December 31, 2024 and 2023

General - The plan was established on December 1, 1985 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees over the age of 18 are eligible to participate in the plan on the first day of the month immediately following the date of hire or after turning age 18.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Upon meeting eligibility requirements, new employees are automatically enrolled in the plan and have 2% of their compensation withheld as elective deferral contributions. These participants' elective deferral percentages then automatically increase by 1% each year until they reach a maximum of 6%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Matching contributions may be made at the employer's discretion. The employer elected to contribute employer discretionary matching contributions equal to 50% of the first 4% of participants' deferrals, up to 2% of eligible compensation during 2024 and 2023. These contributions are funded coinciding with each payroll with an annual true-up contribution.
- d. Additional employer contributions may be made at the discretion of the employers' boards of directors. No such contributions were made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of the employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their employee elective deferral and rollover contributions and related earnings. Participants are also always 100% vested in safe harbor matching contributions that were made in previous years and related earnings. Participants begin vesting in employer discretionary contributions and related earnings upon two years of service at which time they are 40% vested. The participant then vests at the rate of 20% for each year thereafter.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or upon attaining the age of 59 ½ (in-service withdrawals). Participants can receive their distributions in the form of a lump sum, partial withdrawals, or installments. Hardship withdrawals are permitted under certain circumstances.

Forfeitures - Forfeited nonvested accounts can be used to pay plan administrative fees or reduce employer contributions. Forfeitures used to reduce employer contributions were \$2,000 in 2024 and \$5,000 in 2023. Unapplied forfeitures were \$22,000 and \$4,000 as of December 31, 2024 and 2023.

Administrative fees - Certain administrative costs of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses generally consist of participant directed charges for distribution and loan processing fees paid to EPIC.

In addition, Matrix and EPIC provide certain administrative services to the plan pursuant to service agreements between the parties. Matrix and EPIC receive revenue in the form of indirect compensation from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts that may otherwise be owed by the plan to Matrix and EPIC for administrative services provided to the plan.

Notes receivable from participants - Participants may obtain loans from their accounts with the approval of the plan administrator. The maximum loan amount is the lesser of \$50,000 or 50% of the vested account balance. There is no minimum loan amount. Participants may have up to five loans outstanding at any given time. The maximum loan term for is five years. Under a previous loan policy, the loan terms were allowed to be extended if the loan proceeds are used to purchase a primary residence. As of December 31, 2024, the notes receivable from participants have various repayment schedules through April 2034 with interest rates from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all discretionary employer contributions and related earnings.

4. INCOME TAX STATUS

The plan is operating under an EPIC Advisors Inc. non-standardized pre-approved profit sharing plan ("the EPIC plan") which received its most recent favorable opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the EPIC plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. EXEMPT AND NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, the plan sponsor, EPIC and Matrix qualify as party-in-interest transactions. Notes receivable from participants' transactions also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

During 2024, the plan sponsor remitted certain employee elective deferral contributions later than required by Department of Labor Regulation 2510.3-102. The plan sponsor will calculate and remit lost earnings related to the late contributions in 2025 to account for the investment income that would have been earned had the contributions been remitted on a timely basis. In addition, the plan sponsor will file the Internal Revenue Service Form 5330 and pay the associated excise tax.

6. INFORMATION CERTIFIED BY MATRIX

Management has obtained certifications from Matrix, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such and noninterest-bearing cash as of December 31, 2024 and 2023;
- b. Dividends and interest income from investments and net appreciation (depreciation) in the fair value of investments during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases and sales of investments and inter-fund transfers between investments during 2024 and 2023.
