### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Armed Forces Insurance Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor’s Responsibilities for the Audit of the Financial Statements***

Except as described in the “Scope and Nature of the ERISA Section 103(a)(3)(C) Audit” section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matters- Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Armed Forces Insurance Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** — The Plan is a defined contribution plan covering substantially all employees of Armed Forces Insurance Exchange (the “Company”) and its subsidiaries. Participants become eligible to participate in the Plan the first day of the quarter following date of hire. Participants also become eligible for the Company’s matching contribution and the non-elective safe harbor contribution the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or following the completion of one year of service, as defined in the Plan. Effective May 1, 2022, in addition to the years of service requirement, participants must be 20 years of age to be eligible for the non-elective safe harbor contribution. The Plan Administrator Committee controls and manages the operation and administration of the Plan. Ascensus Trust Company serves as the trustee of the Plan, and Ascensus, LLC is the recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective May 1, 2022, the Plan approved a restatement of its Adoption Agreement associated with a pre-approved plan document provided by Ascensus, LLC.

**Contributions** — Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. The Company contributes 100% of the first 6% of pre-tax or Roth after-tax employee contributions. The Company also contributes a non-elective safe harbor contribution of 4% of compensation.

Additional amounts may be contributed at the discretion of the Company’s Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, all participants who are eligible to make elective deferrals under this Plan and have attained age 50 before the close of the Plan year are eligible to make catch-up contributions in accordance with the Plan document.

The auto enrollment provision provides that those newly eligible participants who do not complete a valid enrollment form will be automatically enrolled with a 6% salary deferral effective with their initial eligibility date. Salary deferrals for these participants are invested in the Target Date Fund closest to the individual participant’s normal retirement date. Effective January 1, 2024, the Plan was amended to allow Plan participants to make flexible contribution election changes. Previously, participants were restricted to making such elections changes on a quarterly basis only.

The auto escalate provision applies to all participants with a current deferral of less than 10%, with the exception of those participants who have made a deferral election of 0%. Unless making an election to opt out of the auto escalate provision, participants with a deferral of less than 10% will have that deferral percentage increased by 1% effective with the first pay period of March in each Plan year, until the percentage reaches 10%. Participants impacted by the auto escalate provisions of the Plan may change their deferral percentage at the beginning of the next quarter (this deferral change provision applies to all participants).

**Participant Accounts** — Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of the Company's non-elective safe harbor contributions and discretionary contributions, and Plan earnings, and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments** — Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions, the Company's non-elective safe harbor contributions, and discretionary contributions are invested in the same options selected by the participant for their elective deferral contributions. The Plan currently offers a variety of mutual funds, including target retirement date funds for periods 2020 through 2065, as investment options for participants.

**Vesting and Forfeited Accounts** — Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are immediately vested in their non-elective safe harbor contributions, plus earnings thereon. A participant becomes 100% vested in Company matching contributions, and discretionary contributions after three years of credited service. Non-vested amounts of the matching contributions portion and discretionary contributions portion of a participant's account which are forfeited are used to reduce any Company contributions. As of December 31, 2024 and 2023, there were \$13,258 and \$4,478, respectively, of forfeitures available to reduce the Company's future contributions. There was \$4,478 used to reduce the Company's contributions during the 2024 plan year.

**Notes Receivable from Participants** — Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined quarterly by the Plan trustee. Principal and interest is paid ratably through payroll deductions. Loan terms shall not exceed five years. Participants may not have more than two loans outstanding at any time. As of December 31, 2024, participant loans have maturities through 2029 at an interest rate of 5.75% - 9.50%.

**Payment of Benefits** — Upon termination of service, if a participant's vested benefit in the Plan does not exceed \$1,000, then the vested benefit will be distributed in a single lump-sum payment. If the participant's vested interest in the Plan exceeds \$1,000 but not \$7,000, the distribution will be made in a lump-sum to an IRA unless the participant directs either a single lump-sum payment or installments over a period of not more than the participant's assumed life expectancy. If the participant's vested interest in the Plan exceeds \$7,000, then the participant must consent to the distribution.

**Qualified Retirement Plan Excess Funds** – Effective March 1, 2024, the Company terminated its Pension Plan. Excess funds of \$4,589,849 were transferred into the Plan, which is considered a qualified retirement plan in accordance with IRS regulations. These funds will be used for profit-sharing and safe harbor employer contributions over a period of not less than seven years.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties** — The Plan primarily utilizes mutual funds as investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition** — The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Administrative Expenses** — Administrative expenses of the Plan are paid by the Company as provided in the Plan document. Participants pay administrative costs for loans and distributions.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits** — Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

### 3. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

The valuation methods as described in Note 2 may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

## **5. FEDERAL INCOME TAX STATUS**

The Plan used a prototype plan document sponsored by McGrath North Mullin and Kratz, PC LLO. McGrath North Mullin and Kratz received an opinion letter from the Internal Revenue Service (IRS), dated December 1, 2014, which stated that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). Effective May 1, 2022, the Plan restated their plan document and uses a prototype plan document sponsored by Ascensus, LLC. Ascensus, LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provision of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Company and the plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **6. INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator Committee has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, as agent for Ascensus Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

## **7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$1,080 of recordkeeping fees during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

**8. NET ASSETS BY PARTICIPANT – AND NONPARTICIPANT – DIRECTED INVESTMENTS**

In December 2024, the plan sponsor terminated a qualified retirement plan and transferred \$4,589,849 to the Plan (see Note 1). The funds are held in non-interest bearing cash with the balance to be used for future Company contributions. During the year ended December 31, 2024 there was no significant or material activity from the nonparticipant-directed investments.

**9. SUBSEQUENT EVENTS**

For the year ended December 31, 2024, subsequent events were evaluated through October 8, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Company amended its Plan whereby it reduced its match from 100% of the first 6% of pre-tax or Roth after-tax employee contributions to 100% of the first 3% of pre-tax or Roth after-tax employee contributions. In addition, the Company makes a profit-sharing contribution of 3% of compensation. All employees eligible for the safe harbor contribution are eligible for the profit-sharing contribution.

Effective January 1, 2025, the Company amended its Plan to allow Roth elective deferrals by participants and added options for In-Plan Roth Rollovers which allow eligible participants to change the tax nature of pre-tax and non-Roth after-tax assets to Roth rollover assets.
