## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Patriot Federal Credit Union Retirement Pension Plan  
Chambersburg, Pennsylvania

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Patriot Federal Credit Union Retirement Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for pension benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for pension benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Patriot Federal Credit Union Retirement Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Patriot Federal Credit Union Retirement Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Patriot Federal Credit Union Retirement Pension Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Patriot Federal Credit Union Retirement Pension Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Patriot Federal Credit Union Retirement Pension Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule H, Part IV, line 4i – Schedule of Assets (Held at Year End) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **NOTE 1 DESCRIPTION OF PLAN**

---

The following brief description of the Patriot Federal Credit Union Retirement Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined benefit pension plan covering all eligible employees of the Patriot Federal Credit Union ("Employer" or the "Credit Union"). Employees are eligible to participate in the Plan on the Plan's anniversary date following the completion of a six month period of service and reaching age 20. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended, effective December 31, 2019, with regards to employees who are hired or rehired after December 31, 2019, to freeze entry into the Plan. No employee, former employee, or inactive participant will become an active participant after such date.

Additionally, the Plan was amended, effective September 30, 2020, to freeze the Plan. No additional benefits will accrue after September 30, 2020.

The Plan is administered by the Credit Union's Executive Committee (Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### ***Funding Policy***

The Plan's funding policy is for the Credit Union to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023 the Plan was over funded and therefore the Credit Union was not required to make additional contributions to the Plan. Any available accumulated funding credit is considered when determining the level of contribution. The Credit Union's contributions for 2024 and 2023 equaled or exceeded the minimum funding requirements of ERISA. There are no required participant contributions, nor are there any voluntary contributions permitted by the participants under the Plan.

Although it has not expressed any intention to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

#### ***Pension Benefits***

For employees hired before January 1, 2019 the Plan provides for normal retirement benefits at the age of 65 equal to 55% of average compensation (as defined by the Plan). Pension benefits are reduced on a pro-rata basis for each year of credited service less than 20 that the participant is credited with at the normal retirement date. For employees hired on or after January 1, 2019 the Plan provides for normal retirement benefits at age 65 equal to 1.25% of average compensation multiplied by accrual services years on such date, plus 0.67% of average compensation in excess of integration level multiplied by accrual service years on such date.

***Pension Benefits (continued)***

The Plan also provides options for early retirement at the age of 55 with 5 years of service and late retirement. Early retirement benefits are equal to the participant's vested accrued benefit reduced by 1/15 for each of the first five years of service and then 1/30 for each of the next 5 years of service that the early retirement date precedes the normal retirement date. Pension benefits for late retirement are calculated the same as normal retirement benefits. Participants are 100% vested as a result of death, disability, or if employed on or after their normal retirement age as defined by the Plan document. Participants that terminate employment prior to their normal retirement age for reasons other than death or disability are entitled to a percentage of their accrued benefits as defined in the vesting schedule as follows: less than 5 years of service 0% vested; 5 or more years of service 100% vested.

Prior to October 1, 2023, participants may elect to receive the value of their accumulated plan benefits through 2003 as a lump-sum distribution upon retirement or termination, or they may elect to receive their benefits as a life annuity payable monthly from retirement. Participants may only receive the value of their accumulated plan benefits subsequent to 2003 upon retirement or termination as a life annuity payable monthly from retirement.

Effective October 1, 2023, participants (including a participant who became an inactive participant before October 1, 2023) may elect to receive the value of their accumulated plan benefits as a lump-sum distribution at any time after the participant has a severance from employment and before the participant's retirement date, provided the participant has not again become an employee. They may also elect to receive their benefits as a life annuity payable monthly from retirement.

***Death and Disability Benefits***

Upon a participant's death, the Plan benefit is equal to the present value of the vested accrued benefit. Upon the disability of a participant, the Plan benefit is equal to the early retirement benefit without regard to age and service requirements.

***Small Amount Payments***

If the present value of the participant's vested accrued benefit does not exceed \$5,000, and the Participant has not had an annuity starting date with respect to any portion of such vested accrued benefit, the present value of the participant's entire vested accrued benefit shall be distributed as of the earliest of the participant's retirement date, the date the participant dies, or the date the participant has a severance from employment for any other reason. If the present value of the participant's vested accrued benefit is \$1,000 or less, the present value of the participants entire vested accrued benefit shall be paid directly to the participant, unless the participant elects otherwise. Accounts greater than \$1,000 but less than \$5,000 will be paid as a direct rollover into an individual retirement account designated by the plan administrator unless the participant elects otherwise. Effective January 1, 2024, the small amount payment threshold was increased from \$5,000 to \$7,000.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

The following are the significant accounting policies followed by the Plan:

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Credit Union's Executive Committee determines the Plan's valuation policies utilizing information provided by investment advisers and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Plan's expenses are paid either by the Plan or by the Credit Union, as provided by the plan document. Expenses that are paid directly by the Credit Union are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for pension benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for pension benefits.

**NOTE 3 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

---

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Refer to Note 1 for benefit provisions of the Plan. Benefits under the plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances – retirement, death, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of January 1, 2025 and 2024 were:

(1) Life Expectancy of Participants Pre/Post Retirement	Pri-2012 total dataset base rate mortality table projected generationally using MP-2021 (2025 and 2024)
(2) Investment Return	4.50% (2025 and 2024)
(3) Retirement Age	Normal Retirement Age

The foregoing actuarial assumptions are based on the presumption that the plan will continue. Were the plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, there would be no material differences.

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- The portion of your Accrued Benefit which is derived from your contributions made to the Plan, if any.
- Equally among:
  - Retired participants and their beneficiary to whom payment commenced at least 3 years prior to the date of termination; and
  - Participants who could have retired and received payment of their benefits at least 3 years prior to the date of termination
- To all benefits guaranteed and insured by the Pension Benefit Guaranty Corporation.
- To all other vested Accrued Benefits not insured by the Pension Benefit Guaranty Corporation.
- To all other Accrued Benefits provided under the Plan.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits, should the Plan terminate at some future time, will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

#### **NOTE 5 FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Registered Investment Companies***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Pooled Separate Accounts***

Valued at the net asset value of the underlying investments on the last day of the plan year. The net asset value of the fund is based on the market value of its underlying investments, but it is not a publicly quoted price in an active market.

This investment is subject to investment and liquidity risk and other risks inherent in real estate such as those associated with general and local economic conditions.

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and dividends, for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), a qualified institution.

**NOTE 7 ACCUMULATED PLAN BENEFITS AND CHANGES IN ACCUMULATED PLAN BENEFITS**

---

Accumulated benefits are those annual pension benefits that individual participants have accumulated under the Plan's benefit accrual provision based on their current salary and service to date. The current value of those accumulated benefits is the aggregate of participants' accumulated benefits adjusted to reflect the life expectancy of participants and discounted for the overall rate of investment return, net of investment expenses. The discount rate used in determining the actuarial present value of accumulated plan benefits was 4.25% per annum for 2024 and 2023, net of expenses.

**NOTE 8 RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for pension benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 9 TAX STATUS OF PLAN**

---

The Plan adopted a Principal Life Insurance Company non-standardized pre-approved defined benefit plan document that was deemed acceptable under section 401(a) of the Internal Revenue Code. The Principal Life Insurance Company has obtained an opinion letter dated February 28, 2023, in which the IRS states that the non-standardized pre-approved document is in compliance with the applicable requirements of the IRC. The Plan administrator adopted the restated prototype plan document effective October 1, 2023.

**NOTE 9 TAX STATUS OF PLAN (CONTINUED)**

---

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

**NOTE 10 RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

---

Plan investments consist of registered investment companies and pooled separate accounts managed by Principal Trust Company, the Trustee, as defined by the Plan; therefore, transactions within these investments qualify as party in interest transactions as defined by ERISA. As described in Note 2, the Plan paid certain expenses to Principal Life Insurance Company for contract administration fees and TriBridge Partners for Investment Advisory fees totaling \$126,075 and \$99,450 for 2024 and 2023, respectively. Additionally, the Plan paid PBGC premiums of \$26,159 and \$ 25,634 during 2024 and 2023, respectively. These transactions are party in interest transactions under ERISA. The Credit Union pays directly any other fees related to the Plan's operations.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note – expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
