## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

### 1. Description of plan

The following description of the Heights Christian School 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Copies of the Plan document are available from the Human Resources Department.

#### *General*

The Plan was established on May 1, 2003, for all eligible employees, as defined in the document. The Plan was amended and restated effective July 1, 2020, to comply with changes in laws and regulations. The Plan is a defined contribution plan sponsored and administered by Heights Christian Schools (the “School” or “Plan Administrator”). The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”).

#### *Eligibility*

All employees are eligible to make deferral contributions to the Plan. Employer matching and discretionary contributions are offered for all participants who have completed two years of service, with the exception of Administrators, Principals and Directors, which are eligible upon hire. If not excluded from the Plan, as defined, there is no age or hour requirement to participate and make elective deferrals.

#### *Contributions*

Participants may make contributions to the Plan in an amount not to exceed their compensation, subject to maximum annual limits established by the Internal Revenue Service. Participants may also make rollover contributions from other retirement plans. Participants who are 50 years of age are eligible to make catch-up contributions. Participants direct the investment of their contributions, and employer contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds as investment options for participants. Participants may elect to change their investment options and transfer their account balances among the different investment options at any time.

Effective July 1, 2020, the school reduced matching contributions to 0% and provided for discretionary contributions as determined by the Board of Directors. Effective July 1, 2021 through July 1, 2025, the school implemented a discretionary match contribution of 2% as determined by the Board of Directors. Subsequent to July 1, 2025, discretionary contributions were reduced to 0% for all subsequent years until further notice. For the years ended December 31, 2024 and 2023, there was \$60,310 and \$107,094 discretionary contributions made, respectively.

#### *Participant accounts*

Each participant’s account is: (a) credited with their elective deferral contributions, an allocation of the Sponsor’s matching and discretionary contributions, investment income and gains/losses, and (b) charged with an allocation of administrative expenses as provided in the Plan document. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is fully entitled is the participant’s own contributions, rollover contributions, and transfers from other appropriate plans. For “all other contributions” a participant is entitled to the participant’s vested portions.

#### *Vesting*

Participants are immediately 100% vested in their voluntary contributions, the School's contributions to their accounts plus actual earnings thereon.

#### *Notes receivable from participants*

Participants may borrow against their vested balance at a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants are secured by the vested balance in the participant's account and bears interest at rates of 3.25% to 8.5%. Notes receivable from participants are for fixed terms, requiring monthly repayments through bi-monthly payroll deductions. Participants may not have more than two notes receivable outstanding at any time. A participant's note receivable becomes immediately due and payable upon a participant's termination of employment, death, or disability.

#### *Benefit payments*

A participant's account will be distributed upon death, disability, retirement or termination in accordance with the distribution options defined by the Plan. Participant's with an account balance of \$5,000 or more may elect to receive an amount equal to the value of the participants vested interest in their account under one of the following methods: (a) a single lump-sum cash distribution, (b) installment payments or (c) purchase of an annuity contract. If the vested balance of the participants account is less than \$5,000, the participant will receive a lump sum amount. Upon attainment of age 59 ½, participants may elect to take an in-service distribution.

Participants may request hardship withdrawals from their account balance for certain financial needs, as defined in the Plan documents.

### 2. Significant accounting policies

#### *Basis of accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

#### *Use of estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingency of assets and liabilities. Actual results could differ from those estimates.

#### *Payment of benefits*

Benefits are recorded when paid.

#### *Investment valuation and income recognition*

The Plan's investments are stated at fair value as determined by quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 6 for a description of the fair value measurement and valuation methodologies used in determining the fair value of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred.

#### *Administrative expenses*

Custodian fees are paid from plan assets. The Plan receives a revenue credit from each underlying fund ranging from .45% to .50% of those investment assets which are used to offset administrative expenses. All other Plan expenses are paid by the School and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. The revenue credit is included in other income on the statement of changes in net assets available for plan benefits. For the years ended December 31, 2024 and 2023, the School incurred administrative expenses of \$208 and \$8,500, respectively.

### 3. Tax status

The Plan adopted the American Fund Distributors Inc. Volume Submitter 403(b) Tax Plan document. The Plan has obtained an IRS opinion letter dated March 31, 2017. There have been amendments to the Plan subsequent to the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable tax exempt requirements of the IRS Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

### 4. Plan termination

Although the School has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants shall become fully vested in their account balances and the net assets of the Plan will be allocated to the participants in accordance with the terms of the Plan.

### 5. Information certified by the custodian

The following is a summary of the information included in the Plan's financial statements that was prepared by the custodian, Capital Bank and Trust, and furnished to the Plan Administrator. The custodian has certified that such information is complete and accurate.

### 6. Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3–Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Cash*: Valued in US currency.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

### 8. Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust. Capital Bank and Trust is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services to related third parties amounted to \$10,728 and \$9,211 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, the School incurred administrative expenses of \$208 and \$8,500, respectively.

### 9. Subsequent events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
