**NOTE A - SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation:* The financial statements of Providia Home Care 401(k) Profit Sharing Plan & Trust (the "Plan") are maintained on the accrual basis in accordance with U.S. generally accepted accounting principles. These financial statements include participants who are employees of Providia Home Care, LLC, who is the Plan Sponsor.

*Investment Valuation and Income Recognition:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

*Payment of Benefits:* Benefit payments are recorded when paid.

*Administrative Expenses:* Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

*Contributions:* Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

*Subsequent Events:* Subsequent events have been evaluated by management through the date of the independent auditor's report, the date the financial statement were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

*Use of Estimates:* The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements, and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE B - DESCRIPTION OF PLAN**

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and covers substantially all employees of the Plan Sponsor. Participants are eligible to enroll following the completion of two months of service, with the entry date being the first day of the month following the date that the eligibility requirements are met.

*Plan Restatement:* The Plan was restated effective January 1, 2024 as the Plan adopted the pre-approved plan provisions under Transamerica Retirement Solutions, LLC.

*SECURE 2.0 Act:* The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.

*Plan Amendment:* Effective June 28, 2024, the Plan was amended to change the Plan trustee to Transamerica Trust Company.

*Termination of the Plan:* Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Plan Sponsor will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, allocation of the Plan Sponsor's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are 100% vested at all times in their voluntary contributions, and actual earnings thereon. Vesting in the Company's employer matching contributions is based on years of continuous service. A participant is 100% vested after six years of credited service (20% per year starting in year two). Participants also become 100% vested in all contributions in the event of death or disability.

*Contributions:* The Plan is funded through employee elective deferrals and Plan Sponsor contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

**NOTE B - DESCRIPTION OF PLAN – continued**

The Plan Sponsor may make discretionary matching contributions each year, which are subject to limits defined in the Plan document. The Plan Sponsor contribution is invested as directed by the participant.

The Plan Sponsor may make discretionary profit-sharing contributions which will be allocated in accordance with the plan document provisions. Participants must be employed on the last day of the plan year to be eligible to receive discretionary profit-sharing contributions. No profit-sharing contributions were made in 2024 and 2023.

*Investment Options:* Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

*Notes Receivables from Participants:* Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the balance in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions and generally repaid within 5 years or up to 30 years for the purchase of a primary residence.

*Payment of Benefits:* On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's account is less than \$5,000, it is automatically paid out as soon as administratively possible. In the absence of an election by the participant within the time period specified by the Plan Sponsor, any balance that exceeds \$1,000 but does not exceed \$5,000, various payment options are available and are described more fully in the Plan adoption agreement. Any balance that does not exceed \$1,000 is paid directly to the participant in the form of a cash, lump-sum distribution. The Plan allows for in-service distributions upon reaching age 59 ½. Hardship withdrawals are available subject to certain limitations.

*Forfeitures:* Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Plan Sponsor contributions to be used to restore eligible rehire forfeiture account balance. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$29, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$146 were used to offset employer contributions.

*Reclassification:* Certain reclassifications may have been made to the 2023 financial statement presentation to correspond to the current year's format. Total net assets available for benefits are unchanged due to these reclassifications.

**NOTE C – INVESTMENT CERTIFIED BY THIRD PARTY (unaudited)**

As permitted by Department of Labor CFR 2520.103-8, investments and participants' notes receivable at December 31, 2024 and the related investment earnings and interest on participants' notes for the year then ended, were certified and held by Reliance Trust Company, the Custodian, and were not audited by the independent auditor. Investments and participants' notes receivable at December 31, 2023 and the related investment earnings and interest on participants' notes for the year then ended, were certified and held by Mid Atlantic Trust Company, the Custodian, and were not audited by the independent auditor.

**NOTE D - INCOME TAX STATUS**

The Plan received its most recent favorable opinion letter from the Internal Revenue Service on June 30, 2020, and although it has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified for tax exempt status. The Plan Administrator is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

**NOTE E – TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

**NOTE F – PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Plan sponsor was required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. The Plan had contributions totaling \$40,088, all of which represented employee salary deferral and loan repayments, that were not remitted timely. These contributions were considered prohibited transactions.

The Company calculated lost investment earnings and filed Form 5330, as applicable, and compensated the Plan for the lost earnings in May 2024 for \$31,195 of the contributions. The remaining \$8,893 and the lost earnings were corrected in January 2025.

**NOTE G - FAIR VALUE MEASUREMENTS**

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
  - quoted prices for identical or similar assets or liabilities in inactive markets
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
  - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
