We have performed audits of the financial statements of Reading & Math, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Reading & Math, Inc. 401(k) Plan Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of Reading & Math, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), covering eligible employees of Reading & Math, Inc. d.b.a Ampact (the "Company") who have completed one consecutive month during which one hour of service was completed. Plan entry dates are the first day of the month after eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for oversight of the Plan. The 401(k) committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company.

#### **Contributions**

Participants may, after meeting eligibility, contribute a percentage of their compensation, as defined in the Plan. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants are automatically enrolled to withhold 4% of their compensation if they have not completed a salary deferral agreement by the time they are eligible to make deferrals. The contributions are invested in a designated balanced fund based on the participant's age until changed by the participant.

The Company may contribute a discretionary match and profit-sharing amount according to the Plan provisions. During 2024 and 2023, discretionary matching contributions were 100% of the first 4% of salary deferrals, for participants that worked at least 1 hour during the plan year. The Company did not make any profit-sharing contributions to the Plan for both 2024 and 2023. Participants must complete one month of service to be eligible for matching and one year of service to be eligible for profit sharing contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### **Vesting**

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Participants vest ratably in employer matching and profit sharing contributions and are fully vested after four years of service.

#### **Forfeitures**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$59,090 and \$18,240 respectively. Forfeitures resulting from a terminated participant's failure to be fully vested in the Company's contributions may be used to offset plan expenses or reduce future Company contributions. Forfeitures used to offset plan expenses totaled \$7,032 and \$10,556 in 2024 and 2023, respectively.

#### **Payment of Benefits**

Upon termination of service, death, disability, or retirement, a participant may receive the value of their vested interest in their account in the form of a lump-sum distribution, substantially equal installments or a partial withdrawal. The participant's eligible vested account balance may remain in the Plan if the balance is over \$7,000. For account balances that are \$7,000 or less, the plan administrator will authorize the benefit payment without the participant's consent. Participants become 100% vested in all accounts under the Plan if they retire on or after normal retirement age, obtain early retirement age and service, die while still employed by the Company, or are disabled. Normal retirement age is when the participant reaches their 65th birthday. The Plan allows for in-service withdrawals of fully vested balances any time after reaching age 59½. Hardship distributions of elective deferrals are also permitted.

#### **Notes Receivable from Participants**

Eligible participants may borrow against the value of their accounts. The maximum amount of any loan is the lesser of 50% of the participant's vested account balance or \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The minimum amount of any loan is \$1,000 and the number of outstanding loans is limited to one. The loans are secured by the balance in the participant's account. The plan administrator will determine a reasonable rate of interest based on similar interest rates charged by other lenders.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants valued as of the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian and investment advisor.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded using the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation represents the Plan's gains or losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### **Funding Policy**

Company matching contributions are generally remitted to the Plan at the same time as salary deferrals.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other costs of maintaining the Plan are included in administrative expenses. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued.

### **NOTE 3 - CERTIFICATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company, the custodian of the Plan.

### **NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: valued at net asset value (NAV) which is based on the market value of its underlying investments. While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted and are determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. There are currently no redemption restrictions on these investments. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan adopted the provisions of ASC 946-210 with respect to the fully benefit-responsive investment contract held by the Minnesota Life Guaranteed Return Account, which is provided as a core investment option to participants in the Plan. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan, represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Minnesota Life Guaranteed Return Account and is a general account product of Standard Insurance Company. Interest is credited daily to amounts allocated at the rate declared by Standard Insurance Company before the beginning of each contract quarter, subject to a minimum guaranteed rate determined in the contract. Transfers and withdrawals from the Guaranteed Return Account are subject to certain limits. Transfers are allowed from any pooled separate account to the Guaranteed Return Account, but transfers from the Guaranteed Return Account are not permitted to any separate accounts that are considered "Competing Investment Options" and, following a transfer from the Guaranteed Return Account, no transfers to pooled separate accounts considered to be competing investment options will be allowed for a period of 90 days. If participants elect the lump sum method of liquidation (rather than installment payments), a market value adjustment may also apply under the contract.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan's documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (e) premature termination of the contract. The plan administrator believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability to transact at contract value with the participants.

### NOTE 6 - TAX STATUS

The Company has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since adoption of the prototype plan; however, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Standard Insurance Company who provides custodial services. These transactions qualify as party-in-interest transactions.

### NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 11 - PROHIBITED TRANSACTIONS**
