INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rush Copley Medical Center Employees' Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Rush Copley Medical Center Employees' Savings Plan ("the Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was originally established January 1, 1985 to provide a defined contribution plan with optional employee contributions on a tax-deferred basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Rush Copley Medical Center, Inc. ("the Corporation") is the sole corporate member of Copley Memorial Hospital, Inc. ("the Hospital") and affiliates (collectively "RCMC"). The Plan is sponsored by the Corporation ("the Plan Sponsor"). Substantially all RCMC employees are eligible for participation in the Plan at employment commencement date for employee deferrals and for employer match contributions. Employees are not eligible for non-elective contributions until the first day of the month coincident with or next following the completion of one year of credited service (1,000 hours or more) and attaining the age of 18.

Plan Management and Administration: The Board of Directors and its management designees control and manage the operation and administration of the Plan. All assets of the Plan are managed by Empower Trust Company, LLC (formerly Prudential Bank & Trust, FSB) and Empower Annuity Insurance Company (EAIC) (formerly Prudential Retirement Insurance and Annuity Company). Empower Trust Company, LLC performs certain administrative functions of the Plan and serves as the trustee.

Effective March 31, 2023, Prudential Bank & Trust, FSB merged into Empower Trust Company, LLC, an Empower affiliate, and all services performed by Prudential Bank & Trust, FSB were assumed by Empower Trust Company, LLC.

Contributions: Participants are eligible to defer from 1% to 50% of their annual pre-tax compensation to the Plan, subject to certain Internal Revenue Service ("IRS") limitations. Participants may also make Roth after-tax contributions and rollover balances from other qualified retirement plans. Participants age 50 and older may elect to defer additional amounts ("catch-up contributions") to the Plan.

For participants who contribute to the Plan, the Corporation makes discretionary matching contributions based on a percentage of the participant's eligible salary deferrals. The Corporation's discretionary matching contribution formula does not apply to the catch-up contributions. During the 2024 plan year, the Plan Sponsor made discretionary matching contributions of \$4,520,749.

Additionally, the Corporation may make annual discretionary profit-sharing contributions. During the 2024 plan year, the Plan Sponsor chose not to make a discretionary profit-sharing contribution.

Participant Accounts: Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, the Corporation's matching and discretionary contributions, and allocations of the Plan's investment earnings. Participant accounts are reduced by withdrawals and allocations of plan investment losses. Allocations of plan earnings and losses are based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Participants vest in the employer contributions credited to their accounts at a rate of 25% per year beginning in the second year, becoming fully vested after five years. Forfeited balances of terminated participants are used to reduce future employer contributions.

Investment Options: Participants direct the investment of contributions and account balances into any or all investments offered by the Plan. The Plan currently offers a guaranteed interest fund, pooled separate accounts, self-directed brokerage accounts and various mutual funds.

Notes Receivable from Participants: Participants in the Plan may request a loan against their vested account balances for the lesser of one-half of that vested balance or the IRS limit. The minimum loan amount is \$1,000 and repayment is made over a maximum of five years (20 years if used to purchase a primary residence). Loans are secured by the remaining balance in a participant's account. The interest rate applicable to the loan is the prime rate plus one percent determined at the time the loan is made. The participant must pay application and processing fees and is restricted to one outstanding loan at a time.

Forfeited Accounts: Forfeited nonvested accounts totaled approximately \$365,293 and \$278,000 at December 31, 2024 and 2023, respectively. Forfeited nonvested accounts are available to reduce future employer contributions.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as other expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Corporation.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for investments in mutual funds, pooled separate accounts, self-directed brokerage accounts and an investment contract that, in general, are exposed to various risks such as liquidity, interest rate, credit and overall market volatility risks as well as the risks associated with the global events. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are stated at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions.

Benefit Payments: Participants may receive a lump-sum payment, installment payments, or rollover of the balance in their account upon termination, normal or early retirement, death, or disability. In-service withdrawals from a Participant's account are permitted by the Plan. If the Participant is over the age of 59 ½, the Participant is allowed to withdraw his or her entire vested balance. Hardship withdrawals may be taken from the Participant's account. Benefit payments are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan) and Empower Annuity Insurance Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Brokerage accounts: The brokerage accounts primarily consist of common stock and mutual funds. The fair value of the brokerage accounts is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled separate accounts: The fair value of participation units held in pooled separate accounts is based on the net asset values reported by the account managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a traditional fully benefit-responsive investment contract with Empower Annuity and Insurance Company (“EAIC”) that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan’s traditional fully benefit-responsive investment contract is presented below:

EAIC maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 3.0%. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct permitted withdrawal or transfer of all or a portion of their investments at contract value within reasonable time frames.

Under the Plan’s investment contract, a plan sponsor initiated termination of the contract is an event that could limit the ability of the Plan to transact at contract value paid within 90 days. In this instance contract value could be paid overtime, or at the plan sponsor’s discretion, paid over at most a one-year period after the application of market value adjustments.

There are no events that allow the issuer to terminate the contract, and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. At this time, plan management does not believe that it is probable that the contract will be terminated.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, participants will become fully vested in their accounts.

NOTE 7 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated September 16, 2022, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the originally adopted prototype plan, the Corporation and the plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Corporation. No such officer or employee receives compensation from the Plan. The Corporation pays certain professional fees for the administration and audit of the Plan. Fees paid from the plan to service providers qualify as party-in-interest transactions.

Party-in-interest investments include a guaranteed investment contract and pooled separate accounts issued by affiliates of the Plan's trustee. Notes receivable from participants are also considered transactions with parties-in-interest.
