**Note 1 – Plan Description**

---

The following description of the Wall Residences, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan covering all eligible employees of Wall Residences, Inc. (the “Company”) who are at least 21 years of age and have compiled a minimum of six months of service. The Plan excludes employees whose employment is governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 30, 2023, the Plan was amended to reduce the minimum age requirement to 18 years old and the service requirement to two months of service.

*Contributions*

Each year participants may contribute up to 100% of pre-tax annual compensation up to the maximum allowable under the *Internal Revenue Code (IRC)*, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants may elect pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company matches 100% of the first 4% of eligible participants’ compensation contributed to the Plan. The Company may contribute amounts at the discretion of the Company’s Board of Directors. Participants are eligible to receive the Company’s discretionary contributions if they are employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year, as defined. There was no additional discretionary profit-sharing contribution in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, an allocation of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution is 100% upon entering the Plan. Vesting in the Company’s discretionary profit-sharing contributions are based on years of continuous service. A participant is 100% vested in the profit-sharing contribution after six years of credited service.

*Payment of Benefits*

Upon termination of service for any reason, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In service withdrawals are available to participants age 65. Vested account balances less than or equal to \$5,000 are subject to be rolled over into an IRA or automatic cash out, as defined.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$341 and \$358, respectively. The forfeited accounts may be used to pay Plan administrative expenses or reduce employer contributions. No forfeitures were used to pay Plan administrative expenses or reduce employer contributions during 2024.

*Administrative Costs*

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

*Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime rate. Note terms may not exceed five years unless the note is for the purchase of a principal residence, in which case the term may exceed five years. Principal and interest are paid ratably through monthly payroll deductions. The interest rates ranged from 5.50% to 8.50% at December 31, 2024.

**Note 2 – Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Valuation of Investments and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Benefit Payments*

Benefits are recorded when paid.

**Note 3 – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**Note 4 – Related Party Transactions**

---

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds issued and managed by the Plan Trustee. Investments in funds issued and managed by the Trustee are considered related party transactions. Fees paid to the Trustee by the Plan for investment management and trust services amounted to \$47,673 for 2024.

---

**Note 5 – Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

**Note 6 – Tax Status**

---

The Plan is an adoption of a non-standardized pre-approved profit-sharing plan sponsored by Fidelity Management Trust Company. The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
