

1. **Description of the Plan** The following description of the Athena Technology Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Athena Technology Group, Inc. (the "Company") who have completed thirty days of service, except for union employees, nonresident aliens, leased employees, employees who are classified as independent contractors by the Company, and temporary and seasonal employees. If a temporary or seasonal employee completes a year of service, which is twelve consecutive months with 1000 hours worked, they will become an eligible participant and enter the Plan at the next entry date. Employees may enter the Plan on the first day of the month subsequent to satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a six percent withholding of pretax annual compensation. The Company contributes a safe harbor matching contribution of 100 percent of the first one percent and 50 percent up to six percent of compensation that a participant contributes to the Plan. The Plan allows for discretionary matching and profit sharing contributions. The Company made a discretionary contribution to the Plan for the year ended December 31, 2024 totaling \$100,000. This amount was funded to the Plan in 2025, net \$25,000 of forfeitures used to reduce the discretionary contribution. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's safe harbor contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on the grouping allocation method whereby the amount contributed for each group is allocated based on the ratio of the participant's compensation in that group to the total compensation for all participants of that group for the Plan year. Each participant may constitute its own group. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company safe harbor and discretionary contributions is based on years of continuous service. For safe harbor contributions, a participant is 100 percent vested after two years of service is completed. For discretionary contributions, a participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years of service is completed.

Payment of benefits: Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum and installment payments.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants may also be charged asset based fees for recordkeeping and investment advisory services.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$129,877 and \$40,848 (unaudited), respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, no forfeited nonvested accounts were used to reduce Company contributions. During 2024, \$16,408 of forfeited nonvested accounts were used to pay Plan expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Participant contributions and the related Company safe harbor and discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary profit sharing contributions, if any, are recognized in the period the related eligible compensation is paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 13, 2025, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments and interest and dividend income for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee of the Plan.
- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

5. Guaranteed investment contract

The Plan participates in a benefit responsive investment contract with Standard Insurance Company ("Standard") via an investment in a Guaranteed Investment Contract ("GIC"). Standard commingles the assets of the GIC with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer, such as the termination of the Plan or contract. Additionally, any withdrawals or transfers from the GIC requested by the Company, either in a single transaction or in aggregate transactions for the Plan year, may be delayed if total withdrawals and transfers from the GIC are in excess of 25 percent of the balance of the GIC as of the beginning Plan year. Should the Plan choose to terminate the contract, the assets in the contract may be either disbursed immediately as a lump sum payment subject to a market value adjustment as described in the contract or in six annual installment payments over five years. Standard may delay any lump sum payment for up to six months. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 8. Tax status** The Plan is a pre-approved plan of Tiger's Eye Benefits Consulting which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 9. Party-in-interest transactions** Certain Plan investments are managed by affiliates of The Vanguard Group. The Vanguard Group executed a recordkeeping agreement with the Company, under which it has subcontracted the Plan's recordkeeping services to Ascensus, LLC ("Ascensus"). The Plan pays expenses related to Plan administration and investment activities to Ascensus and various other service providers. These transactions qualify as exempt party-in-interest transactions.
- 10. Reconciliation to Form 5500** The following is a reconciliation of amounts in the financial statements to Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024:
