## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### DESCRIPTION OF THE PLAN

The following description of the Om Ganesh One, Inc. (the Company) 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution salary reduction and profit sharing plan covering all eligible employees of the Company. An employee first become eligible to participate in the Plan upon completing twelve consecutive months of service in which they have at least 1,000 credited hours and are at least 21 years of age. Eligible employees may enter the Plan on the first day of the month following meeting age and eligible service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA)

Om Ganesh One, Inc. is the Plan administrator. Paychex is the recordkeeper of the Plan and Mid Atlantic Trust Company is the asset custodian of the Plan. The Plan trustee is Marin Granteed.

#### Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer discretionary matching contributions are determined at the discretion of the Company's management and are determined annually. For the Plan year December 31, 2024 and 2023, the company made no matching contributions.

Contributions are subject to certain IRS limitations.

#### Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Participants may direct contributions in investment options in percent increments or fixed dollar amounts. All employer contributions are invested in the same funds in which the participants invest their own contributions.

### DESCRIPTION OF THE PLAN (Continued)

#### Participant accounts –

Each participant's account is credited with the participant's contributions, Company matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting –

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

#### Recently adopted accounting guidance – allowance for credit losses –

Effective January 1, 2023, the Plan implemented FASB ASC 326 which significantly changed how entities will measure credit losses for most financial assets. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were notes receivable from participants. The impact of the adoption was not considered material to the financial statements and primarily resulted in new and enhanced disclosures.

#### Recently passed legislation –

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. The legislation includes a vast array of provisional changes to retirement plans that became effective in 2023 and beyond. There were no significant changes to the plan as a result of implantation.

#### Notes receivable from participants –

Participants may borrow from their fund up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 to 5 years or longer if the loan is for the purchase of primary residence provided documentation as to the purpose of the loan is made available. The loans are secured by the balance in the participant's account balance. The loan interest rate is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions or by direct payments to the plan's trustee.

#### Payment of benefits –

The Plan permits withdrawals when a participant terminates employment, retires, or becomes disabled or deceased. In-service withdrawals are also permitted when a participant has reached the age of 59 ½. Benefits are payable in lump-sum payments, partial payments, installments, and by purchase of an annuity contract.

### Forfeited accounts –

Forfeitures are used to reduce future employer contributions or pay plan expenses. Forfeiture balances as of December 31, 2024 and 2023 were \$1,281 and \$1,281 respectively. During 2024 and 2023, there were no forfeitures used to pay Plan expenses or reduce employer contributions.

### Administration of Plan assets –

The Plan's assets are held by the John Hancock Life Insurance Company. As a prototype sponsor of the Plan, they provide investment services for the Plan. The third-party administrator is Ascensus Holdings, Inc., they provide recordkeeping and administrative services including preparation of all required annual filings. Administrative expenses are paid first by the Plan's earnings, prior to being allocated to the participant accounts. During the years ending December 31, 2024 and 2023, 16,683 and \$13,955, were paid out in administrative expenses, respectively.

## SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of estimates –

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment valuation and income recognition –

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee of the Plan determines the Plan's valuation policy utilizing information provided by the investment advisors, custodians and insurance company. See the “**FAIR VALUE MEASUREMENTS**” note for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefit.

### Notes receivable from participants –

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### Payment of benefits –

Benefits are recorded when paid.

#### Expenses –

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

#### Subsequent events –

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

### FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

---

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes net asset value (NAV) of units, as determined by John Hancock Retirement. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information of the underlying investments.

The methods used above may product a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST

Certain Plan investments are shares of mutual funds managed by John Hancock Retirement. John Hancock Life Retirement is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment.

Ascensus Holdings, Inc. is the recordkeeper of the Plan therefore, these truncations qualify as party in interest transactions. As described in the Summary of Accounting Policies, the Plan made direct payments to the third-party administrator of \$16,683, which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### TAX STATUS

The non-standardized document, upon which the Plan was designed received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan was amended subsequent to receiving the opinion letter, however, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.
