Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of HBH Holdings, Inc. 401(k) (the "Plan") have been prepared on the accrual basis using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Related Party Transactions

Certain employees of Enerfab, Inc. (the "Company" and "Plan Sponsor") provide administrative and executive oversight services to the Plan. The Plan is not charged by the Company for the services.

Certain Plan investments are invested in accounts managed by the asset custodian. AdvisorTrust, Inc. is the asset custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest.

Notes to Financial Statements (Continued)

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain Plan expenses are paid by the Company, and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

In preparing its financial statements, Plan management has evaluated events subsequent to the balance sheet date through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 1985, is a defined contribution plan covering union and non-union employees of the Company who have attained the age of 21 and completed three months of service. Plan entry dates are the first day of each calendar month. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute, before and after tax, contributions to the Plan up to 100% of their eligible annual compensation, as defined by the Plan document. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for 2024). Section 414(v) of the Internal Revenue Code of 1986 as amended allows a maximum catch-up contribution of \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make matching contributions for non-union employees at discretion of the Company's Board of Directors. Allocations of the Company's discretionary contributions are based upon compensation. During 2024, the Company matched 50% of certain participants' elective deferrals up to 8% of annual pre-tax or after tax contributions and matched 25% of certain participants' elective deferrals up to 8% of annual pre-tax or after tax contributions. The matching contributions for 2024 was \$1,444,596. Union employees are eligible to receive additional discretionary contributions contributed by the Company. A discretionary contribution in the amount of \$31,290 was made in 2024 on behalf of union employees. Union employees are eligible to receive Company contributions only.

The plan includes an automatic enrollment option whereby all eligible employees are automatically enrolled into the Plan at a 3% deferral rate unless they elect to not participate. Each participant in the Plan will have their deferral percentage increased by 1% each year until the participant reaches an 8% deferral rate.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Contributions (Continued)

Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. A participant may change the amount of his or her elective deferred contributions at any time during the Plan year by issuing a change request form to the Plan administrator. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with allocations of (a) the participant's contribution, (b) the Company's contribution and (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions and Plan earnings thereon is based on years of continuous service using the elapsed time method. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Each participant may have only one outstanding note at a time. The notes receivable from participants are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions. All notes receivable must be repaid within five years except in the case of a note for the purpose of acquiring a home.

Payment of Benefits

On termination of service due to death, disability, retirement, or other termination of employment with the Company, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance of \$5,000 or less may be automatically distributed as a lump-sum.

In-service distributions are permissible for participants that have attained the age of 59 1/2. Participants electing in-service distribution may elect to receive all or a portion of their vested balance in a lump sum payment.

In conditions of "financial hardship," a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code ("IRC").

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Forfeitures

Forfeitures can be used by the Plan to reduce Plan expenses or matching contributions. During 2024, the Company used \$66,171 to pay plan expenses, and the company did not use forfeitures to offset employer contributions. The balance in the unallocated forfeitures was \$248,432 and \$134,180 at December 31, 2024 and 2023, respectively.

NOTE 3 TAX STATUS

The Plan adopted a prototype plan which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the provider's prototype, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code. Furthermore, the Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4 PLAN TERMINATION

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

3. The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 6 FAIR VALUE MEASUREMENTS

GAAP provisions for Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions for Fair Value Measurements are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 6 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust, as provided by the trustee. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
