### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Richardson 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following brief description of the Richardson 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a defined contribution plan established May 1, 2013 by Richardson (US) Holdings Limited (formerly Richardson Milling, Inc.) (the Employer) in conjunction with a spin-off of participants and Plan assets from the Viterra USA, LLC 401(k) Plan and Trust. The Plan has been amended and restated to comply with tax legislation. The Plan was last amended and restated effective January 1, 2023. The Plan covers substantially all employees of the Employer and employees of Richardson Oilseed Products (US) Limited, Italgrani U.S.A., Inc., Italgrani Elevator Company, Renville Elevator Company, Mayco Export, Inc., Powers Lake Elevator Company, McLean Elevator Company, U.S. Durum Milling, Inc., and Richardson Milling Inc. (participating employers). Employees are eligible after attaining age 18 and completing three months of service. An employee becomes a participant in the Plan on the first day of the month following the completion of the eligibility requirements. The Plan excludes leased employees, nonresident aliens with no U.S. source income, and part-time/temporary/seasonal employees whose regularly scheduled service is less than 1,000 hours in the eligibility computation period, residents of Puerto Rico and International Longshoremen's Association Local 1765 AFL-CIO union employees. The Plan is subject to the provisions of ERISA, as amended. The Governance Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Under this arrangement and subject to Plan provisions, eligible participants are permitted to elect to have pre-tax salary reduction contributions contributed to the Plan up to the maximum allowable by law. The Plan allows for after-tax Roth contributions. Participants age 50 and older are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Contributions (Continued)**

The Plan provides for a safe harbor matching contribution for eligible nonunion employees whereby the Employer will contribute 100% of the first 5% of eligible compensation that a participant contributes to the Plan. The Plan provides for a discretionary matching contribution for eligible union employees. For the year ended December 31, 2024, the Employer authorized a discretionary matching contribution to eligible South Sioux City union employees (hired on or before December 31, 2020) equal to 50% of the first 4% of eligible compensation, a discretionary match contribution to eligible South Sioux City union employees (hired after December 31, 2020) equal to 100% up to 2.5% of eligible compensation, a discretionary matching contribution to eligible Memphis Refinery (Wesson) union employees (hired on or before December 31, 2020) equal to 50% of employee deferrals up to 6% of eligible compensation, and a discretionary matching contribution to eligible Wesson union employees (hired after December 31, 2020) equal to 100% up to 2% of eligible compensation.

The Plan also provides for a discretionary profit sharing contribution for certain eligible employees. In order for an employee to share in the discretionary profit sharing contribution, they must be in an eligible category as defined in the Plan text, complete 1,000 hours of service during the Plan year, and be employed on the last day of the Plan year (December 31<sup>st</sup>). Effective January 1, 2021, union employees other than South Sioux City Union Employees hired after December 31, 2019 and Memphis Union Employees hired after December 31, 2020 are excluded from eligibility for future discretionary profit sharing contributions. During 2024, a discretionary profit sharing contribution, equal to 2%, was paid to eligible South Sioux City union employees (hired after December 31, 2019) and eligible Memphis union employees (hired after December 31, 2020).

**Participant Accounts**

Each participant's account is credited with the participant's salary deferral, the Employer's safe harbor matching contribution, the Employer's discretionary matching contribution, the Employer's discretionary profit sharing contribution, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's accounts. Participants direct the investment of contributions into the various investment options offered under the Plan.

**Vesting**

Participants are immediately vested in their salary deferrals and safe harbor matching contributions plus actual earnings thereon. Employer discretionary matching and profit sharing contributions plus earnings thereon are subject to a graded vesting schedule where participants become 100% vested after the completion of five years of credited service. Participants in the Italgrani U.S.A, Inc. Employee Savings Plan prior to January 1, 2023 are 100% vested in the Employer discretionary profit sharing contributions.

Notwithstanding the above, participants shall become 100% vested and be entitled to the full value of their account upon reaching normal retirement age (65) or becomes deceased or permanently disabled.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of service, death, disability, or retirement, the participant may receive the value of the vested interest in his or her account in the form of a lump-sum distribution, installment, or partial withdrawal. A distribution in the form of an annuity is available to participants with account balances that hold transferred pension assets. If a participant terminated employment and his or her account balance is less than \$1,000, the Plan administrator can authorize the payment of the benefit as a lump-sum cash-out, less withholding, without the participant's consent. The Plan also allows for in-service withdrawals at age 59 ½ and hardship distributions subject to Plan provisions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested fund balance. Note terms range from one to five years unless the purpose of the note is to purchase a primary residence. The notes are secured by the balance in the participant's account and bear interest at prime plus 2%. Principal and interest is paid directly by participants through ACH payments.

**Forfeitures**

Forfeited nonvested accounts attributable to the Employer discretionary matching and profit sharing contributions will be used to pay administrative expenses or to reduce future Employer discretionary contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$20,237 and \$3, respectively. Forfeitures of \$5,766 were used to pay administrative expenses during the year ended December 31, 2024. Forfeitures of \$25,636 were used to reduce Employer discretionary contributions during the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Governance Committee determines the Plan's valuation policies utilizing information provided by the insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants, benefit payments and general administration services are charged directly to participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

The Standard Insurance Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued daily at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a group annuity contract with Minnesota Life Insurance Company (Minnesota Life) on May 1, 2013. Minnesota Life maintains the contributions as directed by the participants in separate accounts.

**NOTE 6 TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by The Standard Insurance Company. The Standard Insurance Company is the insurance company as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Richardson 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Richardson 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 DESCRIPTION OF PLAN**

The following brief description of the Richardson 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a defined contribution plan established May 1, 2013 by Richardson (US) Holdings Limited (formerly Richardson Milling, Inc.) (the Employer) in conjunction with a spin-off of participants and Plan assets from the Viterra USA, LLC 401(k) Plan and Trust. The Plan has been amended and restated to comply with tax legislation. The Plan was last amended and restated effective January 1, 2023. The Plan covers substantially all employees of the Employer and employees of Richardson Oilseed Products (US) Limited, Italgrani U.S.A., Inc., Italgrani Elevator Company, Renville Elevator Company, Mayco Export, Inc., Powers Lake Elevator Company, McLean Elevator Company, U.S. Durum Milling, Inc., and Richardson Milling Inc. (participating employers). Employees are eligible after attaining age 18 and completing three months of service. An employee becomes a participant in the Plan on the first day of the month following the completion of the eligibility requirements. The Plan excludes leased employees, nonresident aliens with no U.S. source income, and part-time/temporary/seasonal employees whose regularly scheduled service is less than 1,000 hours in the eligibility computation period, residents of Puerto Rico and International Longshoremen's Association Local 1765 AFL-CIO union employees. The Plan is subject to the provisions of ERISA, as amended. The Governance Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Under this arrangement and subject to Plan provisions, eligible participants are permitted to elect to have pre-tax salary reduction contributions contributed to the Plan up to the maximum allowable by law. The Plan allows for after-tax Roth contributions. Participants age 50 and older are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

**Contributions (Continued)**

The Plan provides for a safe harbor matching contribution for eligible nonunion employees whereby the Employer will contribute 100% of the first 5% of eligible compensation that a participant contributes to the Plan. The Plan provides for a discretionary matching contribution for eligible union employees. For the year ended December 31, 2024, the Employer authorized a discretionary matching contribution to eligible South Sioux City union employees (hired on or before December 31, 2020) equal to 50% of the first 4% of eligible compensation, a discretionary match contribution to eligible South Sioux City union employees (hired after December 31, 2020) equal to 100% up to 2.5% of eligible compensation, a discretionary matching contribution to eligible Memphis Refinery (Wesson) union employees (hired on or before December 31, 2020) equal to 50% of employee deferrals up to 6% of eligible compensation, and a discretionary matching contribution to eligible Wesson union employees (hired after December 31, 2020) equal to 100% up to 2% of eligible compensation.

The Plan also provides for a discretionary profit sharing contribution for certain eligible employees. In order for an employee to share in the discretionary profit sharing contribution, they must be in an eligible category as defined in the Plan text, complete 1,000 hours of service during the Plan year, and be employed on the last day of the Plan year (December 31<sup>st</sup>). Effective January 1, 2021, union employees other than South Sioux City Union Employees hired after December 31, 2019 and Memphis Union Employees hired after December 31, 2020 are excluded from eligibility for future discretionary profit sharing contributions. During 2024, a discretionary profit sharing contribution, equal to 2%, was paid to eligible South Sioux City union employees (hired after December 31, 2019) and eligible Memphis union employees (hired after December 31, 2020).

**Participant Accounts**

Each participant's account is credited with the participant's salary deferral, the Employer's safe harbor matching contribution, the Employer's discretionary matching contribution, the Employer's discretionary profit sharing contribution, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's accounts. Participants direct the investment of contributions into the various investment options offered under the Plan.

**Vesting**

Participants are immediately vested in their salary deferrals and safe harbor matching contributions plus actual earnings thereon. Employer discretionary matching and profit sharing contributions plus earnings thereon are subject to a graded vesting schedule where participants become 100% vested after the completion of five years of credited service. Participants in the Italgrani U.S.A, Inc. Employee Savings Plan prior to January 1, 2023 are 100% vested in the Employer discretionary profit sharing contributions.

Notwithstanding the above, participants shall become 100% vested and be entitled to the full value of their account upon reaching normal retirement age (65) or becomes deceased or permanently disabled.

**Payment of Benefits**

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of service, death, disability, or retirement, the participant may receive the value of the vested interest in his or her account in the form of a lump-sum distribution, installment, or partial withdrawal. A distribution in the form of an annuity is available to participants with account balances that hold transferred pension assets. If a participant terminated employment and his or her account balance is less than \$1,000, the Plan administrator can authorize the payment of the benefit as a lump-sum cash-out, less withholding, without the participant's consent. The Plan also allows for in-service withdrawals at age 59 ½ and hardship distributions subject to Plan provisions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested fund balance. Note terms range from one to five years unless the purpose of the note is to purchase a primary residence. The notes are secured by the balance in the participant's account and bear interest at prime plus 2%. Principal and interest is paid directly by participants through ACH payments.

**Forfeitures**

Forfeited nonvested accounts attributable to the Employer discretionary matching and profit sharing contributions will be used to pay administrative expenses or to reduce future Employer discretionary contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$20,237 and \$3, respectively. Forfeitures of \$5,766 were used to pay administrative expenses during the year ended December 31, 2024. Forfeitures of \$25,636 were used to reduce Employer discretionary contributions during the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Governance Committee determines the Plan's valuation policies utilizing information provided by the insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants, benefit payments and general administration services are charged directly to participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION (CONTINUED)**

Minnesota Life Insurance Company, the former qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2023.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued daily at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a group annuity contract with Minnesota Life Insurance Company (Minnesota Life) on May 1, 2013. Minnesota Life maintains the contributions as directed by the participants in separate accounts.

**NOTE 6 TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by The Standard Insurance Company. The Standard Insurance Company is the insurance company as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.
