## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants  
Whitestone Group 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Whitestone Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## 1. DESCRIPTION OF PLAN:

The following description of the Whitestone Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all employees, as defined, of The Whitestone Group, Inc. and any participating employers (Employer or Company) who have completed 90 days of services. Employer discretionary non-elective contributions require eligible employees to complete 1 year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Directors of the Company is responsible for oversight of the Plan.

### Contributions

Participants may contribute up to 100% of eligible compensation, as defined in the Plan, as pre-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (IRC). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary non-elective contribution. In addition to the discretionary non-elective contribution, the Employer may make additional contributions necessary to meet the Employer's requirements under applicable prevailing wage statutes (prevailing wage contributions). There were no discretionary non-elective contributions for the year ended December 31, 2024. For the year ended December 31, 2024 the Employer made prevailing wage contributions of \$1,675,809.

### Participant accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their voluntary contributions, employer contributions, and corresponding earnings.

### Payment of benefits

On termination of service, death, disability or retirement, a participant or his or her beneficiary will receive a distribution equal to the value of his or her account as a lump sum payment. Normal retirement age is age 59 ½. Financial hardship withdrawals are permitted in accordance with the Internal Revenue Service (IRS) guidelines.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,190 and \$2,160 respectively. Forfeitures may be used to reduce future Employer contributions or to pay plan expenses. No forfeitures were used to pay plan expenses or offset employer contributions for the year ended December 31, 2024.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

### **Basis of accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

### **Investment valuation and income recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on the trade date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses incurred in the administration of the Plan are paid by the Employer and are excluded from these financial statements. Investment-related fees are included in net appreciation in fair value of investments. Fees related to participant directed transactions are charged directly to the participant's account and are included in administrative expenses.

### **Subsequent events**

The plan was evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

## **3. CERTIFIED INVESTMENT INFORMATION:**

Certain information in the accompany financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower), qualified institutions.

**4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in the active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurements level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 or 2023.

- Mutual funds: The fair value of these securities is based on the net asset value (NAV) of shares held by the plan at year end which is based on observable market quotations for identical assets and are priced on a daily basis at the close of business.

**5. GROUP ANNUITY CONTRACT:**

The Plan holds a traditional fully benefit-responsive group annuity contract issued by Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The Plan may transact according to the terms defined in the contract at any time, however, certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the early termination of the contract prior to Empower's recovery of start-up costs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract may be terminated by the issuer with at least sixty days of advance written notice to the other party.

**6. PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are managed by Empower, the qualified institution, and, therefore, these transactions qualify as party-in-interest transactions to the Plan.

**7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**8. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts and the amounts reported in the statement of net assets available for benefits.

**9. TAX STATUS:**

The Plan adopted a non-standardized pre-approved plan which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with applicable requirements of the IRC. While the Employer has not obtained its own determination letter on the Plan, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in these financial statements.

**10. NONEXEMPT TRANSACTIONS:**

During 2024 certain employee deferrals totaling \$1,917 were not remitted to the Plan on a timely basis in accordance with Department of Labor guidelines. These transactions constitute nonexempt transactions. The Employer will take necessary corrective action for all affected participants.

**11. PLAN OPERATIONS:**

The Plan Administrator adopted the distribution relief provisions included in the CARES Act which permitted qualified individuals to request a pre-approved distribution, through participant self-certification of eligibility. The maximum dollar amount that could be requested per participant was \$100,000 up through December 30, 2020.

The Employer intends to formally amend the Plan before the end of the applicable remedial amendment period to reflect such provision
