There has been a change in both the enrolled actuary, and a change in the business organization providing actuarial services to the plan. Additionally, the new enrolled actuary uses different valuation software than the prior enrolled actuary. In comparing results of the prior enrolled actuary to, no changes in non-prescribed assumptions or other changes in method were made. The Funding Target and Target Normal Cost determined with the new software are each within 3% and the Actuarial Value of Plan Assets are within 2% of those values as determined by the prior enrolled actuary as of the prior year valuation date, using the same actuarial assumptions. The other conditions listed in Revenue Procedure 2017-56 have also been satisfied, so automatic approval for this change is provided by that Revenue Procedure.
