### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTE A – PLAN DESCRIPTION

The following description of the Solid Ground Washington Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a 401(k) defined contribution plan covering all eligible employees of Solid Ground. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Eligibility and Participation

Any full-time employee of Solid Ground, except those participating in a plan sponsored by a collective bargaining agreement, who has attained the age of 18 is eligible to participate. Participants must generally complete six months of service to be eligible for the discretionary employer contribution.

#### Contributions

Participants may elect to contribute between 1% and 100% of eligible compensation to the Plan annually. During 2024, Solid Ground made a discretionary contribution equal to 3% of each participant's eligible compensation. Effective March 1, 2014, the Plan was amended to include an employer match and was amended again effective January 1, 2015 to raise the employer match to one-third of the first 3% deferred, up to 1% of eligible wages. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective May 1, 2022, the Plan was amended to permit roth contributions. Contributions are subject to regulatory limitations.

#### Participant Accounts

Participants direct the investment of their contributions and Solid Ground's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution and allocations of (a) Solid Ground's contribution, (b) Plan earnings or losses, and (c) charged with an allocation of administrative expenses. Contributions are allocated based on eligible compensation. Plan earnings or losses and administrative expenses are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are 100% vested in all participant and employer contributions upon entrance into the Plan.

#### Administrative Expenses

The Plan pays recordkeeping, custodian and investment management fees.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or beneficiary thereof, will receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount, subject to certain restrictions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, subject to certain restrictions.

NOTE B - SIGNIFICANT ACCOUNTING POLICES

Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America as applied to defined contribution plans, and in accordance with the Plan agreement.

Fair Value Measurements

In accordance with financial accounting standards, a three-tiered hierarchy of input levels is used for measuring fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date. Valuation techniques utilized to determine fair value are consistently applied. The three tiers of inputs used for fair value measurements are as follows:

Level 1: Fair values are based on quoted prices in active markets for identical assets.

Level 2: Fair values are based on observable inputs that include: quoted market prices for similar assets; quoted market prices that are not in an active market; or other inputs that are observable in the market and can be corroborated by observable market data for substantially the full term of the assets.

Level 3: Fair values are calculated by the use of pricing models and/or discounted cash flow methodologies, and may require significant management judgment or estimation. These methodologies may result in a significant portion of the fair value being derived from unobservable data.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Investment Valuation

Investments are stated at fair value (except for the collective trust, which is reported at net asset value) as certified by the Plan's custodian, Matrix Trust Company.

### NOTE B – SIGNIFICANT ACCOUNTING POLICIES (Continued)

The Morley Stable Value Fund (the Fund) is a collective trust that invests mainly in investment contracts and synthetic investment contracts. The objective of the Fund is to provide investments offering yields consistent with a stable fixed-income methodology and the assumption of investment risk, providing for preservation of capital; stability and predictability of returns; liquidity to pay plan benefits; and high credit quality. Plan participants may redeem their investment for permitted transactions at net asset value (NAV).

Units held in the Fund are valued using the NAV of the fund. The NAV is based on the contract value of the underlying investment contracts held by the fund, minus its liabilities, and then divided by the number of units outstanding. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount to be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Fund at NAV. The net crediting rate of the Fund was 2.85% and 2.76%, respectively, for the years ending December 31, 2024 and 2023.

#### Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

#### Payment of Benefits

Benefits are recorded when paid.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires that the plan administrator make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### NOTE C - INCOME TAX STATUS

The Internal Revenue Service has determined and informed Solid Ground, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE D - TERMINATION OF THE PLAN

Although Solid Ground has not expressed any intent to do so, it has the right to terminate the Plan subject to the provisions of ERISA.

### NOTE F - INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of:

- The fair value of mutual funds of \$12,319,237 and \$11,057,787 included in the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively.
- The contract value of \$1,069,085 and \$1,048,382 of the collective trust at December 31, 2024 and 2023, respectively.
- Investment returns totaling \$1,248,555 are included on the statement of net assets available for benefits for the year ended December 31, 2024.
- Investment information contained in the supplemental information.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

### NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Matrix Trust Company acts as the custodian of the Plan investments and, therefore, transactions with Matrix Trust Company qualify as exempt party-in-interest transactions. Fees paid to the custodian by the Plan for account services totaled \$41,788 for the year ending December 31, 2024.

### NOTE I - SUBSEQUENT EVENTS

Management has evaluated events occurring subsequent to December 31, 2024 through October 6, 2025, which is the date the financial statements were available to be issued and has recognized in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at December 31, 2024 including the estimates inherent in the processing of financial statements.
