INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Cornerstones, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cornerstones, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cornerstones, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cornerstones, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cornerstones, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

The following description of the Cornerstones, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a safe harbor 401(k) plan covering all eligible employees of Cornerstones, Inc., (formerly Reston Interfaith, Inc.) a non-profit corporation. The Company adopted the Retirement Planners & Administrators, Inc. Volume Submitter 401(k) Profit Sharing Plan effective August 1, 1999. The Plan was amended and restated effective January 1, 2016 to bring Plan into compliance with the Pension Protection Act of 2006 (“PPA”) and other legislative and regulatory changes.

Effective March 14, 2017, the Company also amended the Plan to allow participants to refinance loans.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees who have reached the age of 18 are eligible for all contribution types on the first day of the month coinciding with or next following date requirements met. Residents of Puerto Rico are excluded from participating in the Plan.

Administration of the Plan

The Company serves as the Plan Administrator. John Hancock Life Insurance Company serves as trustee as well as the recordkeeper.

Contributions

The Plan permits the following contribution types as described below:

Elective Deferrals

Participants may elect to have compensation deferred by up to 75% of their compensation, subject to the maximum limit under Section 415 of the Internal Revenue Code (“IRC”), which was \$23,000 for 2024. Participants who have attained the age 50 before the end of the plan year are eligible to make additional catch-up contributions. Such catch-up contributions are subject to an annual IRC limitation, which was \$7,500 for 2024. The Plan also allows for rollover contributions from other qualified plans.

Participants may change their salary deferral percentage at any time and are permitted to revoke their election at any time during the plan year. Participants may change their investment options at any time.

Employer Safe Harbor Matching Contributions

The Employer makes an enhanced matching contribution equal to the sum of 100% of the participant's elective deferrals that do not exceed 4% of the participant’s compensation. The matching safe harbor contribution is made each payroll period.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Employer Matching Contribution

The Employer may make matching contributions equal to a discretionary percentage, to be determined by the Employer, of the Participant's Elective Deferrals. There were no matching contributions for the year ended December 31, 2024.

Employer Profit-sharing-contribution

Discretionary contribution, are determined by the Employer. There were no profit-sharing contributions for the year ended December 31, 2024.

Vesting

Participants are immediately vested in their voluntary contributions (including any rollover contributions) plus actual earnings thereon and in the Company's contribution, plus actual earnings thereon.

Participant Accounts

Each participant's account is credited with the participants' contributions and allocations of (a) the employer contribution and (b) Plan earnings or losses, and charged investment expenses. Allocations are based on participant earnings or account balances, as defined. Participants self-direct their investment selections. Investment options include mutual funds and target date funds.

Participant Notes Receivable

Participants may borrow from their vested accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% over prime rate determined when the loan was made.

Payment of Benefits

Distributions may be made as soon as administratively feasible upon severance of employment. Participant consent is required only if distribution is over \$1,000. Participants who have severed employment may not elect to defer a distribution beyond age 62 or participant's normal retirement age. In-service distributions are permitted from all vested accounts to participants that have attained age 59 1/2. Distributions upon death of participant will be made within 5 years of death for all beneficiaries. In addition, hardship distributions are permitted if certain criteria are met. Benefits are recorded when paid.

Forfeitures

Forfeitures will occur as of the earlier of (1) the last day of the Plan Year in which the former Participant incurs five (5) consecutive 1-Year Breaks in Service, or (2) the distribution of the entire vested portion of the Participant's Account.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared using the accrual method of accounting, with the exception of the payment of benefits, which are recognized as a reduction in the Net Assets Available for Benefits of the Plan as they are disbursed to participants.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested benefit.

Investment Valuation

The Plan's investments are held by John Hancock Life Insurance Company, at December 31, 2024. Investments in mutual funds are stated at their fair value determined by the unit value as reported by John Hancock Life Insurance Company, at December 31, 2024. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on the trade date.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans is recorded on an accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. The entire unpaid balance and interest of the note will become due and payable upon (a) termination of employment or (b) failure to make a scheduled payment. Default on the loan will occur if repayment is not made in full by the end of the calendar quarter following the calendar quarter in which either one of the above events occurs.

Forfeitures

Forfeitures, if any, may be made available to reinstate previously forfeited account balances of Former Participants or used to satisfy any employer contribution that may be required. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. A total of \$0 and \$0 of forfeitures were applied to employer contributions in 2024 and 2023, respectively.

Administrative Expenses

Administrative fees are paid by the Plan. Administrative fees for loans are paid by each participant who has borrowed money from their account. All other fees, including professional fees are paid by the Company.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Balances of Terminated Participants

As of December 31, 2024 and 2023 the total vested account balances of terminated employees amounted to \$1,072,391 and \$1,177,584 respectively.

NOTE 3 – FAIR VALUE MEASUREMENTS

ASC 820, Fair Value Measurement (“ASC 820”) defines fair value, establishes a framework for measuring fair value in accordance with U.S. GAAP and expands disclosures about the fair value measurement. ASC 820 provides guidance on how to measure fair value by providing a fair value hierarchy used to classify the source of the information.

ASC 820 requires that assets and liabilities carried at fair value be classified and disclosed in one of the following categories:

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment’s level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan Sponsor’s assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment. Inputs applicable to a particular investment type, or a specific investment, may vary from period to period.

The plan invests in a group annuity contract with John Hancock Life Insurance Company. The contract is part of a pooled separate account that invests primarily in fixed-income securities and seeks to preserve principal and provide a stable return.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

The fair value of the contract is based on the net asset value (NAV) of units held in the John Hancock Pooled Separate Account, as reported by the insurance company, which uses observable market inputs for the underlying investments. The contract is classified as Level 2 in the fair value hierarchy.

There are no restrictions on participant-directed redemptions. The fair value and contract value of the investment as of December 31, 2024, were \$5,299,515 and \$4,971,178, respectively.

There were no significant transfers between level I, II or III fair value measurements during the years ended December 31, 2024 and 2023.

NOTE 4 – CERTIFIED FINANCIAL INFORMATION

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include investments managed by John Hancock. John Hancock is the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Professional fees paid to John Hancock were \$14,419 net of invested-related revenue used towards cost of Plan services for the year ended December 31, 2024 and were based on customary and reasonable rates.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – TAX STATUS

The Plan operates under a volume submitter plan document sponsored by Retirement Planners & Administrators, Inc. The volume submitter plan received a favorable opinion letter dated March 31, 2014 from the Internal Revenue Service as to the volume submitter plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – SUBSEQUENT EVENTS

For purposes of these financial statements, subsequent events were evaluated through October 14, 2025, the date of issuance of the financial statements.
