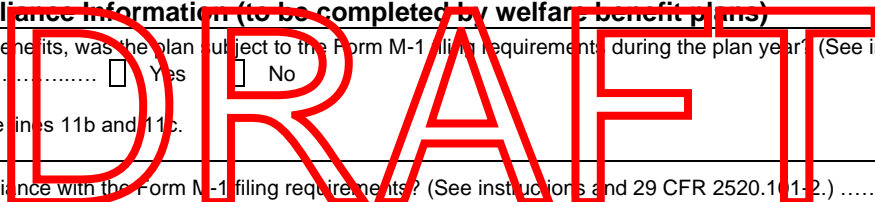

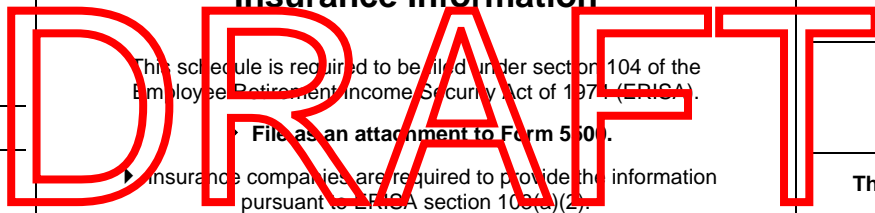

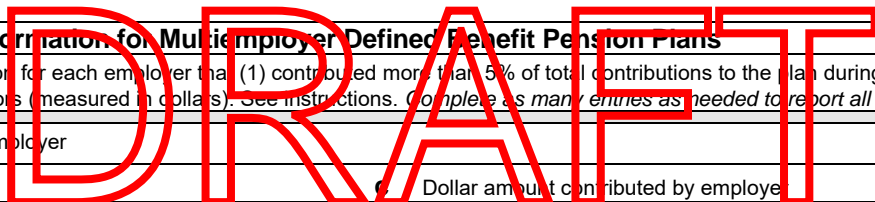

### Note 1: Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Inter-Lakes Community Action Partnership, Inc. (the "Plan") is provided only for general information purposes. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan under Code Section 403(b) covering all qualified employees of Inter-Lakes Community Action Partnership, Inc. (the "Employer"). The Employer is the plan sponsor and is a not-for-profit organization as described in Section 501(c)(3) of the Internal Revenue Code (IRC). Employees are eligible to participate in the Plan immediately upon date of hire. Employees are eligible for the employer matching contribution after completion of six months of service and if they normally work more than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

In December 2022, the Setting Every Community Up for Retirement Enhancement Act 2.0 (SECURE 2.0) was signed into law. Required amendments will be made to the plan in accordance with law and Internal Revenue Service (IRS) guidelines.

#### Contributions

Each year participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, subject to limitations specified by the IRS. Participants can also make Roth elective deferrals which are "after tax" deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). In addition, qualified employees may elect to defer an additional special Code 403(b) catch-up contribution as defined in the plan document. The Plan allows for employer matching contributions. During 2024 and 2023, the employer matching contributions were 100% of the participant's elective deferrals up to 3% of the participant's eligible compensation, totaling \$127,636 and \$133,798, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limits.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's matching contributions and an allocation of the plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in all contributions, plus actual earnings thereon.

#### Plan Loans

Participants may use their vested balance to collateralize loans directly from Mutual of America Life Insurance Company outside of the Plan. The balances of these loans are not paid through payroll deductions and are not considered plan assets and thus are not reported on the statements of net assets available for benefits, however they are secured by the balance in the participant's interest accumulation account where 120% of the principal balance is held as reserve. The loan balances collateralized by the Plan's assets with Mutual of America Life Insurance Company as of December 31, 2024 and 2023 were \$55,411 and \$28,899, respectively.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the vested portion of the participant's account does not exceed \$5,000, the account balance may be paid out in a lump sum, rolled into an IRA or another qualified plan, or any combination of these when requested by the participant. However, when a request is not received, accounts with balances less than \$1,000 will be automatically distributed and accounts with balances between \$1,000 and \$5,000 will be automatically rolled over into a qualified Individual Retirement Account. If the vested portion of the participant's account exceeds \$5,000, the distribution will be made after the participant or beneficiary gives consent. The Plan allows participants to make hardship withdrawals, provided certain conditions are met. In-service distributions are allowed for participants who are 59 ½ years old.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account; however, there were no notes receivable from participants as of December 31, 2024 and 2023. The notes bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of distributions or for holding an account balance after the participant has terminated employment are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses in investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### Cash Equivalent

The Plan considers investments in Mutual of America's General Account (i.e. the Interest Accumulation Account) to be a cash equivalent.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments or deemed distributions on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled separate accounts:* Fair value of pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. For the Lincoln pooled separate accounts, fair value is based on the fair value of the underlying mutual funds held in pooled separate accounts. Lincoln uses NAV as a practical expedient to estimate fair value.

### Note 4: Information Prepared and Certified by the Plan's Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, cash equivalents, which include plan loans, and the fully benefit-responsive investment contract held at December 31, 2024 and 2023, and net appreciation in fair value of investments and, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company and The Lincoln National Life Insurance Company (Lincoln), the Custodians of the Plan.

### Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan has a fully benefit-responsive guaranteed investment contract (GIC) with Lincoln. Lincoln maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with Lincoln and is based on the individual contracts in place.

Such interest rates are reviewed on a quarterly basis depending on the contract for resetting, with guaranteed minimum interest rates that change either on a five year or ten year basis. The minimum guaranteed rates on the contracts range from 1.75% to 3.00%.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

### Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 7: Party in Interest Transactions

Certain plan investments are managed by Mutual of America Life Insurance Company and Lincoln. Mutual of America Life Insurance Company and Lincoln are the Custodians as defined by the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees incurred and paid by the Plan for administrative expenses were \$910 and \$638 for the years ended December 31, 2024 and 2023. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, which for certain investments are paid through revenue sharing, rather than a direct payment.

### Note 8: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA.

### **Note 9: Tax Status**

The Employer adopted a nonstandard prototype document with an IRS notification letter, dated March 31, 2017, which states the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
