The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

General

The following description of Rainbows United, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Rainbows United, Inc. (Organization) for the benefit of its employees who have attained age 18 and have at least 1 hour of service. Direct Service Providers of Family Support Services employees of the Organization must complete one year of service (with 1,000 hours of service) and attain age 18. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). INTRUST BANK, N.A. is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to 75 percent of eligible compensation. Roth and employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Each year, the Board of Directors determines the amount of matching contributions to the Plan. The Organization made matching contributions of 50 percent of employees' salary deferral amounts on the first 6 percent of employees' compensation in 2024 and 2023.

Participant Investment Account Options

Each participant has the option of directing contributions into any of the various investment options offered by the Plan and may change the allocation to the extent permitted by the individual agreements.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 2 percent of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred of 1 percent and is ultimately capped at 6 percent.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Organization's contribution portion of their account plus earnings thereon is based on years of service. A participant is fully vested after five years of service.

Payment of Benefits

On termination of service including due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or other periodic installments over a period as defined in the Plan. If the participant is married, the benefit provides a life annuity for the participant and a survivor annuity payable for the remaining life of the participant's surviving spouse equal to 50 percent of the amount of the annuity payable during the life of the participant. If the participant is not married the benefit provides for a life annuity for the participant. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

A lump-sum distribution is required for vested account balances less than \$5,000. Additionally, a participant may also elect to have a portion, or all their distributions paid in the form of a direct trustee-to-trustee transfer to another eligible retirement plan designated by the participant. A participant may also receive a distribution of their deferral contributions if a participant has a financial hardship as defined in the Plan.

At December 31, 2024, plan assets include \$20,025 of pending investment redemptions (includes a \$25 administrative fee) for a benefit payment requested by a participant in December 2024 that was not paid out until January 2025.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,348 and \$2,540, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. \$0 and \$39,671 of the forfeited non-vested account balances were used to reduce employer contributions or pay plan expenses in 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the common trust fund is valued based on information reported by the investment advisor using the audited financial statements of the stable value fund at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which they employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, INTRUST Bank, N.A., a qualified institution, has certified the following information included in the accompanying financial statements and supplemental schedules is complete and accurate.

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

INTRUST Bank, N.A., is the trustee as defined by the Plan. Plan assets are held and managed by the trustee. Nestegg, a division of INTRUST Bank, N.A., serves as the Plan's recordkeeper. Therefore, these transactions qualify as party-in-interest transactions. The plan sponsor pays directly any other fees related to the Plan's operations.

An Advisory Committee, appointed by the Organization, administers certain aspects of the Plan. The Advisory Committee has the duty to determine rights of eligibility of an employee to participate in the Plan and the value of a participant's account balances and vested interest. The Advisory Committee also has the duty to enforce the terms of the Plan, the duty to review and render decisions requesting claims for benefits under the Plan, select the investment funds available to participants under the Plan and certain other ministerial duties. The members of the Advisory Committee serve without compensation from the Plan.

The Plan paid \$30,164 and \$26,533 of trustee fees during 2024 and 2023, respectively. Recordkeeping fees paid by the Plan during 2024 and 2023 amounted to \$11,962 and \$11,845, respectively. The Organization provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a non-standardized pre-approved profit-sharing plan document sponsored by INTRUST Bank, N.A. This pre-approved plan document received a letter from the Internal Revenue Service stating that the plan is acceptable under the appropriate section of the Internal Revenue Code (IRC). The Plan itself has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer’s general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. Contributions of \$50 were not remitted within the required time period for the year ended December 31, 2023.
