Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedule of Schedule of Delinquent Contributions and Schedule of Assets Held at End of Year are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note A – Description of Plan**

The following description of the Methodist Manor Retirement Community (the Company) 403(b) Plan (hereinafter referred to as the Plan) is provided for general purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a defined contribution plan adopted January 1, 2007, for eligible employees of the Company. All employees who normally work 20 hours or more a week are eligible to contribute to the Plan. Employees who have attained the age of twenty-one and have worked three consecutive full calendar months are eligible for employer contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

An employee who is eligible to participate in the Plan may file an elective deferral agreement for an amount up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans. Participants direct their contributions into various investment options offered by the Plan.

The Company may make a matching contribution at their discretion. The matching contribution may be determined as a percentage of the eligible participant's salary deferrals or as a uniform dollar amount. Contributions are subject to certain limitations. For the years ended December 31, 2024 and 2023, the Company used the following formula in calculating the employer match: 100% match on the first 2% of compensation that an employee defers, and a 50% match on the next 6% of compensation that an employee defers. Employer matches are funded 100% by Methodist Manor Retirement Community by the due date of the Company's federal tax return. The Company has the right to discontinue their contributions at any time and terminate their portion of the Plan subject to the provisions set forth in ERISA.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, allocations and Plan earnings. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on their accounts is based on years of continuous service as follows:

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either in a lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In-service Distributions

In-service distributions may be made to a participant who has not separated from service and has attained age 59 ½. Amounts withdrawn must be 100% vested.

Forfeitures

A forfeiture occurs at the end of the year when a participant terminates his or her employment before reaching six years of service. Forfeited nonvested accounts totaled \$0 and \$17,224 as of December 31, 2024 and 2023, respectively. Forfeitures will be allocated to reduce future employer contributions.

Hardship Distributions

There is no minimum amount set for hardship distributions or in-service distributions. The hardship distributions are limited only to an immediate and heavy financial need. Hardship distributions for expenses of a beneficiary are allowed.

**Note B – Summary of Significant Accounting Policies**

Preparation of the Financial Statements

The Plan prepares its financial statements in accordance with the Department of Labor's rules and regulations on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from the estimates.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

**Note B – Summary of Significant Accounting Policies (Continued)**

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing the information provided by the investment advisers, custodians and insurance company. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Loans

Loans are not available to participants under this plan.

Payment of Benefits

Benefits are recorded when paid.

**Note C - Investments**

The Plan's trustees have provided certifications to the plan administrator regarding the accuracy and completeness of certain information related to investment holdings of the Plan and the income and expenses of the Plan. The following information certified by the trustees has been used in the preparation of the accompanying financial statements. This information is unaudited.

**Note D – Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by Matrix Trust Company. Matrix Trust Company is the trustee and record-keeper for the Plan and, therefore, these transactions qualify as party in interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

**Note E – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note F – Tax Status**

The IRS has determined and informed the Company by a letter dated March 2, 2007, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the US Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note G – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**Note H – Administration Expenses Paid by the Plan**

For the years ended December 31, 2024 and 2023, the Plan paid third party administration fees of \$11,374 and \$10,083, respectively.

**Note I – Plan Operational Deficiencies**

During the audit process, it was discovered various salary deferrals were not deposited into the plan within a timely manner. The plan administrator will continue to monitor and improve salary deferral contributions so they are made in a timely manner.
