Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mitchell & Titus, LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of the Mitchell & Titus, LLP 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the eligible partners and employees of Mitchell & Titus, LLP (the "Company"). Generally, partners and employees automatically become participants on the first day of their employment unless they waive participation in writing. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute, or elect to defer, a dollar amount or a percentage of their annual compensation as defined by the Plan, subject to limits of the Internal Revenue Code ("IRC"). Annual contributions by participants are limited to a maximum contribution amount as prescribed by the IRC. The Company matches the elected contributions of participants up to a maximum of 50% of that portion of contributions which do not exceed 4% of the participant's annual compensation as defined by the Plan. During 2024, an employer matching contribution was made to the Plan in the amount of \$204,631. Forfeitures of \$42,735 were used toward this amount. Participants direct their contributions into the various investment options. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from the Plan the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account with interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. A fee is charged to participants initiating loans. Principal and interest are paid ratably through payroll deductions. Upon termination any unpaid loan balance could become a taxable distribution to the participant.

1. Description of Plan (*continued*)

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan's provisions. Investment related expenses are included in the Net Asset Value ("NAV") of the respective funds and, consequently, those expenses are not separately reflected, but are a component of net appreciation in fair value of investments.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of service as follows:

Less than 2 years of service	0%
2 years of service	20%
3 years of service	40%
4 years of service	60%
5 or more years of service	100%

Payment of Benefits

Upon termination of service with the Company, a participant may elect to receive either a lump-sum distribution equal to the value of his or her account less the required Federal withholding, if any, or have the full balance in his or her account transferred to a qualified plan.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$119,303 and \$74,371, respectively. These accounts will be used to reduce future Company contributions. In 2024, \$42,735 of forfeitures were used to reduce employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual funds are stated at fair value as determined by quoted market prices, which represents the NAV of shares held by the Plan at year end.

Investment Valuation and Income Recognition (continued)

The Fidelity Advisor Stable Value II Fund, a common collective trust fund, invests in fully benefit-responsive investment contracts. This fund is recorded at contract value. Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. There are no significant redemption restrictions. The contract value represents contributions plus earnings, less participant withdrawals and administrative expenses. The fair value is derived from the underlying assets using discounted cash flow models and observable market inputs (Level 2), and may differ from contract value due to market fluctuations. The difference is disclosed in Note 10.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation in investments at fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefit

Benefits are recognized when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 10, 2025.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan.

Mutual funds – The mutual funds were valued at the NAV of the shares held by the Plan based on publicly traded prices. These investments fall within the Level 1 fair value hierarchy at December 31, 2024 and 2023.

5. Excess Contribution Payable

Excess contributions payable represent amounts due to participants for a return of excess employee deferral contributions as required to satisfy the relevant nondiscrimination requirement of the IRC.

6. Exempt Party-in-Interest Transactions

Certain administrative functions are performed by the partners and employees of the Company, which are exempt party-in-interest transactions. No such partner or employee received compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Company. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA.

Certain Plan investments are shares of mutual funds and a common/collective trust managed by Fidelity Management Trust Company, the trustee, as defined by the Plan at December 31, 2024. Therefore, these transactions of the Plan qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, there shall be no reduction of any participant's or beneficiary's proportionate interest in the Plan or diversion of any portion of the Plan's funds for purposes other than the exclusive benefit of participants and their beneficiaries prior to the satisfaction of all liabilities under the Plan. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Risks and Uncertainties (*continued*)

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

10. Reconciliation of Financial Statements to Form 5500

This adjustment is presented in accordance with ASC 962-325 and DOL requirements. It reflects fair value reporting for Form 5500 and does not affect GAAP net assets.
