We have performed audits of the accompanying financial statements of The Orvis Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Orvis Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Plan Description

The following description of The Orvis Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of The Orvis Company (the “Company”) who are at least 18 years of age and have compiled a minimum of two months of service. The Plan excludes employees whose employment is governed by a collective bargaining agreement, leased employees, and residents of Puerto Rico. Unless otherwise elected, participants are automatically enrolled at 3% with 1% annual automatic increases, up to 10% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 90% of eligible compensation as pre-tax or Roth deferrals up to the maximum allowable under the *Internal Revenue Code* (IRC), as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. The Company makes a safe harbor matching contribution equal to 100% of the first 3% of eligible compensation plus 50% of the next 3% of eligible compensation deferred. The Company may contribute amounts at the discretion of the Company’s board of directors. Participants are eligible to receive the Company’s discretionary contributions if they are employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year, as defined. There was no additional discretionary contribution in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Plan was amended effective January 1, 2024, to reinstate the Company’s safe harbor matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, an allocation of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions is based on years of service. A participant is 100% vested in the Company’s contributions after two years of credited service.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive either a lump sum amount or installment payments equal to the value of the participant’s vested interest in his or her account. In service withdrawals are available to participants age 59 ½ and for hardship. Vested account balances less than or equal to \$1,000 are subject to automatic cash out, as defined.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$112,015 and \$129,111, respectively. The forfeited accounts may be used to pay Plan administrative expenses or reduce employer contributions. During 2024, \$152,625 in forfeitures were used to reduce employer contributions.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set by the Plan Administrator, based on prevailing interest rates charged by lending institutions. Principal and interest are paid ratably through monthly payroll deductions over a period no longer than ten years. The interest rate ranged from 4.25% to 9.50% at December 31, 2024.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective May 31, 2025, the Plan was amended to suspend the Safe Harbor Match.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The collective investment trust fund issued by Galliard (Galliard Stable Return Fund E) and owned at December 31, 2024 and 2023 is invested 100% in Galliard Stable Return Fund Core which is composed primarily of a variety of guaranteed investment contracts, security-backed contracts, and short-term investment funds and are valued at the net asset value of units of Galliard collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount

different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is no notice period if the Plan initiates a full redemption of the collective investment trust.

Note 4 – Investment Contracts

The Plan has investments in the Galliard Stable Return Fund. Included in these funds are guaranteed investment contracts and certain wrapper contracts. These contracts are benefit-responsive and are required to be stated at fair value. The average yields for the funds are as follows:

The objective of the Funds is to provide a moderate level of stable income without principal volatility.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds issued and managed by the Plan Trustee. Investments in funds issued and managed by the Trustee are considered related party transactions. Fees paid to the Trustee by the Plan for investment management and trust services amounted to \$152,672 for 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan is an adoption of a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management Trust Company. The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended, however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Orvis Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Orvis Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Orvis Company 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management


Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Orvis Company 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1 – Plan Description

The following description of The Orvis Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of The Orvis Company (the “Company”) who are at least 18 years of age and have compiled a minimum of two months of service. The Plan excludes employees whose employment is governed by a collective bargaining agreement, leased employees, and residents of Puerto Rico. Unless otherwise elected, participants are automatically enrolled at 3% with 1% annual automatic increases, up to 10% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 90% of eligible compensation as pre-tax or Roth deferrals up to the maximum allowable under the *Internal Revenue Code* (IRC), as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. The Company makes a safe harbor matching contribution equal to 100% of the first 3% of eligible compensation plus 50% of the next 3% of eligible compensation deferred. The Company may contribute amounts at the discretion of the Company’s board of directors. Participants are eligible to receive the Company’s discretionary contributions if they are employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year, as defined. There was no additional discretionary contribution in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Plan was amended effective January 1, 2024, to reinstate the Company’s safe harbor matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, an allocation of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions is based on years of service. A participant is 100% vested in the Company’s contributions after two years of credited service.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive either a lump sum amount or installment payments equal to the value of the participant’s vested interest in his or her account. In service withdrawals are available to participants age 59 ½ and for hardship. Vested account balances less than or equal to \$1,000 are subject to automatic cash out, as defined.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$112,015 and \$129,111, respectively. The forfeited accounts may be used to pay Plan administrative expenses or reduce employer contributions. During 2024, \$152,625 in forfeitures were used to reduce employer contributions.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set by the Plan Administrator, based on prevailing interest rates charged by lending institutions. Principal and interest are paid ratably through monthly payroll deductions over a period no longer than ten years. The interest rate ranged from 4.25% to 9.50% at December 31, 2024.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective May 31, 2025, the Plan was amended to suspend the Safe Harbor Match.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The collective investment trust fund issued by Galliard (Galliard Stable Return Fund E) and owned at December 31, 2024 and 2023 is invested 100% in Galliard Stable Return Fund Core which is composed primarily of a variety of guaranteed investment contracts, security-backed contracts, and short-term investment funds and are valued at the net asset value of units of Galliard collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount

different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is no notice period if the Plan initiates a full redemption of the collective investment trust.

Note 4 – Investment Contracts

The Plan has investments in the Galliard Stable Return Fund. Included in these funds are guaranteed investment contracts and certain wrapper contracts. These contracts are benefit-responsive and are required to be stated at fair value. The average yields for the funds are as follows:

The objective of the Funds is to provide a moderate level of stable income without principal volatility.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds issued and managed by the Plan Trustee. Investments in funds issued and managed by the Trustee are considered related party transactions. Fees paid to the Trustee by the Plan for investment management and trust services amounted to \$152,672 for 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan is an adoption of a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management Trust Company. The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended, however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
