INDEPENDENT AUDITOR'S REPORT

To the Plan Participants and Plan Administrator of
Matrix Human Services Tax Sheltered Annuity Plan
Detroit, Michigan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Matrix Human Services Tax Sheltered Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1) DESCRIPTION OF THE PLAN

The following description of the Matrix Human Services Tax Sheltered Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description and the Plan Document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Matrix Human Services (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by Matrix Human Services (the Organization). Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company was the custodian of the plan for the years ended December 31, 2024 and 2023. The Custodian invests funds received from contributions, investment sales, and interest and dividend income and makes distribution payments to the applicable participant.

Eligibility

All employees who are hired to work for at least twenty hours per week are eligible to participate in the plan. An employee is considered to work more than twenty hours per week if 1) for the twelve-month period beginning on the employee's hire date, the Organization reasonably expects the employee to work more than 1,000 hours in such period or 2) for each Plan year ending after the close of the twelve-month period beginning on the employee's hire date, the employee worked more than 1,000 hours in the preceding twelve-month period.

Contributions

Each year, participants may contribute to the Plan up to 100% of their pre-tax annual compensation, as defined in the Plan, subject to the maximum permitted by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Organization may, at its discretion, make qualified non-elective contributions. Contributions are subject to certain IRS limitations. Participants direct the investments of their contributions into various options offered by the Plan.

1) DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately vested in their salary deferral contributions and any Organization qualified non-elective contributions plus actual earnings thereon.

Distributions

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments or annuity as defined by the Plan's agreement. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Withdrawals

Distributions of a participant's account balance may be authorized at any time by the plan administrator under certain hardship conditions as specified in the Plan Document.

Participant Account

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions, rollover contributions, allocations of the Organization's contributions (if any), and Plan earnings or losses as defined by the Plan agreement. Plan earnings or losses are allocated daily based on each participant's account balance. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Notes Receivable from Participants

The Plan allows participants to borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Such loans bear interest at the prime rate in effect at the time of origination plus 1% per annum. Principal and interest are paid ratably through payroll deductions. The outstanding loan balance for the years ended December 31, 2024 and 2023 was \$90,353 and \$99,671 respectively.

Forfeitures

As of December 31, 2024, and 2023, forfeiture accounts had a balance of \$0. At December 31, 2024 and 2023, the Plan had a balance of \$47 and \$44 in unallocated accounts respectively.

2) SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are paid directly by the participant. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value, by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodian of the Plan for the years ended December 31, 2024, and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See footnote 4 on "Fair Value Measurement" for more details.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / depreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid out of the Plan.

Plan Expenses

The Plan's administrative expenses are paid either by the Plan or the Organization as provided by the Plan agreement. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are adjusted against investment income. For fiscal year 2024 and 2023, the investment related expenses are included in the Plan expenses.

Recently Adopted Accounting Standards

Effective January 1, 2023, the Plan adopted accounting standards update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments (FASB ASC 326), which significantly changed how entities measure credit losses for most financial assets. The most significant change in the standard is a shift from the loss methodology incurred to an expected loss methodology. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were contributions receivable. There was no material impact to the financial statements as a result of the adoption of ASU 2016-13.

3) CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company qualified institution (the custodian of the Plan).

4) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

5) FULLY BENEFIT-RESPONSIVE GUARANTEED INVESTMENT CONTRACT

The Plan entered into a fully benefit-responsive guaranteed option investment contract with Principal Life Insurance Company totaling \$3,704 for 2024 and \$2,486 for 2023. The Principal Guaranteed Option is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed option investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is declared from time to time by Principal Life. Those participants enrolled in the Plan and contract shall receive an effective crediting annual interest rate of approximately 2.55%. The crediting rate is reviewed on a periodic basis for resetting. The guaranteed option investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

6) ERISA BOND REQUIREMENTS

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000.

7) TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations prior to 2021.

8) PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

10) TRANSACTIONS WITH PARTIES-IN-INTEREST

Transactions with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company as Custodian of the Plan are party-in-interest transactions, as defined by ERISA. In addition, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and MAP Retirement provide certain administrative services to the Plan pursuant to service agreements between the Organization and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and MAP Retirement. Amounts paid by the Plan to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and MAP Retirement for these administrative services qualify as party-in-interest transactions.

11) LATE REMITTANCES OF CONTRIBUTIONS TO THE PLAN

During the plan year, the Organization failed to remit certain participant salary deferrals and loan repayments to the Plan's trustee within the time frame required by the Department of Labor's regulations.

Late remittances totaling \$938, identified in 2023, were corrected during 2024. However, additional late remittances of \$30,182 related to 2022 and \$10,303 identified in 2024 had not been remitted to the Plan as of the date of this report.

The Organization is in the process of calculating and remitting lost earnings associated with these delinquent participant contributions. These late remittances are disclosed in the supplemental information, Schedule H, Part IV, line 4a (Schedule of Delinquent Participant Contributions).

12) SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. No significant event was noted that required adjustment or disclosure in the financial statements.
