ERISA: Post-retirement, IRS 2024 Static Mortality Table using combined tables for annuitants and non-annuitants as published in the final regulations for 1.430(h)(3)-1(e) (previously IRS 2023 Static Mortality Table). No mortality is assumed prior to retirement. The actuary has determined that pre-retirement mortality rates are not material to the determination of the plan's liability for this population.

Retirement Rates: 100% of active participants are assumed to retire at age 62. 100% of terminated vested participants are assumed to retire immediately. Gains or losses resulting from actual retirement experience will be recognized through the routine application of the actuarial cost method.

Termination Rates: No termination rates have been assumed. The actuary has determined that turnover rates are not material to the determination of the plan's liability.

Marital Status: Not applicable in the valuation due to death benefit being 100% of the vested accrued benefit and the assumed form of payment being a lump sum.

Maximum Benefit: \$275,000 for 2024.

Maximum Salary: \$345,000 for 2024.

Form of Payment: 100% of participants are assumed to take a lump sum.

Data Assumptions: No data assumptions were necessary for missing or incomplete information.

Actuarial Value of Plan Assets for Funding Purposes: The actuarial value of assets is equal to the market value of assets (including discounted employer contributions receivable) on the valuation date.

Shortfall Amortization Charge for ERISA Funding Purposes: Per IRC Section 430(c), the shortfall amortization charge for any plan year is the aggregate total (not less than zero) of the shortfall amortization installments for such plan year with respect to any shortfall amortization base which has not been fully amortized. The shortfall amortization installments are the amounts necessary to amortize the shortfall amortization base of the plan for any plan year in level annual installments over the 15-year period beginning with such plan year.

Actuarial Cost Method: The unit credit cost method is used for ERISA Funding Target (FT) purposes. Under this method, accrued pension benefits are determined for all eligible active participants. These benefits reflect service, salary and negotiated benefit increases to date. The liability is then equal to the present value of all benefits for inactive participants plus the PVAB for active participants.

The normal cost is determined on an individual basis for all active participants who have not attained the assumed retirement age and is equal to the present value of the difference between the current accrued benefit and the anticipated accrued benefit one year later, with the accrued benefit based upon earnings, or negotiated benefit increases, to date in both cases. The total normal cost is based upon the sum of the individual normal costs. The target normal cost for funding is equal to the total normal cost plus assumed administrative expenses expected to be paid from the trust.

The projected unit credit method is used for IRS maximum deductible limit cushion amount. Under this method, accrued pension benefits are determined for all eligible active participants reflecting service to date and anticipated salary and negotiated benefit increases to the assumed retirement age. This liability for active participants is then added to the present value of all benefits for inactive participants to determine the total liability under this method.

The normal cost is determined on an individual basis for all active participants who have not attained the assumed retirement age and is equal to the present value of the difference between the current accrued benefit and the anticipated accrued benefit one year later, with the accrued benefit based upon earnings and negotiated benefit increases projected to assumed retirement age in both cases. The total normal cost is based upon the sum of the individual normal costs.

Eligibility: All employees not excluded by class are eligible to enter on the January 1 or July 1 coincident or next following the attainment of age 21 and one year of service.

All employees in the company are eligible to participate, with the exception of union employees, non-resident aliens, leased employees, and Highly Compensated Employees, or attorneys who are not designated as Senior Managing Directors, Managing Directors, Directors, or Senior Attorneys.

Definitions:

Vesting Service: Credited based on the number of plan years with at least 1,000 hours of service. Participants are 100% vested after three years of service.

Cash Balance Account: An account that is the sum of a participant's Interest Credits and Employer Credits. At any point following termination of employment (or death), a plan participant (or designated beneficiary) is entitled to the vested portion of his or her Cash Balance Account.

Interest Credit: A 3% annual credit to a participant's Cash Balance Account.

Forms of Payment:

Normal form of benefit: Single life annuity. The single life annuity shall be actuarially equivalent to the Cash Balance Account as of the elected benefit commencement date.

Optional forms: Participants who retire under the plan may elect a life annuity, 50%, 75%, or 100% joint and survivor annuity, or a lump sum distribution.

Maximum on Benefits and Pay:

All benefits and pay for any calendar year may not exceed the maximum limitations for that year as defined in the Internal Revenue Code. The plan provides for increasing the dollar limits automatically as such changes become effective.

Plan participants must have worked at least 1,000 hours during the plan year to receive an Employer Credit for that year.

Future Plan Changes: No future plan changes were recognized in determining minimum and maximum contributions.
