### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of PleasureLand, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and October 31, 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and for the two-month period ended December 31, 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and October 31, 2023, and for the year ended December 31, 2024 and two-month period ended December 31, 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the PleasureLand, Inc. Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was effective November 1, 1988, and has been amended and restated throughout the years to comply with tax legislation. The Plan was last amended and restated effective November 1, 2023. The Plan is sponsored by PleasureLand, Inc. (Employer). Employees who have completed three months of service and attained age 18 are eligible to participate in the 401(k) portion of the Plan. Employees must complete one year of service and attain age 21 to be eligible to receive Employer contributions. The Plan excludes seasonal employees who have not completed one year of service, union employees, nonresident aliens with no U.S. source income and leased employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees are responsible for the oversight of the Plan. The Plan trustees, along with the external investment advisor, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Effective November 1, 2023, the Plan was amended to change the Plan year-end from October 31 to December 31.

**Contributions**

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are thereby permitted to elect to have a portion, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. The Plan also allows participants age 50 and older to make catch up contributions. The Plan has an automatic deferral contribution whereby participants were automatically enrolled with a 4% deferral rate unless otherwise elected. Effective November 1, 2023, the plan adopted an automatic increase provision in which participants who automatically enrolled will increase 1% at the beginning of each plan year until reaching the maximum 10% threshold.

The Employer may, at its discretion, elect to make a profit sharing contribution allocated to all eligible participants. No Profit sharing contributions were authorized for the year ended December 31, 2024 or the two-month period ended December 31, 2023.

The Employer may, at its discretion, also elect to make matching contributions allocated to those who elect salary reduction contributions. Matching contributions authorized for the year ended December 31, 2024 and the two-month period ended December 31, 2023 were 50% of employee deferrals up to \$1,250.

In order to share in Employer matching contributions, a participant must have completed 1,000 hours of service and have been employed on the last day of the Plan year unless termination was due to death, disability, or retirement age (60). There were no allocation conditions to receive the Employer profit sharing contribution.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs. Participants direct the investment options of their contributions into the various options offered by the Plan. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's deferral contributions and the Employer's matching and profit sharing contributions, an allocation of Plan earnings or losses, and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. Profit sharing contributions are allocated based on compensation using a cross tested formula. Income is allocated daily based on each participant's share of the fund.

**Vesting**

Participants are immediately 100% vested in their deferral contributions and Employer matching contributions, plus actual earnings thereon. Employer discretionary profit sharing contributions, plus actual earnings thereon, vest at a rate of 20% per year starting with the second year of credited service. A participant is 100% vested after completing six years of credited service. Notwithstanding the above, a participant's account will be fully vested upon reaching normal retirement age, death, or permanent disability.

**Forfeitures**

Forfeitures of nonvested accounts are used to pay Plan expenses or to reduce Employer contributions. There were \$25,764 and \$0 forfeitures used to reduce Employer contributions and \$6,967 and \$482 pay plan expenses for the year ended December 31, 2024 and the two-month period ended December 31, 2023, respectively. Unallocated forfeitures totaled \$1,031, \$14,556, and \$13,955 as of December 31, 2024 and 2023 and October 31, 2023.

**Benefit Payments**

Upon termination of service, a participant may elect to receive their vested account balance in the form of a lump sum or partial distributions. If a participant terminates employment and the participant's account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan requires all mandatory distributions greater than \$1,000 to be rolled over into an individual retirement account if no other election is made by the participant. Effective January 1, 2024, the limit increased to \$7,000. The Plan also allows for hardship withdrawals subject to Plan provisions. Effective November 1, 2023, the plan allows for in-service withdrawals at 59 ½.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years or longer for the purchase of a primary residence. The notes are secured by the balance in the participant's account balance and bear interest at the prime plus 1%. Principal and interest is paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value (except for fully benefit responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies utilizing information provided by the investment advisor and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and investment advisory fees are asset-based and allocated to participant accounts as administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Effective November 1, 2023, American United Life Company, the insurance company and custodian, has supplied the Plan administrator with certifications as to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the year ended December 31, 2024 and the two-month period ended December 31, 2023, and the schedule of assets (held at end of year) as of December 31, 2024 and 2023.

From November 1, 2023 to November 29, 2023 (date of transfer), John Hancock Life Insurance Company (John Hancock), the insurance company and custodian, has supplied the Plan administrator with a certification as to the completeness and accuracy all investment information reflected on the accompanying statement changes in net assets available for benefits for the time period.

Prior to November 1, 2023, John Hancock Life Insurance Company (John Hancock), the insurance company and custodian, has supplied the Plan administrator with a certification as to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statement of net assets available for benefits as of October 31, 2023.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023 and October 31, 2023.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with American United Insurance Company (the Insurance Company). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer accounts.

**NOTE 8 PLAN TAX STATUS**

The Plan adopted a pre-approved plan that has received an opinion letter from the Internal Revenue Service (IRS) indicating that the pre-approved plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under present income tax law. The pre-approved Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Through November 29, 2023 (date of transfer), the investments are managed by John Hancock Life Insurance Company, the insurance company. Therefore, the related transaction qualifies as party-in-interest as defined by ERISA.

Effective November 1, 2023, the investments are managed by American United Life Insurance Company, the insurance company. Therefore, the related transaction qualifies as party-in-interest as defined by ERISA.

These are deemed prohibited transactions in accordance with ERISA and the IRC. The Company is correcting the prohibited transaction by remitting lost earnings to the Plan.
