In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Fashion Glass & Mirror, Inc. 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of ABC Company Employee Benefit Plan's internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



# Fashion Glass & Mirror, Inc. 401(k) Retirement Savings Plan

## NOTES TO THE FINANCIAL STATEMENTS

### Note A - Description of the Plan

The following description of the Fashion Glass & Mirror, Inc. 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan was established effective February 15, 1992, as a defined contribution plan for the benefit of eligible employees of Fashion Glass & Mirror, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Income Security Act of 1974 ("ERISA").

### Administration

Empower has been appointed the Custodian (the "Custodian") of the Plan. Resource Benefits Administrators has been appointed Third Party Administrator ("TPA") of the Plan.

### Eligibility

Employees of the Company, who have completed 90 days of service, are generally eligible to participate in the Plan. The entry date of the Plan for eligible participants is on the first day of the calendar month following the date that a participant first satisfies eligibility requirements.

There are no exclusions from participation.

### Contributions

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation (\$23,000 and \$22,500 in 2024 and 2023 respectively) set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Participants may make after-tax Roth contributions. Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax catch-up contributions that exceed the annual elective deferral limit. Participants' total catch-up contributions during 2024 and 2023 cannot exceed \$7,500 and \$7,500, respectively.

Employees will be subject to the automatic enrollment provisions and include Participants without an existing affirmative election or whose affirmative election is less than the automatic enrollment amount of 3%.

### **Note A - Description of the Plan, continued**

Permissible withdrawals will be allowed provided they are requested within 90 days after the first automatic deferral (no fewer than 30 or more than 90 days).

The Company may contribute a discretionary matching contribution. During 2024 and 2023, the Company made \$117,522 and \$120,526 in matching contributions, respectively.

The Plan also provides for discretionary Company profit sharing contributions. During 2024 and 2023, the Company made no discretionary employer profit sharing contributions.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

### **Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Company's contributions into various investments offered by the Plan.

### **Vesting**

Participants are vested immediately in their elective contributions and rollover contributions plus any earnings on such contributions. The vesting of discretionary Company contributions plus any earnings thereon is based on years of continuous service (as defined) accrued by the participant while in covered employment. Participants become 100% vested on a six-year graded vesting schedule.

### **Participant Loans**

Participants may borrow from their accounts on a pro-rata basis from all contribution sources up to a maximum equal to the lesser of \$50,000.00 or 50% of the participant's vested account balance. Loan terms must not exceed five (5) years unless the loan is to be used in the financing of the participant's homestead in which case the loan may be payable in terms of similar length provided by conventional lending institutions. The loans are secured by the vested balance in the participant's account and bear an interest rate of 3.25% to 8.50%. Principal and interest payments are made by means of payroll withholdings according to the terms of the promissory note. A participant may have only one loan outstanding at any time. Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

## **Note A - Description of the Plan, continued**

### **Payment of Benefits**

Upon termination of employment due to death, disability, attainment of age 59 ½ or retirement a participant (or his/her designated beneficiary in the event of death) may elect to receive a lump-sum amount. For termination of employment due to other reasons, the vested interest in his or her account may be distributed as rollover to another plan, a lump-sum distribution or it may be left in the Plan if the account balance is greater than \$1,000.

### **Forfeited Accounts**

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to offset future employer contributions. As of December 31, 2024, there were \$25,499 forfeitures that have not yet been applied. These forfeitures should be used by the end of the following plan year.

### **Administrative Expenses**

In 2024 the plan was primarily responsible for payment of fees. Such expenses paid by the participants during year ended December 31, 2024, were approximately \$22,940.

## **Note B - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

### **Risk and Uncertainties**

The Plan provides for various investment options. These investment options are exposed to market risk, which generally means the risk of loss in value to certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

## **Note B - Summary of Significant Accounting Policies, continued**

### **Investment Valuation and Income Recognition**

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Investments in fully-benefit responsive investment contracts are reported at contract value as discussed in Note C.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2024, the date on which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

### **Contributions**

Contributions from Plan participants and the matching contribution, if any, from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from amounts paid. Profit sharing contributions, if any, are recognized upon authorization and in the year the underlying compensation is recognized. All participant and employer contributions are participant-directed.

### **Benefit Payments**

Benefits are recorded when paid.

### **Note C – Insurance Investment Contract**

In 2005, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with MassMutual Retirement Services ("MMRS") totaling \$1,565,696 on December 31, 2024. MMRS general investment account investment option for defined contribution plans is a guaranteed interest account provided through a group annuity contract. Under the terms of the group annuity contract, a crediting rate is established for amounts invested in the guaranteed interest account and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as "book value." MMRS considers this investment option to be fully-benefit responsive notwithstanding the liquidation value events under the contract that limit the ability to the plan to transact at contract value.

The contract value, as reported to the Plan by MMRS, represents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **Note C – Insurance Investment Contract, continued**

All bona-fide participant-initiated withdrawals from the GIA, including benefit payments at termination or retirement, loans, and transfers to other non-competing investment options, are paid at book value. Similar to other stable value alternatives, transfers to competing fixed income investments are not allowed. Employer-initiated events such as layoffs, a sale of a business unit, a company merger, or a change in the stable value option offered under a plan are considered market value events and are subject to the plan sponsor liquidity.

Upon full or partial contract or plan termination and certain other sponsor-initiated events, distributions from the GIA may be subject to a liquidation value (market value) adjustment pursuant to a formula specified in the contract. The market value formula may produce a value that is more or less than the book value of the plan's investment in the GIA.

### **Note D - Fair Value Measurements**

Accounting Standards Codification 820 "Fair Value Measurements and Disclosures" (ASC 820) establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan has adopted ASU No. 2015-07 which removed the requirement to categorize and disclose investments for which fair value is measured using the NAV per share as the practical expedient within the fair value hierarchy. As of December 31, 2024 and 2023, the plan's investments that are measured using NAV as a practical expedient leveling, in accordance with ASC 820, does not apply.

The following is a description of the valuation methodologies used for investments measured at fair value.

*Pooled separate accounts:* Valued at net asset value as a practical expedient. The net asset value is based on the fair value of the underlying assets owned by the fund. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The underlying securities in the pooled separate accounts are listed on the national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted net asset value under agreements with the insurance company.

It is possible that the redemptions rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the net asset value of the pooled separate accounts and the fair value of the Plan's investments.

The preceding methods described may produce a value that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or

assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Empower also certified to the completeness and accuracy (including gains and losses on investments bought and sold, as well as held during the year) of \$343,377 of net appreciation in the fair value of investments, \$40,418 in other income and \$40,792 of interest, \$8,469 in loan interest for the year ended December 31, 2024.

**Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note G – Tax Status**

The IRS has determined and informed the Company by an opinion letter dated September 30, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H – Party-in-Interest Transactions**

The plan invests in participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments are funds managed by the Trustee and the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

**Note I – Benefit Claims Payable**

On December 31, 2024 and 2023, there were no benefit claims payable for distributions requests made prior to year-end.

**Note J– Recent Accounting Pronouncements**

Recent accounting pronouncements issued by the FASB did not or are not believed by management to have a material impact on the Plan’s present or future financial statements.
