INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Fleet Driver Service, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Fleet Driver Service, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Fleet Driver Service, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Fleet Driver Service, Inc. (the Company) 401(k) Plan (the Plan), as amended provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer defined contribution plan covering all employees of the adopting employers. During the 2024 year, the adopting employers were Barnes Transportation Services, Inc. and a controlled group of employers that consists of Fleet Driver Service, Inc., Fleet Personnel Corp., Fleet Driver HQ, Inc. and Fleet Partners, Inc. Barnes Transportation Services, Inc. was sold in June 2024, and as a result, ceased participation in the Plan. The remaining employer continues to sponsor the Plan as of December 31, 2024. Participants of the employer that was sold either received distributions or had their account balances transferred in accordance with the Plan's provisions. There are no age or minimum service requirements. The Plan is subject to the provisions of ERISA. Fleet Driver Service, Inc. is the Plan's sponsor and the Plan's administrator. Transamerica Financial Life Insurance Company, Inc. manages the investments in the Plan as directed by the participants. In addition, Transamerica provides recordkeeping services for the Plan.

Eligibility

Employees are eligible if employed by any of the adopting employers.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan up to the maximum amount allowable under the provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at minimum of \$25 per week and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes 10% of the employee contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the greater of a maximum of 50 percent of their vested account balances or \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made. Loans are assets of participants' accounts and are secured by the balance in the participants' accounts. Interest rates must be comparable to current interest rates charged by financial institutions for similar loans. The interest that will apply to the loans will be the Prime Rate on the date of the loans plus 1% per year. Loans must be paid in equal payments over a period not extending beyond five years from the date of the loan.

Payment of Benefits

On termination of service due to an event other than death such as disability or retirement, a participant, unless otherwise elected, will receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. Payments on death are made pursuant to the election of the Participant or designated beneficiary.

Forfeitures

Terminated employees whose account balances are not fully vested, forfeit their non-vested portion. The funds in these accounts can be used to reduce future employer matching contributions or to offset administrative expenses. Forfeited non-vested accounts used to offset employer profit-sharing contributions were \$5,512 and \$2,335 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,355 and \$2,589, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been presented on the accrual basis of accounting which conforms to accounting principles generally accepted in the United States of America (U.S. GAAP). All contributions and loan activity are reflected in participants' equity on an accrual basis.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan follows Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* as well as subsequent guidance in Accounting Standards Update (ASU) 2015-07 *Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or its Equivalent)*, and ASU 2015-12 *Plan Accounting: Defined Contribution: Part(I) Fully Benefit-Responsive Investment Contracts, part (II) Plan Investment Disclosures, Part (III) Measurement Date Expedient*.

ASC 820 requires that investments held by the Plan be stated at fair value which is defined as the price that the Plan would receive upon selling an investment in an orderly transaction to an independent buyer in the principal or most advantageous market of the investment.

For certain investments measured using net asset value (NAV) as the practical expedient for fair value, ASC 2015-07 exempts the inclusion of these investments from the categorization within the fair value hierarchy established by ASC 820. The Plan's common collective trust investment uses NAV as a practical expedient of fair value.

The Plan presents the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid. Benefit payments totaled \$471,736 for the year ended December 31, 2024. There were no benefits owed before year-end that were not paid at December 31, 2024.

Administrative Expenses

All expenses are comprised of transactional and other investment fees paid by the Plan and are reported as administrative expenses on the statement of changes in net assets available for benefits. Other administrative expenses of the Plan, including legal and accounting expenses have been paid by the Company.

Subsequent Events

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, American Trust, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate for the years ended December 31, 2024 and 2023:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown on the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and supplemental schedule of assets (held at end of year) as of December 31, 2024;

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 – FAIR VALUE MEASUREMENTS

ASC 820 established a three-tier hierarchy to maximize the use of observable market data and minimize the use of unobservable inputs, and to establish classification of fair value measurements for disclosure purposes. Inputs refer broadly to the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity’s own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available.

The three-tier hierarchy of inputs is summarized in the three broad levels listed below.

- Level 1 – quoted prices in active markets for identical investments
- Level 2 – other significant observable inputs (including quoted prices for similar investments, interest rates, prepayment speeds, credit risk, etc.)
- Level 3 – significant unobservable inputs (including the Plan’s own assumptions in determining the fair value of investments)

The level in the fair value hierarchy within the fair value measurement is based on the lowest level of input that is significant in the fair value measurement.

Group Annuity Contract

In 2022, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica. The Transamerica Stable Value Option is an investment choice backed by the general account of Transamerica. Interest is credited on a daily basis. Contract asset charges and services fees deducted from the account reduce participants return reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions.

The contract values at December 31, 2024 and 2023 were \$6,517 and 4,707, respectively and represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 – ROLLOVER CONTRIBUTIONS

An aggregate of \$2,496 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, Plan investments were managed by Transamerica, the trustee. Therefore, transactions occurring during the years ended December 31, 2024 and 2023 with Transamerica qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee received compensation from the Plan for these services.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, each participant's account becomes fully vested and the assets will be distributed to the participants.

NOTE 8 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 1, 2021 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

The Plan follows the accounting requirements associated with uncertainty in income taxes using the provisions of FASB ASC 740, *Income Taxes*. The Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. Previous open tax years may be subject to examination by taxing authorities.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan provides various investment options that in general are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of these risks associates with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 10 – SUBSEQUENT EVENTS

The Plan Administrator evaluated its December 31, 2024 financial statements for subsequent events through the date the financial statements were issued.

NOTE 11 – FIDELITY BOND

The Plan Sponsor is required by the Employee Retirement Income Security Act of 1974 (ERISA) to maintain a fidelity bond to protect the assets of the plan from losses resulting from acts of fraud or dishonesty. During the years ended December 31, 2024 and 2023, the Plan Sponsor did not have a fidelity bond in place as required by ERISA Section 412.

As of December 31, 2024 and 2023, the lack of a fidelity bond exposed the Plan and its participants to increased risks associated with the potential misappropriation of assets. Subsequent to the year ended December 31, 2024, the Plan Sponsor has taken corrective action to obtain the required fidelity bond.

NOTE 12 – EXCESS CONTRIBUTION LIABILITY

At December 31, 2024, the Plan recorded a liability related to the correction of the Actual Deferral Percentage (ADP) and Actual Contribution Percentage (ACP) nondiscrimination tests. The liability consists of amounts refundable to participants for excess employee deferrals and excess matching contributions, along with the allocable investment earnings thereon. The total liability of \$6,595 includes \$1,463 related to ADP excess deferrals and \$5,132 related to ACP excess matching contributions (including \$706 of related earnings). All amounts are to be refunded to participants subsequent to year-end in accordance with IRS regulations.
