## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
the Chef Works, Inc. 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chef Works, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **Note 1 – Plan Description**

Description of the Plan

The following description of the Chef Works, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally established July 1, 2001 by Chef Works, Inc. (the "Company", "Employer", or "Plan Sponsor"), as defined in the Plan document, under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan's recordkeeper and custodian is Fidelity Management Trust Company (the "Custodian"). The Custodian has the power to administer the Plan and apply all its provisions on behalf of the Plan Sponsor. The Plan Sponsor has the discretion to appoint or remove any trustee or agent of the Plan.

Eligibility

Employees age 18 or older with at least 1 month of credited service are eligible to participate in the Plan. Enrollments into the Plan are done on the first day of each month. Ineligible employees generally include non-resident aliens, leased employees, those whose employment is covered by a collective bargaining agreement, and certain other classes of employees as specified in the Plan document.

Contributions

*Participant contributions* – Participants may elect to contribute up to 100% of their eligible compensation, as defined, through pre-tax salary deferrals, up to limits imposed by the IRC. Upon reaching the age of 50, participants may make additional "catch-up contributions" up to limits imposed by the IRC. Participants may also make rollover contributions from other qualified defined plans and certain individual retirement accounts.

*Employer discretionary matching contributions* – The Company may make matching contributions each payroll period equal to a uniform percentage of participants' elective salary deferrals, as determined by the Company. To be eligible for these contributions, participants must have obtained 1 year of credited service, consisting of 1,000 hours. For the year ended December 31, 2024, the Company matched 100% of each participant's contributions, up to 2% of the participant's deferred election, and up to 2% of eligible compensation.

*Employer discretionary, non-elective contributions* – The Company may also make a discretionary, non-elective contribution to the Plan each year. To be eligible for these contributions, participants must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. If made, such contributions are allocated to eligible participants' accounts based on each participant's compensation in proportion to total compensation for all eligible participants. The Company made no discretionary, non-elective contributions for the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each participant to reflect the participant's contributions, Employer contributions, and allocations of Plan earnings (losses) and administrative expenses. Allocations are done daily based on participant earnings or a weighted average of participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting

Participants are always 100% vested in their elective salary deferrals, catch-up contributions, rollover contributions, and any earnings (losses) thereon. Participants vest in Employer discretionary matching contributions, Employer discretionary, non-elective contributions, and any earnings (losses) thereon, as follows:

Participants become 100% vested in their accounts if they are employed with the Company and reach normal retirement age, become totally disabled, die, or if the Plan terminates.

Forfeitures

Participants who terminate employment forfeit the non-vested portion of their Employer discretionary matching contributions, Employer discretionary, non-elective contributions, and earnings thereon. Forfeitures may be used to pay Plan administrative expenses, reduce Employer contributions, or restore forfeited account balances of rehires. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,068 and \$4,756, respectively. During the year ended December 31, 2024, \$8,757 of forfeitures were used to reduce Employer discretionary matching contributions.

Notes Receivable from Participants

Participants may borrow from their accounts the lesser of a) \$50,000, reduced by the highest outstanding note balance during the prior year, or b) 50% of their vested account balance, subject to a \$1,000 minimum. Notes are secured by the vested balance in the participant's account. Participants may have only two notes outstanding at a time.

Note payments are made through payroll deductions over periods up to 5 years, unless the note is used to acquire a principal residence, in which case the maximum repayment period is 30 years. New notes bear interest at the prime rate plus 1% per annum, fixed at inception of the note.

Notes Receivable from Participants (continued)

As of December 31, 2024 outstanding notes mature through 2029 and bear interest at rates ranging from 4.25% to 9.50% per annum on loans outstanding at December 31, 2024 and 2023.

Benefits Paid to Participants

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive an amount equal to the participant's vested account balance in a lump-sum payment, installment payments over the participant's or beneficiary's assumed life expectancy, roll the amount to an individual retirement account or other eligible transferee plan, or delay payment until the required beginning date of minimum distributions, depending on the value of the account. In addition, the Plan permits in-service distributions for participants who are age 59 ½ or older. Distributions paid prior to the participant attaining age 59 ½ and not rolled into another retirement account are subject to federal income tax of 20% and a federal excise tax of 10%.

Vested account balances less than \$5,000, but more than \$1,000 may be distributed as a lump-sum cash payment or in the form of a direct rollover to an individual retirement account or eligible retirement plan at the consent of the participant or beneficiary. Vested account balances less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

In addition, in the event of hardship as defined by the IRC, participants may request withdrawals from their vested account balance.

Administrative Expenses

All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. The Employer provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan. Expenses, to the extent not paid by the Company, are paid by the Plan and allocated to participants based on their account balances. Expenses that relate solely to a specific participant, such as fees for notes receivable or benefit payments, are assessed to the participant. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

SECURE 2.0 Act of 2022

The Plan has implemented certain requirements of the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The provisions implemented in 2024 include, among others, an increase in the required minimum distribution age from 72 to 73, reduced service requirements for long term, and part-time employees to participate in the Plan, and remove the pre-death required minimum distribution requirement for Roth accounts. Future provisions will be adopted at later dates, as necessary, to comply with the requirements of SECURE 2.0.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”) as set forth by the Financial Accounting Standards Board (“FASB”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Plan has direct investments in a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. See Note 4 for discussion of contract value investments.

Net appreciation (depreciation) in fair value of investments consists of the net change in unrealized gains or losses on investments during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid interest. If a participant does not make note repayments and the Employer considers the note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded.

Payment of Benefits

Benefits are recorded when paid.

**Note 3 – Information Certified by the Custodian**

Plan management has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule (Schedule H, Line 4i) was provided and certified by the Custodian as of December 31, 2024 and 2023 and for the year ended December 31, 2024 as complete and accurate:

- Investments, at fair value and contract value and changes thereon
- Investment income (loss)
- Net appreciation in fair value of investments
- Dividends
- Notes receivable from participants
- Interest earned on notes receivable from participants
- Assets included on the supplemental schedule of assets (held at end of year)

**Note 4 – Fully Benefit-Responsive Investment Contract**

The Lincoln Stable Value Account is a fully benefit-responsive guaranteed fixed annuity contract available as an investment option to Plan participants. The fixed annuity contract is issued by Lincoln National Life Insurance Company ("Lincoln"). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

. Contract value, as reported to the Plan by Lincoln at net asset value of \$1 per share, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value. Contract value approximates fair value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
- (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan,
- (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or
- (5) premature termination of the contract.

The Plan administrator believes no events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan mandates specific rules regarding the movement of funds between accounts. As such, once a participant transfers funds from the Lincoln Stable Value Account, they must keep those funds in a non-competing fund for a minimum of ninety days before they can transfer them to a competing fund. Additionally, if a participant decides to transfer funds from a non-competing fund to a competing fund, they will not be allowed to make any further transfers from the Lincoln Stable Value Account for a consecutive ninety day period.

**Note 5 – Fair Value Measurements**

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements* (“FASB ASC 820”), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted, quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The following describes the three levels of the fair value hierarchy under FASB ASC 820:

- Level 1 – Inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs include:
  - Quoted prices for similar assets or liabilities in active markets,
  - Quoted prices for identical or similar assets or liabilities in inactive markets,
  - Inputs other than quoted prices that are observable for the asset or liability, and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs are unobservable and significant to the fair value.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan’s investments at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

- Mutual Funds – Mutual funds are valued at quoted market prices which are available on active markets and, therefore, are classified as Level 1 within the valuation hierarchy.
- Collective Investment Trusts – The fair values of participation units held in collective investment trusts are based on the net asset value (“NAV”), as a practical expedient, reported by the fund managers as of the financial statement dates and recent transaction prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 – Party-In-Interest Transactions**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain of the Plan’s investments are managed by the Custodian. Therefore, these investments and their related investment transactions qualify as exempt party-in-interest transactions.

Additionally, the Company is a party-in-interest to the Plan. However, there were no transactions with the Company other than the funding of contributions to the Plan.

**Note 7 – Plan Termination**

Although it has expressed no intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions and earnings thereon.

**Note 8 – Income Tax Status**

The Plan adopted a volume submitter defined contribution plan which received a favorable advisory letter dated June 30, 2020 in which the Internal Revenue Service (“IRS”) stated that as of that date, the Plan document was designed in compliance with the applicable IRC requirements. The adopted Plan document has been amended since the issuance of this letter.

However, Plan management and the third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan is qualified, and the related trust is tax exempt.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, credit, foreign currency, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
