INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the L&M Development
Partners LLC 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of L&M Development Partners LLC 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of L&M Development Partners LLC 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of L&M Development Partners LLC 401(k) Retirement Savings Plan and to meet our other ethical

responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about L&M Development Partners LLC 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of L&M Development Partners LLC 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about L&M Development Partners LLC 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO THE FINANCIAL STATEMENTS

NOTE A – PLAN DESCRIPTION

The following brief description of the L&M Development Partners LLC 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information.

L&M Development Partners LLC, formerly known as L&M Development Partners Inc. (the “Company”) established the L&M Equity Participants LTD Profit-Sharing Plan effective as of January 1, 1991. As of April 19, 2010, the Plan was amended and restated in its entirety and was renamed the L&M Development Partners Inc. 401(k) Retirement Savings Plan (the “Plan”). On April 29, 2014 the eligibility requirements of the Plan were amended. On January 1, 2016 the Plan was amended and restated to comply with applicable requirements. Effective January 1, 2021 the Plan was amended, restated and renamed to comply with applicable requirements (the “Amended Plan”).

General, Eligibility and Participant Accounts

The Plan is a defined contribution plan covering all full-time employees of the Company which contains provisions for elective deferrals and non-elective contributions. As amended effective October 1, 2022, any eligible employee who has completed one month of service and has attained the age of 21 is eligible to participate for elective deferrals and the safe harbor contributions component of the Plan while any eligible employee who has completed one year of service and has attained the age of 21 is eligible to participate in the non-elective contribution component of the Plan.

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, if any, and (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions

Employee Elective Salary Deferrals

Each year, participants may elect to defer a portion of their compensation which would have been received in the Plan year by up to a maximum amount which will not cause the Plan to violate (a) its Actual Deferral Percentage (“ADP”) test as determined under Section 4.5 of the Plan or (b) the Maximum Annual Additions to the plan allowable under the Internal Revenue Code. For 2024, employee deferrals were limited to \$23,000 with an additional \$7,500 available

as a ‘catch up’ contribution for employees who were at least 50 years of age as of the end of the year.

Employee Rollover Contributions

At the discretion of the Plan’s administrator, once an employee has become a Plan Participant, they are eligible to deposit distributions received from other plans into the Plan. Such contributions will be accounted for separately in a “rollover account” and these amounts can be withdrawn at any time.

Employer Safe Harbor Contributions

Pursuant to the adoption by the Plan on April 19, 2010 of the Basic Matching Contribution Formula for purposes of *safe harbor contributions*, the employer was required to contribute, on behalf of each eligible Participant, a *safe harbor* amount which consists of a matching contribution equal to the sum of 100% of the Participant’s elective deferrals that are not in excess of 3% of the Participants’ compensation, plus 50% of the amount of elective deferrals made exceeding 3% of compensation but not in excess of 5% of compensation. On May 24, 2020, the Plan was amended and this requirement was removed from the Plan. As of January 1, 2022 and pursuant to the Amended Plan, the Company adopted an Enhanced Safe Harbor Match equal to 100% of the participants’ deferrals for the first 4% of compensation.

Employer Profit Sharing Contributions

Each year the Employer may make a discretionary profit-sharing contribution to the Participant’s account.

NOTE A – PLAN DESCRIPTION (continued)

Account Vesting

Salary deferrals, rollover contributions and safe harbor contributions are always 100% fully vested. Profit sharing contributions vest as follows:

Less than 2 years	0%
2 to 3 years	20%
3 to 4 years	40%
4 to 5 years	60%
5 to 6 years	80%
6 years or more	100%

Distributions from the Plan

Distributions from the Plan may not be made earlier than (a) the Participants death, disability or other severance of employment; (b) the Participant’s attainment of age 59 ½; (c) Plan termination; (d) a proven hardship (e) the Participant is called to reservist or active military duty for certain time periods and (f) a federally declared disaster where resulting legislation authorizes such a distribution.

Payment of Benefits

Benefits are recorded when paid.

If employment terminates for reasons other than death, disability or normal retirement, the Participant will receive the “vested” portion of his account as soon as administratively feasible following termination.

Upon normal retirement (the later of attainment of 65th birthdate or 5th year anniversary of joining the Plan) or disability, the Participant will become 100% vested in all accounts and can receive distributions as soon as administratively feasible. If the Participant remains employed after attaining normal retirement age, he can defer receipt of benefits until employment is actually terminated, provided, however, that this deferral will be made only until such time as the

Participant has reached the age of required minimum distribution in accordance with Treasury Regulations under Code Section 401(a)(9).

Forfeitures

Plan forfeitures are used to reduce the Employer's contributions for the Plan year.

Plan Loans

Participants may request a loan from the Plan. These loans are available to Participants on a reasonably equivalent basis. Such loans must be adequately secured with a promissory note along with a loan pledge. Generally, the vested interest in the Plan must be used as security for the loan and the outstanding balance of the loan for an individual Participant cannot exceed the lesser of \$50,000 or 50% of the vested interest in the Plan. Interest is charged on the loan at the fixed rate of 1% over prime for the duration of the loan and repayment will generally be required in level payments over a period not to exceed 5 years (unless used to purchase a primary residence, in which case the period can be extended beyond 5 years.)

The terms of the Participant Loan Program were amended as of July 10, 2020 to, amongst other provisions, limit the number of loans per participant to 2, set a \$1,000 minimum for loans and to restate application, note requirements and other loan provisions as of that date.

Date of Management's Review

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Company has entered into a Group Annuity Contract with John Hancock Life Insurance Company of New York (“JH”) which provides Pooled Separate Accounts (“PSA”) for participant-directed investments. The Plan considers the contract value of the Group Annuity Contract to be the fair value of such assets as discussed in Note D to the financial statements and as such, The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts without any adjustment to the contract value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment on the terms of the Plan document.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the administrator to made estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the

measurement date. The Investment Committee of the Plan determines the Plan's valuation policies. See note D for the discussion of fair value measurements and assumptions.

Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid for by the Company and are therefore excluded from these financial statements. Investment-related expenses paid by the Plan are expensed as incurred.

NOTE D – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. No plan assets are considered to have Level 2 or Level 3 inputs.

Level 1 Fair Value Measurements

A Level 1 measurement is derived from quoted prices in active markets for identical assets or liabilities that the reporting entity can access at the measurement date. All of the Plan's investments are held in mutual funds or targeted managed portfolio funds provided under the Group Annuity Contracts with John Hancock Life Insurance Company of New York ("JH") and its value is based on JH's quoted net asset values held by the plan as of the end of the Plan year.

JH publishes the unit prices of all of the mutual fund sub accounts daily on its website. JH executes properly transmitted instructions from contract holders and their participants at the posted prices. Even if JH did not, in fact, have any trades in a particular unit class of a particular unit class of a particular sub-account fund on a particular day, the published price would be the price which would have been used for such transaction.

The Administrators of the Plan believe that since the prices are determined and published daily, the portion of the Group Annuity based on sub accounts funds are determined from an "active market" which is present even though participants may not be able to trade the units directly with third parties. Since JH is ready at all times to redeem an investment at their quoted unit value, anyone who wishes to redeem is afforded the quoted price for redemption. Therefore, it is believed that JH is, in and of itself, acting as a market maker for those investing in the Group Annuity Contract. The fair value of the investments as of December 31, 2024 and 2023 have been certified by JH (see Note C.)

NOTE F –PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G –RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are pooled separate accounts with JH. JH is the custodian and record keeper of the plan and as such, pursuant to ERISA rules, is a party in interest. Fees reported as paid by the plan by the custodian amounted to \$179,432 during 2024. In addition, the plan has a number of services providers who are paid by the Company. Such parties are also parties-in-interest under ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE I – TAX STATUS

The Company has not applied for a determination letter from the Internal Revenue Service regarding the taxability of the Plan. However, not unlike many companies who adopt a volume submitter document, the Company has relied upon an Advisory Letter issued by the Internal Revenue Service regarding the acceptability of such documents for purposes of Internal Revenue Code Section (“IRC”) 401. In addition, although the Plan has been amended since the original documents were prepared, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there

are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE J—RISKS AND UNCERTAINTIES

The Plan investments consist of participant-directed investments in mutual funds and strategically managed portfolios available from JH. Due to the level of risk associated with the investment in the funds and to uncertainties inherent in the estimations and assumptions processes, it is at least reasonably possible that changes in the value of these investments will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.
