We have performed audits of the accompanying financial statements of the Stratus Aviation LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of Plan**

The following description of the Stratus Aviation LLC 401(k) Plan (the "Plan") provides only general information. The Plan was originally established April 1, 2008 and was most recently amended and restated effective May 1, 2024 (see Note 10). Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees, except for union employees and nonresident aliens, of Stratus Aviation LLC (the "Company"), who have attained the age of nineteen and have completed two consecutive months of service. Eligible participants may enter the Plan on the first day of each month of the Plan year. Management of the Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Ascensus Trust Company is the trustee of the Plan.

**Contributions**

Each year, participants may contribute a portion of their compensation, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make "catch-up" contributions. Contributions may be designated as Roth 401(k) contributions. The Plan provides for an automatic enrollment of salary deferral contributions of 4% of eligible compensation, increasing by 1% annually on the first day of the Plan year up to a maximum of 10%, unless otherwise elected by the participant. Effective May 1, 2024, the Plan was amended and restated to remove the automatic enrollment and automatic escalation provisions (see Note 10). The Plan Sponsor designates the age-appropriate target fund as the default investment for participants who do not make an affirmative election of an investment fund. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for discretionary employer matching contributions. Participants must be employed on the last day of the Plan year to be eligible for discretionary employer matching contributions, unless in the event of the participant's death, become disabled or reach normal retirement age (65) during the Plan year. For the year ended December 31, 2024, the Plan Sponsor provided discretionary employer matching contributions of 50% of the first 4% of the base compensation that participants contribute to the Plan.

The Plan also provides for discretionary employer profit sharing contributions allocated under a grouping method in accordance with the Plan document. Participants must complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year (unless in the event of the participant's death, becomes disabled or reaches normal retirement age during the Plan year) to be eligible for the discretionary employer profit sharing contributions. For the year ended December 31, 2024, no employer profit sharing contributions were made.

Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, employer matching contributions, if any, as well as allocations of the employer profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

A participant, at all times, has a fully vested (100%) interest in their own contributions and rollover contributions plus actual earnings thereon.

Discretionary employer profit sharing contributions vest after three years of vesting service.

Notwithstanding the above vesting for the discretionary employer matching contributions and discretionary employer profit sharing contributions, a participant will become 100% vested in these accounts upon their attainment of normal retirement age, as defined in the Plan document.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,670 and \$16,957, respectively. These accounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, \$12,973 of forfeitures were used to pay Plan expenses. No forfeitures were used to reduce employer contributions.

**Notes Receivable from Participants**

Loans to participants are permitted under the Plan and are treated as a participant directed investment. The minimum loan is \$1,000. Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence.

**Benefit Payments**

Upon severance of employment, participants may elect to receive, in a lump-sum payment or in partial payments, an amount equal to the value of the participant's vested interest in his or her account. If a distribution is not requested and the balance is between \$1,000 and \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), the account balance will be transferred by the Plan administrator to an individual retirement account established on behalf of the participant. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In-service withdrawals of elective deferrals may be made by participants who have attained the age of 59-1/2. Participants are also permitted to make hardship withdrawals, as defined in the Plan document, in certain cases of immediate and heavy financial need.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the trustee, custodian and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the discretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Discretionary employer profit sharing contributions, if any, are recorded in the year in which the related participant compensation was earned.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Excess Contributions Payable**

The Plan is required to return contributions received during the Plan year in excess of the IRC limits. As of December 31, 2024, the Plan had excess contributions. Such excess contributions are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants during 2025.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan, are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Management fees and operating expenses associated with investments in the mutual funds are deducted from income earned by these funds on a daily basis and are not separately reflected. Consequently, management fees and operating expenses associated with investments are included in the net appreciation in fair value of investments.

**Subsequent Events**

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* Valued at the net asset value or equivalent based on units of the collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the collective investment trust less its liabilities. This practical expedient is not used when it is determined to be probable that the collective investment trust will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future returns. The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its collective investment trust (Reliance Trust Company Collective Investment Trust III for MetLife Group Annuity Contract No. 25053), which is composed primarily of fully benefit-responsive investment contracts. Participants' ownership of the collective investment trust is represented in units. Participant transactions (purchases and sales) may occur daily. The investment objective is interest income and the preservation of capital. This investment option provides guaranteed interest rates, which are adjusted quarterly. MetLife guarantees the principal plus accrued interest, based on credited interest rates, for participant-initiated withdrawals as long as the contract remains active. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio. MetLife resets the crediting interest rate by amortizing the difference between the market value of the portfolio and the guaranteed value over the weighted average duration of the underlying investments. Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other investment options of the Plan, and payments because of retirement, termination of employment, death, disability and in-service withdrawals to the extent allowable by the Plan. It is possible that these redemption rights may be restricted by MetLife in the future in accordance with underlying agreements, including termination of the contract by the Plan sponsor or a full redemption of the collective investment trust.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts including any employer contributions, and all remaining assets in the Plan are to be distributed to the participants by the trustee in accordance with the accrued benefits of such participants as of the date of termination.

**7. Tax Status**

Effective April 1, 2022 and May 1, 2024, through the adoption of an Ascensus, LLC Non-Standardized Pre-Approved Profit Sharing Plan, the Plan was amended and restated (See Note 10). The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, stating that the pre-approved profit sharing plan document as then designed was in accordance with applicable IRC requirements. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Related-Party and Party-in-Interest Transactions**

For the year ended December 31, 2024, the Plan paid fees to Ascensus, LLC ("Ascensus") of \$14,955. Ascensus Trust Company is trustee of the Plan and Ascensus is the recordkeeper of the Plan. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. Therefore, those transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

**9. Operational Defect**

During 2024, Plan management identified an operational defect related to automatic escalation and deferral rate changes during the Plan years ending December 31, 2023 and 2022. Due to administrative errors, participant's deferral rates were not updated in a timely manner in the payroll system. Plan management corrected the matter through the IRS Employee Plans Compliance Resolution System ("EPCRS") and made the affected participants whole, including having the Plan sponsor contribute to the affected participant accounts amounts equal to 25% of the employee's missed deferrals plus 100% of the matching contribution for the missed deferrals plus lost earnings. After performing an analysis and consultation with its advisors and ERISA counsel, Plan management determined that the total correction amount for 2023 and 2022 to be \$6,600 that would be contributed to the

Plan as a Qualified Nonelective. Such amount was recorded in employer contributions receivable on the statement of net assets available for benefits as of December 31, 2023. Plan management completed the correction and funded the affected participant's accounts during 2024.

**10. Plan Amendments**

Effective May 1, 2024, the Plan was amended and restated to remove the automatic enrollment and automatic escalation provisions.
