## Note 1 – Description of the Plan

The following description of the LS Cable & System U.S.A. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering all employees of LS Cable & System U.S.A., Inc. (the “Company”), who have completed 30 days of service, except for employees whose benefits have been collectively bargained, leased employees, and nonresident aliens who do not receive US-source income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Principal Trust Company was the trustee of the Plan, and Principal Life Insurance Company was the record-keeper of the Plan.

**Contributions** – Each year, participants may contribute up to 50% of pretax annual compensation, as defined by the Plan, subject to certain statutory limitations under the Internal Revenue Code (IRC), into any of the investment funds offered by the Plan on a tax-deferred basis. Such contribution was limited to \$23,000 in 2024. Participants aged 50 or older or who will turn 50 during the Plan year, are allowed to make additional pretax catch-up contributions up to a maximum of \$7,500 for 2024. The Plan also provides for automatic enrollment of eligible participants at a 5% deferral rate, unless such new hires affirmatively opt out of such participation within 30 days following the date of hire.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans

The Company contributes a matching contribution equal to 100% of the first 3% of eligible compensation that a participant contributes to the Plan and 50% of the next 2% of eligible compensation that a participant contributes to the Plan.

The Company may also elect to make a discretionary profit-sharing contribution to the Plan. No profit-sharing contributions were made in 2024.

**Participant Accounts** – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contribution, and allocations of (i) Company's profit-sharing contributions and (ii) Plan income, as well as charged with withdrawals and an allocation of the Plan's losses and administrative expenses. Profit-sharing contributions, if any, are allocated to the participants' accounts, based on each participant's relative compensation, as defined by the Plan. Plan income (loss) is allocated daily to the participants' accounts in proportion to their respective account balances, within investment options.

**Vesting** – Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are vested immediately in the Company’s matching contributions, plus actual earnings thereon.

**Payment of Benefits** – Upon termination of service due to death, disability, or retirement, a participant may elect to receive installment payments over a period not to exceed 10 years or a lump-sum amount equal to the vested value of his/her account. In-service withdrawals are permitted upon attainment of age 59 1/2 or in case of financial hardship.

**Loans to Participants** – Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested balances, whichever is less, with a minimum loan amount of \$1,000. Loans are repayable through payroll deductions over periods ranging up to 60 months, except for a primary residence loan, for which the term may be extended to 15 years. Loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator.

### Note 2 – Summary of Significant Accounting Policies

**Basis of Accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Shares of mutual funds are valued at daily closing prices, as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset values and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year.

### **Note 2 – Summary of Significant Accounting Policies (Continued)**

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and fund-operating expenses are reflected as reductions of investment returns for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as distributions based on the terms of the Plan document. As of December 31, 2024, no allowance for credit losses was recorded.

**Risks and Uncertainties** – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Plan Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Payment of Benefits** – The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

**Termination of the Plan** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## Note 3 – Investments

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments.

- Investments at fair value
- Net appreciation in fair value of investments
- Dividend and other income
- Interest income
- Schedule of assets held at end of year

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## Note 4 – Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value as it related to financial assets and liabilities and to nonfinancial assets and liabilities measured at fair value on a recurring basis. Such framework provides fair value three-level valuation hierarchy based on upon observable and unobservable inputs with preference given to observable inputs.

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets.

Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices in markets that are not active, quoted prices for similar assets, or other inputs that are observable, either directly or indirectly, for substantially the full term of the asset.

Level 3 – Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The Plan used the following methods and assumptions in estimating its fair value disclosure for financial instruments:

Mutual Funds – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts – The fair values of participation units held in group annuity contract sub-accounts of Principal Pooled Separate Accounts were based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices (Level 2 inputs). Each of Principal Separate Accounts is comprised of numerous sub-accounts which invests solely in shares of a mutual fund which are segregated from other assets of the insurance company in the name of the pooled separate account. The name of the underlying mutual fund is identified in the name of the pooled separate account when the underlying mutual fund is managed by an entity other than an affiliate of the insurance company. The sub-accounts that invest in mutual funds sponsored by an affiliate of the insurance company generally reference the investment strategy of the underlying mutual fund in their names. Participants direct their investments to certain of the underlying sub-accounts of Principal Separate Accounts available to them under the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in fair value of the investments.

The Plan's policy is to recognize transfers between Level 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer.

### Note 5 – Party-In-Interest Transactions

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain Plan investments are managed by Principal Trust Company, the custodian of the Plan. Purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants held by the Plan are considered party-in-interest transactions.

### Note 6 – Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated August 8, 2014, that the Plan, subject to amendment, and related trust were designed in accordance with the applicable regulations of the IRC. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and that the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 6 – Income Tax Status (Continued)**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by US taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there is currently no audit for any tax period in progress.

### **Note 7 – Subsequent Events**

The Plan evaluated events or transactions that may have occurred after the Statement of Net Assets Available for Benefits date for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.
