#### (1) Description of Plan

The following description of the CMH, Inc. 403(b) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### (a) General

The Plan is a defined contribution plan covering all employees of Community Memorial Hospital, Inc. (Hospital or Plan Sponsor). Employees become eligible to make elective deferrals to the Plan after completing one year of service and attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### (b) Contributions

Participants may make elective deferrals of a minimum of 1% of eligible compensation up to the annual Internal Revenue Service (IRS) contribution limit of pretax annual compensation, as defined by the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into investment options offered by the Plan, which include a money market and various mutual funds.

The Hospital may elect to make discretionary matching contributions on an annual basis. To be eligible for any discretionary matching contributions, a participant must be employed during the Plan year and be 18 years of age. During 2024 and 2023, the Hospital made discretionary matching contributions equaling 1% of compensation for all eligible participants, and 50% of any additional employee contributions up to 4% of compensation, for a maximum total of 3% employer match. Employer discretionary matching contributions amounted to \$273,200 and \$213,151 for the years ended December 31, 2024 and 2023, respectively.

The Hospital may also elect to make discretionary non-elective contributions on an annual basis, based on a participant group allocation formula. All active participants are eligible for discretionary non-elective contributions. The Hospital will allocate discretionary contribution amounts based on years of service and projected retirement age to eligible participants. The Hospital made discretionary non-elective contributions totaling \$252,474 and \$199,506 for the years ended December 31, 2024 and 2023, respectively.

(1) Description of Plan, Continued

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and Hospital discretionary contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the discretionary employer's contribution portion of participant accounts is based on years of continuous service and is as follows:

(e) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and a corresponding reduction to contributions. The Plan has determined the information used to calculate the excess contributions for 2022 contained incorrect and/or incomplete data. As such the Plan is working with their custodian to update the calculations and make corrective distributions, if necessary, in 2025.

(f) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### (1) Description of Plan, Continued

##### (g) Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeited accounts are used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by approximately \$10,500 and \$900, respectively, from forfeited nonvested accounts.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### (b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### (c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### (d) Payment of Benefits

Benefits are recorded when paid.

#### (2) Summary of Significant Accounting Policies, Continued

##### (e) Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

##### (f) Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### (3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(3) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at the net asset value of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Certified Information

Certain investment information disclosed in the accompanying financial statements and ERISA -required supplementary schedule, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by NBT Bank, the custodian of the Plan.

#### (5) Party-in-Interest Transactions

All Plan investments are managed by NBT Bank. NBT Bank is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid out of Plan assets to the custodian were \$2,295 and \$1,936 for the years ended December 31, 2024 and 2023, respectively.

#### (6) Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in the Hospital contribution portion of their account.

#### (7) Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

#### (8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
