## **INDEPENDENT AUDITORS' REPORT**

To the Participants and the Trustees  
Yachiyo 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Yachiyo 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2023 and 2022 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **Responsibilities of Management for the Financial Statements**

## 1. DESCRIPTION OF PLAN:

The following description of the Yachiyo 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all employees, subject to certain exclusions as defined, of Yachiyo of America, Inc., and affiliated adopting companies (collectively, the Employer) who are at least 18 years of age. An employee may participate in the Plan as of the first day that the employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Fiduciary Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings.

### Contributions

Participants may contribute up to 100% of their annual eligible compensation to the Plan, subject to certain limitations established by law. Participants may also contribute Roth elective deferrals and amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants who reach age 50 may elect to make catch-up contributions.

The Plan provides for discretionary Employer matching contributions. For the years ended December 31, 2023 and 2022, the Employer made matching contributions of 100% of the first 3% of employee salary deferrals. The Employer may also make a discretionary annual contribution to the Plan. No discretionary annual contribution was made during the years ended December 31, 2023 and 2022.

### Participant accounts

Individual account balances are maintained for each participant. Each participant's account is credited with the participant's contributions, related Employer matching contributions, and an allocation of the Employer's discretionary contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan's investments are participant-directed.

### Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

### Payment of benefits

Upon termination of service, death, disability, retirement, or reaching age 59 ½, distributions may be made to the participant or beneficiary in a single lump sum payment, or certain installment payments. Normal retirement is at age 65; however, the Plan also provides for early retirement upon attaining age 55 and five years of service. A participant may also elect to withdraw his or her deferred contributions and vested Employer contributions in the event of financial hardship, subject to Plan provisions.

### Participant notes receivable

Participants may borrow from their Plan accounts under terms ranging from 1-5 years, or a reasonable period of time longer than 5 years for the purchase of a primary residence. The minimum note amount is \$1,000. The maximum note amount is the lesser of \$50,000 or 50% of the vested account balance. Notes are secured by the balance in the participant's Plan account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

### **Basis of accounting**

The financial statements are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment valuation and income recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisor and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Participant notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

### **Payment of benefits**

Benefits are recognized when paid.

### **Administrative expenses**

Certain administrative expenses are paid by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable or transactional fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## **3. CERTIFIED INVESTMENT INFORMATION:**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank and Standard Insurance Company (Standard), qualified institutions, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022 the supplemental schedule of assets (held at end of year) as of December 2023, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.

#### **4. GUARANTEED INVESTMENT CONTRACT WITH THE INSURANCE COMPANY:**

The Plan has a fully benefit-responsive group annuity investment contract issued by Standard. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings at the guaranteed interest rates, less participant withdrawals, transfers and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

By definition, this group annuity investment contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time, however, certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the early termination of the contract prior to Standard's recovery of start-up costs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract may be terminated by the issuer with at least sixty days of advance written notice to the Plan.

#### **5. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2023 and 2022.

- *Interest bearing cash*: Valued at closing price on an active market.
- *Self-directed brokerage accounts*: Valued at observable market quotations for identical assets that are priced on a daily basis. The accounts primarily hold common stock, mutual funds, cash, and unit trusts which are considered actively traded.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023 and 2022.

**6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments are managed by and certain administrative expenses are paid to Charles Schwab Trust Bank and Standard, the custodians of the Plan. Therefore, transactions involving these investments and administrative expenses qualify as party in interest transactions, which are exempt from the prohibited transaction rules.

## **7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **8. TAX STATUS:**

The Employer adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) date June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Employer has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **9. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## **10. PLAN OPERATIONS:**

The Plan Administrator has adopted the distribution relief provisions included in the CARES Act which permitted qualified individuals to request a pre-approved distribution, through participant self-certification of eligibility. The maximum dollar amount that could be requested per participant was \$100,000 up through December 30, 2020.

Additionally, the Plan Administrator has adopted the loan provisions included in the CARES Act which permitted qualified individuals to borrow from their fund accounts in the amount to the lessor of \$100,000 or 100% of the qualified individual's vested account during the period March 27, 2020 through September 21, 2020. Furthermore, qualified individuals were permitted to suspend loan repayments due between March 27, 2020 through December 31, 2020. Repayments on suspended loans were to re-commence on January 1, 2021 and the loan re-amortization period was extended up to twelve months from the original loan repayment end date.

The Employer intends to formally amend the Plan before the end of the applicable remedial amendment period to reflect such provisions.

## **11. NONEXEMPT TRANSACTIONS:**

During 2023 and 2022, certain employee deferrals, including loan repayments, totaling \$93,522 and \$34,849, respectively, were not remitted to the Plan on a timely basis in accordance with Department of Labor guidelines. These transactions constitute nonexempt transactions. The Employer is taking necessary corrective action for all affected participants.

During 2022, certain employee deferrals totaling \$34,849 were not remitted to the Plan on a timely basis in accordance with Department of Labor guidelines. These transactions constitute nonexempt transactions. In 2024, the Employer took the necessary correction action for all affected participants.

**12. OPERATIONAL DEFECT:**

During the year ended December 31, 2022, certain errors occurred regarding remittances to participants accounts which resulted in several participants receiving incorrect allocations of employee deferrals or employer contributions. After reallocating excess contributions between affected participants, it was determined that the Employer should deposit an additional \$52,337 into the Plan to make the affected participants and the Plan whole, which is included in the financial statements as an Employer and Employee contribution receivable as of December 31, 2023 and 2022, respectively. The Plan administrator determined the affected participants and took corrective action in 2024.

**13. SUBSEQUENT EVENT:**

Effective January 1, 2024, the Plan was restated. The restatement implemented a one-month service requirement was added to the existing requirements necessary for employees to become eligible to participate in the Plan. In addition, the restatement changed the entry date for newly eligible employees from immediate upon meeting eligibility requirements to the first day of the month following the month in which the employee becomes eligible to participate. Finally, the restatement added automatic enrollment provisions whereby newly hired eligible individuals will be automatically enrolled into the Plan at 3%.

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
