### 1. Description of the Plan

The following description of the Ophthalmology Specialist of Texas, PLLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan, established January 1, 2005, is a defined contribution plan covering all full-time employees of Ophthalmology Specialist of Texas, PLLC, (the “Company”) who have twelve months of service and are age nineteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### *Contributions*

Participants may elect to make voluntary contributions up to 100% of their pre-tax annual compensation, as defined by the Plan document. Participant contributions are subject to certain annual limitations as prescribed by the Internal Revenue Code (the “Code”), which were \$23,000 for 2024.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the end of the year are eligible to make catch-up contributions in accordance with, and subject to the limitations imposed by the Code (\$7,500 for 2024). Participants direct the investment of their contribution into various investment options offered by the Plan.

The Plan is referred to as a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company makes a safe harbor non-elective contribution equal to 3% of compensation. For 2024, the Company made safe harbor non-elective contributions of \$247,111. The Plan also allows for discretionary profit-sharing contributions. For the year ended December 31, 2024, the Company made \$347,817 in profit sharing contributions.

#### *Participant Accounts*

A separate account is maintained for each participant and is credited with the participant’s voluntary contributions and an allocation of (a) the Company’s contributions, and (b) Plan earnings, net of any administrative expenses applicable to the participant. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting and Forfeitures*

Participants are immediately vested in their contributions and Company safe harbor contributions, plus actual earnings thereon. Vesting in Company Profit sharing contributions plus actual earnings thereon is based on years of service, whereby a participant is 100% vested after five years of credited service. There was \$5,079 in forfeitures during 2024. Forfeitures are generally used to reduce the Company contributions. In 2024, the Company did not apply any forfeitures towards Company contributions.

#### *Participant Loans*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participants account and bear interest at a fixed rate of one percent above the prime interest rate as published in the Wall Street Journal at the time of the loan unless otherwise determined by the trustee. Principal and interest are repaid ratably through payroll deductions over a term of no greater than five years (30 years for purchase of a primary residence).

### 1. Description of the Plan (*Continued*)

#### *Payment of Benefits*

Participants who withdraw from the Plan during the year for reasons of disability, retirement, death, or termination are entitled to their vested account balance. In addition, a participant may withdraw any part of his or her vested account after obtaining age 65. Payment of benefits to participants will be made in a lump-sum distribution.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### *Use of Estimates*

The preparation of these financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported revenues and expenses during the reported period. Actual results could differ from those estimates.

#### *Participant Loans*

Loans to participants are reported at their unpaid principal balances and collateralized by the balance in their individual account.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value as determined by quoted prices in an active market. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Contributions*

Contributions from employee deferral contributions are recorded in the period in which they become obligations to the Plan.

#### *Administrative Expenses*

The Company pays certain recurring administrative expenses of the Plan. Expenses not paid by the Company are paid by the Plan in accordance with the Adoption Agreement and amounted to \$74,514 during 2024. Employees of the Company perform certain administrative functions for the Plan with no compensation from the Plan.

#### *Payment of Benefits*

Benefits are recorded when paid.

### 3. Investments

All investments of the Plan are held in participant directed accounts. Investments are reported at fair value as measured by quoted market prices in an active market as follows at December 31:

The Plan's investments appreciated in value by \$1,368,606 during 2024 as a result of realized and unrealized gains and losses. Loan interest income for 2024 was \$12,397.

### 4. Fair Value Measurements

The Plan follows FASB Accounting Standards Codification Topic 820, Fair Value Measurement (ASC 820). ASC 820 defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into the following three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are derived principally from or corroborated by observable market data, and Level 3 inputs are unobservable and have the lowest priority. The Plan has no investments valued with Level 2 or Level 3 inputs.

### **7. Income Tax Status**

The Plan operates in accordance with July Business Services Volume Submitter Profit Sharing / 401(k) Plan. The Trustee received a favorable advisory letter dated March 31, 2014, in which the Internal Revenue Service stated that the basic plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). In 2017, and again in 2018, the Plan was amended to adopt the proposed regulations pursuant to Revenue Procedure 2015-36. The amendment was intended to qualify as a good faith amendment to document the Plan's compliance with the plan qualification requirements under IRS guidance. The Plan was amended on January 1, 2021, to comply with the requirements for Cycle 3 Pre-Approved Plans, pursuant to Rev. Proc. 2017-41. Although the basic plan document has been amended since receiving the advisory letter, the Plan administrator and the Trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management evaluates the Plan's tax positions and concluded that the Plan has taken no uncertain tax positions that require adjustment to the financial statements to comply with the provision of this guidance. Generally, the Plan is no longer subject to examination by taxing authorities for tax years prior to 2021.

### **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

### **9. Risks and Uncertainties**

The Plan provides for various investment options in any combination of mutual funds. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. At December 31, 2024, participant directed investments include seven mutual funds amounting to \$7,219,179 in aggregate, each of which exceed 5% of net assets, and are considered individually significant to these financial statements. At December 31, 2023, participant directed investments include seven mutual funds amounting to \$5,633,692 in aggregate, each of which exceed 5% of net assets, and are considered individually significant to these financial statements.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through October 07, 2025, which is the date the financial statements were available to be issued. Management is not aware of any material subsequent events.
