We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal controls-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following brief description of The Johns Hopkins University Applied Physics Laboratory Staff Health and Welfare Benefits Plan (the Plan) provides only general information about the Active Plan's provisions. Participants should refer to the Active Plan Agreement for a complete description of the Active Plan's provisions.

(a) General

Effective July 1, 2016, the Plan serves the active employee population and has an undivided interest in the Johns Hopkins University Applied Physics Laboratory Medical and Dental Insurance Trust. The purpose of the Plan is to provide a single plan under which The Johns Hopkins University Applied Physics Laboratory, LLC (APL) may provide and administer various types of ERISA welfare benefits for its eligible employees. Additional fully insured health and welfare benefits are wrapped into the Plan.

The Plan and the Johns Hopkins University Applied Physics Laboratory Retiree Health and Welfare Benefits Plan (the Retiree Plan) are successors of The Johns Hopkins University Applied Physics Laboratory Medical and Dental Insurance Plan.

The Plan provides the following health and welfare benefits for eligible employees and their dependents: medical, dental, vision, life insurance, travel accident insurance, long-term disability insurance, death, Hawaii medical and employee assistance (EAP). Employees are eligible to participate in the EAP and travel accident benefit upon date of hire. All remaining benefits of the Active Plan begin the first day of the month following the employee's date of hire, date of rehire, or entry into a benefit eligible position. The Active Plan automatically enrolls eligible employees for the medical coverage if they do not affirmatively elect not to participate.

The vision, life insurance, travel accident insurance, Hawaii medical, long-term disability and EAP benefits are fully insured. The medical, dental, and death benefits are self-insured by the Plan Administrator, APL.

The Plan has an undivided interest in a Voluntary Employees Beneficiary Association (VEBA) master trust (The Johns Hopkins University Applied Physics Laboratory Medical and Dental Insurance Trust (The VEBA Master Trust)) with PNC Bank, N.A. (the Bank). Premiums for self-insured benefits of the Active Plan are paid from assets of The VEBA Master Trust. Premiums for fully insured benefits are paid to the related insurance company from the general assets of APL with funds received from participants. The Active Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan has changed its fiscal year end from June 30 to December 31.

(b) Plan Administration

The Plan is administered by APL through its duly authorized officers or their delegates.

(c) Medical Benefits

Eligible participants may elect from several options for medical benefits under the Plan. The benefits are administered by Allegiance Benefit Plan Management, Inc. (Allegiance).

Such options include a preferred provider option (PPO) for staff who are not eligible for Medicare and a comprehensive plan for staff who reside outside the PPO service areas. Claims of participants who

elect the PPO plan and use providers designated under the Plan are generally fully covered, with small co-payment requirements for certain services. The PPO plan option has both in-network and out-of-network benefits. When the participant needs medical services, they can decide which to use.

For those in-network covered services that do not require a co-payment (i.e., inpatient hospitalizations, surgical procedures, physician hospital visits, hospice, x-rays, lab work, therapy, and durable medical equipment), the Plan will pay 85% of the network negotiated amount and the participant will pay 15%. Essential Health Benefits, as defined by the Affordable Care Act, are covered at 100% with no co-pay.

The maximum a participant will pay in a year for in network services is \$2,500 for an individual and \$5,000 for a family. The maximum a participant will pay in a year for out of network services is \$3,500 for an individual and \$7,000 for a family. After the out-of-pocket maximum has been met, the Plan will pay 100% of the in-network or out-of-network charges.

The Plan provides eligible staff members residing in Hawaii with medical coverage under the Hawaii Medical Service Association (HMSA) Blue Cross Blue Shield Plan. The HMSA Plan is fully insured by Blue Cross Blue Shield.

(d) Dental Benefits

Participants may elect dental coverage under Delta Dental's Plus Option or Value Option plans. Under the Plus Option and Value Option plans, the Plan pays expenses for routine and some major dental services, subject to specified deductibles and fee schedules for certain services and limits on individuals' benefits in each calendar year. The Plus Option plan also covers orthodontic benefits.

(e) Other Benefits

Eligible participants may elect the following additional benefits under the Plan:

Vision: APL offers a Vision benefit option through MetLife Vision for eligible participants. The Plan covers routine vision exams, eyeglasses and contact lenses.

Life Insurance: Regular staff members are automatically covered by \$50,000 of Basic Life insurance through MetLife paid for by APL. Staff members may elect higher Supplemental Life insurance coverage by paying additional premiums.

Travel Accident: Regular staff members are automatically covered by Business Travel Accident insurance equal to three times base annual salary up to \$700,000 in coverage.

Long-Term Disability (LTD): APL's long-term disability plan is fully insured. The provider is MetLife. LTD coverage begins the first of the month following the date an employee becomes eligible. Eligible employees have two coverage options opting for either 50% or 66.6% coverage of pre-disability income.

Death: APL offers a Death benefit to beneficiaries equal to one month's final salary upon the death of an employee.

Employee Assistance Program (EAP): APL's EAP offers staff and their household members access to Aetna Resources for Living that delivers support for coping with a broad range of issues that create stress or disruption in the lives of employees. EAP is offered at no cost to employees.

(f) Contributions and Funding

APL's contributions to the Active Plan are based upon the coverage elected by the participants. Participants' contributions to the Plan are based on the cost of the coverage options they select in excess of APL's contributions. Participants' contributions are paid in equal installments through payroll withholdings (in the case of active employees) and in periodic installments (in the case of nonactive employees).

APL makes monthly payments for participants electing medical and dental coverage to The VEBA Master Trust managed by the Bank. The payments are based on the estimated annual cost of the benefits and fixed fee amounts per participant and include the contributions of participants and the related contributions of APL.

APL pays the full cost of the premiums and administration for EAP, basic life insurance and business travel accident insurance. APL does not contribute to the cost of supplemental life insurance. The death benefit is paid from the general assets of APL.

(g) Insurance and Administrative Agreements

Benefits relating to the PPO and comprehensive medical plans are administered by Allegiance, pursuant to an administrative services contract. Under terms of the contracts, Allegiance provides claims processing, care management, disease management, pre-notification reviews, information reporting and various other services for which they receive a fee based on the number of participants and the types of coverage selected by the participants. Claims paid by Allegiance are reimbursed by the Active Plan on a weekly basis. The Active Plan pays fees to Voya Financial for stop loss insurance.

Benefits relating to the Plus Option and Value Option dental plans are administered by Delta Dental pursuant to an administrative services contract. Under terms of the contract, Dental Delta provides claims processing, information reporting and various other services for which it receives a fee based on the number of participants and the types of coverage selected by the participants. Claims paid by Dental Delta are reimbursed by the Plan on a weekly basis.

Benefits relating to the prescription coverage are administered by Express Scripts, Inc. (ESI), pursuant to an administrative services contract. Under terms of the contract, ESI provides claims processing, information reporting and various other services for which they receive a fee based on the number of participants. Claims paid by ESI are reimbursed by the Active Plan on a semi-monthly basis. The Plan pays monthly administration fees to ESI.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting. The preparation of financial statements is in accordance with accounting principles generally accepted in the United States of America (GAAP).

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Active Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes

therein, incurred but not reported (IBNR), and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Cash and Cash Equivalents

Cash and cash equivalents included within The VEBA Master Trust include all highly liquid, short-term investments with original maturities at dates of purchase of three months or less.

(d) Trust Funds

Under terms of a trust agreement between the Bank and APL, the Bank manages The VEBA Master Trust established to hold certain assets and pay certain benefits provided by the Active Plan. The Bank has investment discretion with respect to assets of The VEBA Master Trust. APL has established The VEBA Master Trust to fund obligations under the Plan and the Retiree Plan.

(e) Investment Valuation and Income Recognition

The investments of the Plan are held by the Bank (the Trustee) under a trust agreement as of December 31, 2024 and 2023, and are maintained in the VEBA Master Trust. The fair value of the Plan's interest in the VEBA Master Trust is based on the beginning of the year value of the Plan's interest in the VEBA Master Trust, plus actual contributions to the VEBA Master Trust and allocated investment income and administrative expenses, less actual claims payments of the VEBA Master Trust, if any.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies and procedures and reports to the Plan's Board of Trustees. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

(f) Vendor Rebates Receivable

As part of the pharmacy benefit management agreements with Express Scripts, the Active Plan is eligible for rebates based on utilization.

Due to the timing of annual rebate reconciliations and quarterly coverage gap payments, there is a receivable due to the Active Plan from Express Scripts for pharmacy rebates that were funded to the Retiree Plan subsequent to year-end. As of December 31, 2024 and 2023 there was a \$5,041,955 and \$3,241,159 receivable due to the Plan from Express Scripts, respectively.

(g) Contributions

Contributions are recorded in the period that APL makes payroll deductions from the participant's earnings. In 2024, the Lab contributed \$7 million to the VEBA Trust to address a higher-than-expected claims experience and to help mitigate a reduction in the Trust balance and actuarial recommended reserve levels.

As of December 31, 2024 there was a \$617,944 dental contribution receivable due to the Plan from the Lab and as of December 31, 2023 there was no receivable due to the Plan from the Lab

(h) Payment of Benefits

Benefits payments are recorded when paid.

(i) Administrative Expenses

The Active Plan pays administrative expenses that consist primarily of administrative fees paid to third party claims administrators, the trustee, and actuary. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses when incurred.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) Interest in The Johns Hopkins University Applied Physics Laboratory Medical and Dental Insurance Trust (The VEBA Master Trust)

The Plan has an undivided interest in The VEBA Master Trust. As of December 31, 2024 and 2023, the Plan's percentage interest in the net assets of The VEBA Master Trust was approximately 64% and 87%, respectively. Investment income and administrative expenses relating to The VEBA Master Trust are allocated to the individual plans based upon average monthly balances invested by each participating plan.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

Cash and cash equivalents interest bearing: Include money market fund investments with original maturities of three months or less, and are rendered Level 1 due to their frequent pricing.

Exchange traded funds: These funds are valued at the current trading value of shares held by The VEBA Master Trust at year end. Funds are publicly traded in active markets and can be bought or sold at any time during normal trading hours, and are rendered Level 1 due to their frequent pricing.

(6) Tax Status

The VEBA Master Trust was established and amended to hold the assets of the Plan and the Retiree Plan and is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, The VEBA Master Trust's net investment income is exempt from income taxes. The VEBA Master Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated July 27, 1982, and the Active Plan sponsor, APL, believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC. However, to the extent The VEBA Master Trust recognizes any unrelated trade or business income as defined in Section 512 of the IRC, The VEBA Master Trust is required to pay tax at trust income tax rates on any such income. There was no unrelated business income tax due for the year ended December 31, 2024 and six months ended December 31, 2023 for The VEBA Master Trust.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Active Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Active Plan Administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

(7) Risks and Uncertainties

The Plan's assets include a variety of investment funds, some of which are registered investment companies. The investment funds include U.S. equities, international equities, and fixed income securities. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, changes in the values of investment securities could occur in the near term and these changes could materially affect the amounts reported in the statements of net assets available for benefits.

(8) Plan Termination

Although it has not expressed any intent to do so, APL has the right under the Plan to discontinue or amend any or all provisions of the Plan, including insurance contracts maintained to provide benefits under the Plan, subject to provisions of ERISA. Participants in the Plan have no right to Plan benefits after a full or partial Plan termination, and have no right to Plan benefits amended or reduced by Plan amendment, except to the extent that they are entitled to benefits with respect to covered events that occurred before the effective date giving rise to Plan benefits.

(9) Related Party Transactions

APL provides certain accounting and administrative services at no charge to the Plan. Certain other fees such as trustee fees and investment advisor fees are paid to the Bank from the Plan's assets. During the year ended December 31, 2024 and six months ended December 31, 2023, the Plan paid \$29,640 and \$18,260, respectively, for investment advisor fees to the Bank, and these transactions qualify as party in interest transactions which are exempt from the prohibited transaction rules of ERISA.

(10) Subsequent Events

The Plan Administrator has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
