Opinion

We have audited the accompanying financial statements of Ivey Mechanical Company Employee Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1: DESCRIPTION OF THE PLAN

The following description of the Ivey Mechanical Company Employee Benefit Plan (the “Plan”) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

General

The Plan is a defined benefit health and welfare plan established to provide medical and other benefits to substantially all employees of Ivey Mechanical Company, LLC and Trinity Contractors, LLC (collectively referred to as the “Company”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee oversees the Plan.

Blue Cross & Blue Shield acts as the third-party administrator for the Plan and performs certain plan administration including claims processing. Certain administrative functions are performed by employees of the Company without compensation for the services provided.

Eligibility

The Plan covers all employees who have completed a 60-day waiting period and work at least thirty hours a week. Dependent coverage is available at the election of the participant.

Funding Policy

The Company makes contributions to the Plan based on estimates determined by the Plan administrator established at a level to meet funding needs and ensure the solvency of the Plan. The Company pays the majority of the employees’ cost of coverage. Employees may contribute specified amounts, as determined by the administrator, to extend coverage to covered dependents, as defined by the Plan. In-kind contributions include premiums paid by the Company on behalf of the employees for long term disability and life insurance.

All reasonable expenses incurred in the administration and funding of the Plan are to be paid from allocated funds provided; however, the Company may elect to pay any or all of these amounts.

Benefits

The Plan provides payment for covered medical expenses incurred by eligible employees and their covered dependents, as a result of an illness or injury that are in excess of the deductible and any co-payments. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Reconciliation ACT (“COBRA”). Benefits provided through the Plan include medical, life and accidental death and dismemberment insurance coverage, disability and certain flexible spending benefits. Most benefits are processed by a third-party administrator, but the responsibility for the payments to participants and providers is retained by the Plan.

The Plan is partially self-insured with reinsurance to cover the excess over certain specific and aggregate stop loss limitations. Expenses in excess of reinsurance and amounts contributed by participating employees are paid by the Company contributions.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Because of the inherent uncertainties in estimating claims incurred but not reported, it is at least reasonably possible that these estimates will be adjusted as more current information becomes available, and any adjustment could be significant.

Claims Paid and Payable

Unpaid claims represent the estimated liabilities on claims reported to the Plan plus an estimated provision for claims incurred but not reported. Estimated claims incurred but not reported are based on historical data and expected trends in medical expenses using actuarial techniques. These liabilities are determined on an undiscounted basis using evaluations of reported claims. The liability for claims incurred but not reported are based on estimates. Due to the inherent uncertainties involved in the estimates, it is at least reasonably possible that changes to the estimate could occur in the near term, and the effect of that change could be material. Estimated claims incurred but not reported totaled \$113,554 and \$63,667 as of December 31, 2024 and 2023, respectively.

Claims paid are stated net of amounts recovered from rebates and reinsurance arrangements which approximated \$1,322,000 for the year ended December 31, 2024.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrator and reinsurance premiums. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan. Expenses that are paid directly by the Company are excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 13, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: CONCENTRATION OF CREDIT RISK

Financial instruments which subject the Company to concentrations of credit risk consist principally of cash. The Company maintains cash accounts with several financial institutions. At times, cash balances may exceed federally insured limits. However, the Company believes the credit risk is low due to the overall strength of the financial institutions and has incurred no losses to date.

Note 4: REINSURANCE

The Plan has specific and aggregate stop loss insurance (reinsurance) coverage to mitigate its risk from claims incurred. Under terms of the policy, claims are subject to individual deductibles of \$100,000 per covered person and to an aggregating specific deductible for the group of \$150,000. Benefits under specific stop loss provisions are unlimited per covered person. Under aggregate coverage provisions, additional benefits up to \$1,000,000 are provided if total claims exceed the specified minimum attachment point (\$7,057,435 for 2024). Claim liabilities under the attachment point that are not recoverable under specific insurance provisions are retained by the Plan.

Note 5: TAX STATUS

The Plan has elected, pursuant to the Internal Revenue Code (IRC) Section 401(d)(1), to be regulated by ERISA. The Plan has not obtained a tax determination letter from the Internal Revenue Service. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified to be tax-exempt as of the financial statement date.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid certain expenses related to plan operations and investment activity to various service providers (see Note 1). These transactions are party-in-interest transactions under ERISA.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the rights of the Plan participants are limited to expenses incurred before termination.
