Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dick Anderson Construction, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of Dick Anderson Construction, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan is a defined contribution plan covering full-time employees of Dick Anderson Construction, Inc.; Pyramid Cabinet Shop, Inc.; and Chanan Construction (collectively referred to as the Company) who are age 18 or older, excluding union and leased employees and nonresident aliens. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan was originally established as of January 1, 1980, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Contributions Participants may elect to contribute to the Plan, in the form of pre-tax and Roth deferrals, up to the lesser of 100% of their eligible compensation or the maximum amount allowable by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may provide a discretionary profit-sharing contribution to the Plan. Employees are eligible for profit-sharing contributions after completing 12 consecutive months of service consisting of at least 1,000 hours. The Company made discretionary profit-sharing contributions of \$1,674,950 and \$795,635 for the years ended December 31, 2024 and 2023, respectively. The Company also made qualified nonelective contributions of \$-0- and \$85,471 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts Each participant's account is credited with the participant's contributions, Company contributions, and account earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. The Company's allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants are immediately vested in their elective deferrals and rollover contributions, and actual earnings thereon. Discretionary profit-sharing contributions are subject to vesting based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable From Participants Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note receivable repayment terms generally may not exceed five years, unless the loan is used to acquire a principal residence, in which case the maximum loan term is the lesser of 30 years or the number of years between the date of issuance and the participant's normal retirement date. The notes receivable are secured by the balances in the participants' accounts. The notes receivable interest rate, determined monthly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the *Internal Revenue Code* (IRC). On termination of service due to death, a beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her current account, or periodic installments. For termination of service due to disability, termination, or retirement, a participant may receive a value of the vested interest in his or her account as a lump-sum distribution. Terminated participants with balances less than \$7,000 in 2024, and \$5,000 in 2023, will be paid out in a lump-sum payment within a reasonable time after the participant terminates employment. Participants may request distribution of rollover contributions at any time.

At December 31, 2024 and 2023, there were no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid.

Forfeitures Forfeitures attributable to discretionary profit-sharing contributions may be used to reduce Plan expenses or reduce future Company contributions. Forfeited nonvested account balances totaling \$29,692 and \$31,000 were used to reduce Plan expenses for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the remaining forfeited nonvested accounts totaled \$63,942 and \$18,494, respectively.

Plan Termination Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their Company contributions.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee (or custodian). Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuity: Valued at the NAV of shares of an insurance company separate account invested in Capital Group EuroPacific Growth Trust, a collective investment trust. The NAV is based on the quoted market prices of the underlying investment. Participant transactions (issuances and redemptions) may occur daily. If the Plan were to initiate a full redemption of the variable annuity, the investment advisor reserves the right to temporarily delay withdrawal from the variable annuity, in order to ensure that securities liquidations will be carried out in an orderly business manner.

Common Trust: The common trust maintained by Great Gray Trust Company is a pool of investments of which the Plan buys and sells units of participation that generally imitate established mutual funds. The underlying investments consist of a common trust which holds various debt and equity mutual funds and indirect investment contracts. The Plan's valuation estimates are based on the contract and market values of the underlying investments using the practical expedient. Participant transactions (issuances and redemptions) may occur daily.

If the Plan were to initiate a full redemption of the common trust, Great Gray Trust Company reserves the right to temporarily delay withdrawal from the trust, in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 and 2023.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Delinquent participant notes receivable are recorded as distributions in accordance with the terms of the Plan agreement.

Payment of Benefits Benefits are recorded when paid.

Expenses Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments and notes receivable from participants included on the statements of net assets available for benefits, and the investment income (loss) and interest income on notes receivable from participants included on the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, were not subject to auditing procedures and have been certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower). Empower is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Empower. Empower maintains the contributions in a general account. This contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount to be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At December 31, 2024 and 2023, the total contract value was \$1,614,450 and \$667,030, respectively.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. For the years ended December 31, 2024 and 2023, the average yield earned by this fund was 1.41% and 1.23%, respectively. The crediting interest rate to participants was 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: (1) The Plan's failure to qualify under Section 401(a) of the IRC, or the failure of the trust to be tax exempt under Section 501(a) of the IRC; (2) Premature termination of the contracts; (3) Amendments to the Plan document, including complete or partial plan termination or merger with another plan; (4) Changes to the Plan's prohibition on competing investment options; or (5) Bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) Uncured violation of the Plan's investment guidelines; (2) Breach of material obligation under the contract; (3) Material misrepresentation; or (4) Material amendment to the agreements without the consent of the issuer.

6. TRANSFER INTO THE PLAN

On December 31, 2022, the Company acquired Chanen Construction. As a result of the transaction, the Chanen Corporation 401(k) Profit Sharing Plan was merged into the Plan. In June 2024, total assets of \$6,688,666 were transferred to the Plan, including \$6,670,445 in participant account balances, \$10,367 in notes receivable from participants, and \$7,854 in forfeited account balances.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower. Empower is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to an agreement between the Company and Empower. Empower receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Empower for administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by Empower from investment providers exceeds the amount owed under the agreement, Empower remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Company may make a payment to Empower for administrative services not covered by revenue sharing.

8. TAX STATUS

The Plan has adopted a pre-approved nonstandardized profit-sharing plan with CODA established by Randall & Hurley. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax exempt.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. PLAN AMENDMENTS

Effective January 1, 2024, the Plan was amended to include Chanen Construction as a participating employer and allow immediate participation to all eligible employees.

Effective January 1, 2024, the Plan implemented certain provisions of the Securing a Strong Retirement Act of 2022 (SECURE 2.0). In accordance with SECURE 2.0, the threshold for involuntary cash-out distributions to terminated participants was increased from \$5,000 to \$7,000 for distributions processed after December 31, 2023. The Plan will be formally amended to reflect this change no later than December 31, 2026, as permitted by IRS guidance.

Effective March 8, 2024, the Plan was amended to modify the maximum number of loans outstanding to two per participant.

11. SUBSEQUENT EVENTS

Effective January 1, 2025, assets from the Montana Contractors Association Inc. Money Purchase Retirement Plan and Trust were transferred into the Plan. The transfer was completed in accordance with applicable plan provisions and regulations, and participants' account balances were consolidated into the Plan.

Effective January 1, 2025, the Plan was amended to modify the definition of Plan compensation to conform to the Plan's operations. The revised definition clarifies the inclusion and exclusion of various compensation types for contribution purposes, including elective deferrals, fringe benefits, post-severance compensation, and other adjustments.

Effective January 1, 2025, the Plan was amended to change to a safe harbor plan. The Company will make nonelective safe harbor contributions not less than 4% of Plan compensation.

Effective January 1, 2025, the Plan was amended to include that the Company will make a prevailing wage contribution for each participant who performs an hour or more of service under a public contract subject to the Davis-Bacon Act.

Effective May 1, 2025, the Plan was amended to allow for hardship distributions.
