## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of North Florida Medical Centers, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the North Florida Medical Centers, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan, a defined contribution plan, was established effective April 1, 1999 and was amended and restated effective August 1, 2016. The Plan is designed as a deferred compensation plan for participating employees of North Florida Medical Centers, Inc. (the Sponsor). The Sponsor also makes a nonelective contribution each pay period equal to 5% of the base compensation of all participants eligible to share in the allocations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – All regular employees are eligible and may make elective deferrals beginning on their date of hire. All eligible employees who have completed six months of service will participate in the nonelective contributions made by the Sponsor.

**Contributions** – The Plan allows participants to contribute up to 100% of their compensation to the Plan (deferral contributions), not to exceed, in aggregate, the maximum annual contribution limit plus the age 50 catch-up deferral, if applicable, allowed by the Internal Revenue Code. The amount of compensation that may be taken into account for Plan purposes was \$345,000 and \$330,000 for 2024 and 2023, respectively. Deferral contributions are deferred from participants' gross earnings for federal income tax purposes.

Generally, the law imposes a maximum limit on the amount of contributions and allocations (including elective deferrals but excluding age 50 catch-up contributions) that may be made to a participant's account during a Plan year, not to exceed the lesser of a specified dollar limit or 100% of includible compensation. The dollar limit was \$69,000 and \$66,000 in 2024 and 2023, respectively.

**Participants' Accounts** – Elective contributions, nonelective contributions, and allocations are accounted for in individual participant accounts. If a participant is permitted, at the discretion of the Administrator, to rollover distributions that are legally qualified for rollover, those funds are held in a separate account called a rollover account.

**Participant Loans** – Participants may borrow from the Plan an amount limited to the lesser of \$50,000 or 50% of their vested account balance. Loans are for a period not to exceed five years and bear interest at an agreed-upon percentage based on prevailing market rates. The interest rates ranged from 3.25% to 8.50% for each of the years ended December 31, 2024 and 2023.

***Investment Contract with Insurance Company*** – The Plan has entered into a Group Annuity Contract (Contract) with Standard Retirement Services, Inc. (Standard). The Contract is fully benefit responsive and, as such, is reported in the accompanying financial statements at contract value. Contract value, which approximates fair value, represents deposits made under the contract plus interest, less withdrawals and any expenses was \$1,323,326 and \$1,208,385 at December 31, 2024 and 2023, respectively (See Note 5). The average yield earned by the Plan is the yield earned (interest credited) on the Contract. Under the terms of the Contract, the crediting interest rate and the minimum crediting interest rate are set in advance and reset quarterly. The crediting interest rate was 12.28% and 11.20% as of December 31, 2024 and 2023, respectively.

***Distribution of Benefits to Participants*** – Benefits may be paid upon death, disability, termination or retirement to the participants or their beneficiaries. Under certain circumstances, both in-service and hardship withdrawals are allowed from the Plan.

At the option of the participant or beneficiary, distributions under the Plan are made in either one lump-sum payment, an annuity, or are directly rolled over into another eligible retirement plan. The involuntary distribution threshold is \$5,000 for the vested balance of terminated participants.

Upon termination of employment with the Sponsor for reasons other than death, disability, or attainment of normal retirement age (59.5 years), participants are entitled only to a distribution of the vested portion of their account. A participant is 100% vested at all times in his or her deferral contributions and rollover contributions. Participants ordinarily become vested in Sponsor nonelective contributions according to the following schedule:

***Plan Administration*** – The Plan permits the payment of Plan expenses from Plan assets, and expenses paid in that manner are generally allocated among the accounts, either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Certain expenses specifically incurred by, or attributable to, a participant are paid from the participant's account.

***Termination*** – Although they have not expressed any intent to do so, the Sponsor may, at any time, discontinue contributions to the Plan and/or terminate the Plan subject to the provisions of ERISA. Upon permanent discontinuance of contributions or termination of the Plan, all accounts of the participants become fully vested.

**NOTE 1 – DESCRIPTION OF PLAN (continued)**

*Forfeitures* – Forfeitures arise from accounts of participants who have terminated but were not fully vested in the Plan. In accordance with the Plan, forfeitures are utilized to reduce administrative expenses of the Plan. Any remaining forfeitures are then utilized to reduce the Sponsor's contributions for the Plan year in which such forfeitures occur. For the years ended December 31, 2024 and 2023, forfeitures were \$95,178 and \$44,114, respectively. At December 31, 2024 and 2023, there were \$61,497 and \$12,855, respectively, in forfeitures available to pay future administrative expenses of the Plan and reduce Sponsor contributions.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The purpose of the Plan is to accumulate contributions and earnings on Plan assets for the payment of benefits to participants. Significant accounting policies of the Plan are as follows:

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statements of Net Assets Available for Plan Benefits and the Statements of Changes in Net Assets Available for Plan Benefits are prepared on a contract value basis.

*Management Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Notes Receivable from Participants* – Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest, and net of an allowance for credit losses, if any. Interest income is recorded on an accrual basis.

*Payment of Benefits* – Benefits are recorded when paid.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

*Investments* – All assets of the Plan are reported at fair value as of December 31, 2024 and 2023, except the investment contract with an insurance company, which is reported at contract value (see Note 5) and approximates fair value (See Note 4 for discussion of fair value measurements). Fair values are based on quoted market prices at December 31, 2024 and 2023, respectively. These market values include interest and dividends and are net of fees and other expenses. All Plan investments are managed by Standard Retirement Services, Inc.

The Plan invests in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with such investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

*Net Appreciation (Depreciation) in Fair Value of Investments* – Net appreciation (depreciation) in fair value of investments includes both realized gains and losses on dispositions of investments and unrealized gains and losses reflecting adjustments to fair value.

*Reclassification* – Certain prior year amounts have been reclassified to conform to the current year presentation.

**NOTE 3 – INCOME TAX STATUS**

The Plan is adopted under a prototype plan document that has not been approved by the Internal Revenue Service. Management and the Plan administrator believe the Plan is designed and is being operated pursuant to the requirements of a 403(b) Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to IRS examinations for years prior to 2021.

**NOTE 4 – INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The Plan’s investments are held by Charles Schwab Bank. All information on Plan investment assets and related investment income transactions has been prepared and certified as both complete and accurate by Charles Schwab Bank as custodian.

Fair Value Measurement and Disclosures Topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Fair Value Measurement and Disclosures Topic are described as follows:

- Level 1:* Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2:* Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.
- Level 3:* Inputs that are unobservable inputs for the asset or liability. Unobservable inputs are those that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances.

**NOTE 5 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with The Standard Insurance Company (The Standard). The Standard maintains the contributions in a general account. The account is credited with net deposits and interest on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Plan Benefits at contract value, which approximates fair value. Contract value, as reported to the Plan by The Standard, represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals.

Certain events limit the Plan’s ability to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. Furthermore, The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner’s failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants’ contract values are not affected.
