### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Truvant 401(k) Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Note 1 - Description of Plan**

The following description of the Truvant 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is intended to meet the requirements of Section 401(a) of the Internal Revenue Code (IRC) and qualify as a defined contribution plan and was established to provide retirement benefits to eligible employees of Truvant, Inc. (“Company”). Effective January 1, 2020, the Plan was amended to become a Safe Harbor plan in accordance with provisions described in Section 401(k)(12) of the Internal Revenue Code (IRC).

The assets of the Plan are held for the exclusive benefit of the participating employees. An employee is eligible to participate in the elective deferral and employer Safe Harbor matching portion of the Plan after their first year of service with the Company and having attained the age of 21. The year of service requirement is defined as working 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan allows participants to make pre-tax contributions subject to certain Internal Revenue Code limitations (\$23,000 for 2024) in each calendar year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. Employee contributions are fully vested.

The Company makes Safe Harbor matching contributions on behalf of participants. Matching contributions for the years ended December 31, 2024 and 2023 equaled 100 percent of a participant’s elective deferral contributions that were not over three percent of a participant’s eligible compensation, plus 50 percent of a participant’s elective deferral contributions that were over three percent of a participant’s eligible compensation but were not over five percent of eligible compensation. The Company may also make a discretionary profit-sharing contribution to the Plan each year. The Company did not make a profit-sharing contribution for the years ended December 31, 2024 and 2023.

The Plan also accepts rollovers from other tax-qualified plans.

#### **Participant Accounts**

Each participant's account is credited or charged with the participant's contribution and the employer's Safe Harbor contribution based on participant compensation and an allocation of Plan investment income or loss. Participants share pro rata in any investment income or loss of the funds, based upon individual participant account balances in the respective funds as of the end of each day.

#### **Vesting**

Participants are fully vested in their employee elective deferral contributions, employer Safe Harbor contributions and rollover contributions and the earnings thereon at all times. Benefits from employer matching contributions from prior to January 1, 2020 vest at a rate of 20 percent after two years of service and 20 percent per year thereafter so that a participant becomes fully vested after six years of service.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 not to exceed the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Notes are repaid by periodic payroll deductions over terms that range from one to five years. The interest rates on notes receivable from participants ranged from 4.25 to 9.5 percent at December 31, 2024.

#### **Payment of Benefits**

In the event of normal retirement, death, or permanent disability, a participant is entitled to receive the entire amount credited to the participant's account. A participant, or their beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, receive installment payments, or rollover their account balance. If employment is terminated for any other reason, a participant is entitled to the vested portion of the account.

#### **Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

#### **Forfeited Accounts**

The Plan provides that upon a participant's termination for reasons other than retirement, death or disability, the participant's nonvested funds are forfeited. Forfeitures of non-vested participant balances are pooled into a single account. These funds may be used to pay administrative expenses of the Plan or to reduce future contributions due from the Company.

The Company offset 2023 matching contributions funded to the Plan during the year ended December 31, 2024 with \$921 in forfeitures. At December 31, 2024, forfeited non-vested accounts totaled \$2,156.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). The financial statements and supplemental schedules have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

#### Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Administrative Expenses

Administrative expenses of the Plan are paid by the Plan unless otherwise paid by the Company at their discretion. Administrative expenses which are not paid by the Company may be paid from forfeitures or from the remaining net assets of the Plan. Personnel and facilities of the Company used by the Plan for its accounting and other activities are provided at no charge to the Plan.

#### Benefits Paid to Participants

Benefits are recorded when paid.

### Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Bond funds and mutual funds - Valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trust - Valued at quoted redemption values that represent the net asset value (NAV) of units held at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted by Trust Point qualify as party-in-interest transactions.

The Plan paid for expenses related to its investment activity and plan operations. Those transactions qualified as party-in-interest (see Note 2 - administrative expenses).

### Note 6 - Administration of Plan Assets

The Plan assets were held and managed by Trust Point for the years ended December 31, 2024 and 2023. Trust Point invests cash, interest and dividend income as directed by the participants of the Plan.

### **Note 7 - Tax Status**

The Plan adopted the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA which has a favorable advisory letter from the Internal Revenue Service (IRS) dated June 30, 2020. This advisory letter states that the form of the plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### **Note 9 - Subsequent Events**

Management has evaluated subsequent events through August 11, 2025, which is the date the financial statements were available to be issued.
