NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Daughters of Sarah Nursing Home Co. Inc. Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is an Internal Revenue Service (IRS) Code Section 403(b) defined contribution plan that is designed to provide retirement benefits to eligible employees of the Daughters of Sarah Nursing Center Inc. (the Plan Sponsor or Employer). The Plan is administered by the Plan Sponsor and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees are eligible to begin salary deferrals on the date of their employment with the Employer. Employees become eligible to receive Employer discretionary contributions upon attaining the age of 21 and the completion of one year of service in which a minimum of 1,000 hours were worked during that year. With respect to Employer discretionary contributions, an eligible employee shall become a participant effective as of the earlier of the first day of the plan year or the first day of the seventh month of such plan year coinciding with or next following the date such employee met the eligibility requirements provided said employee was still employed as of such date.

Contributions

Participants may contribute a percentage of their annual compensation subject to certain IRS limitations. Contributions are remitted and are invested in accordance with the provisions of the Plan. Employer contributions may be made annually on a discretionary basis. During 2024 and 2023, a discretionary employer contribution was made equal to 3% of the total compensation of all eligible participants. For the years ended December 31, 2024 and 2023, PPHP made a discretionary employer contribution of \$315,000 and \$272,702, respectively, which is included in employer contributions on the statements of changes in net assets available for benefits.

Participant Accounts

Contributions made by the participants and the Employer are reported to the Plan's record keeper and are allocated to the respective participant's account. Each participant's account is credited with the participant's contributions, the employer's contribution, and the periodic allocation of investment earnings and administrative expenses. Investment earning allocations are based on participant account balances.

Participants may, subject to a procedure established by the administrator and applied in a uniform nondiscriminatory manner, direct the investment of their accounts in specific assets, specific funds or other investments permitted under the Plan. If a participant does not elect to direct the investment of their account, then the Plan will invest their account in targeted funds based on the participants' date of birth and projected retirement age.

Investment Options

The accounts of all participants in this Plan are held in a trust. Each participant directs the investment of their plan account among the funding choices available within the Plan. Participants may change their investment options daily.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately fully vested in their voluntary contributions, rollover contributions, and actual investment earnings and losses thereon. Vested percentages of the Plan Sponsor's contributions are based on the following:

Payment of Benefits

Upon termination, retirement, death, or permanent disability, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account or they can elect to leave their account balance in the Plan. The following options are available to those electing a distribution: 1) a lump-sum or partial distribution; 2) deferral of the receipt of distribution until age 70; 3) rollover of a lump-sum distribution into an IRA if done so within 60 days of the distribution; or 4) election of payments in installment amounts over monthly, 5, 10, 15, or 20 year intervals. In addition, benefits paid to participants are recorded when paid.

Hardship Withdrawals

Prior to age 59 ½ a participant may withdraw his or her participant contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her account balance. The maximum loan period is five years, unless for the purchase of the participant's primary residence which the loan period can be up to 15 years. Loans are collateralized using a participant's account balance and bear an interest at a rate of prime plus 1.00%. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes in those assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts of assets available for Plan benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts available to reduce future employer contributions totaled approximately \$7,485 and \$3, respectively. Additionally, 2024 and 2023 employer contributions were reduced by \$7,485 and \$3 using forfeited non-vested amounts, respectively.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are reported at fair value, except for fully benefit-responsive investment contracts which are stated at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

The net appreciation in the fair value of investments consist of realized gains or losses on the sales of investments and the unrealized appreciation of investments. Dividends are recorded on the ex-dividend date and purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Interest income is recognized on the accrual basis.

Fair Value Measurements

US GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's estimate about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation methodologies used during 2024 and 2023.

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4.

Benefits Paid to Participants

Benefit payments are recorded when paid.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from Plan assets to the extent not paid by the Employer. Any expenses paid by the Plan are paid by Plan participants.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds – Value derived from the amount reported by the custodian, based upon quoted market prices.

5. FIXED ANNUITY CONTRACTS

The Plan's investment in fully benefit-responsive fixed annuity contracts is comprised of guaranteed insurance contracts established between the Plan's participants and Principal and Voya. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate.

Principal and Voya maintain Plan contributions in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals.

The fixed annuity contracts guaranteed minimum returns are supported by the entire portfolio, which invests primarily in U.S. debt instruments and investment grade corporate bonds; however, it is also permitted to invest in higher risk securities, including but not limited to, sub-investment grade corporate bonds, common stock and real estate. The assets and earnings from this portfolio are used to pay the guaranteed interest rate associated with the annuity contracts, as well as, future annuity payments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The crediting interest rate of the contract is based on a formula agreed upon with the issuer. Such interest rates are reviewed and reset on a quarterly basis.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution.

7. TAX STATUS

The IRS has determined and informed the Employer by letter dated March 31, 2007 for its Volume Submitter 403(b) Plan that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving that determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

8. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants of the Plan to invest in certain funds managed by Principal and Voya, custodians of the Plan. As such, transactions between the participants investing in these funds and the Plan qualify as party-in-interest transactions.

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan qualify as party-in-interest transactions.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.


