INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Honda of Downtown Chicago 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Honda of Downtown Chicago 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 16, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to December 16, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Honda of Downtown Chicago 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 16, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 16, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Honda of Downtown Chicago 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Merger

As discussed in Note 1A, on December 2, 2024, Plan management approved the merger of the Plan into the Murgado Automotive Group 401(k) Plan (f/k/a Miami Automotive Retail, Inc. 401(k) Plan), effective December 16, 2024 (or as soon as administratively feasible). As a result, all assets were transferred from the Plan into Murgado Automotive Group 401(k) Plan on December 16, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Honda of Downtown Chicago 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Honda of Downtown Chicago 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Honda of Downtown Chicago 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4(a) – Delinquent Participant Contributions is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Honda of Downtown Chicago 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

The Plan is a defined contribution 401(k) plan covering certain employees of MAR CHI-H, LLC ("MAR") who meet certain eligibility requirements, as defined. The Plan also covers eligible employees of MAR JAX MAS, LLC ("Jax"), and MAR CHI-V, LLC ("VW"), entities related to MAR through common ownership (all collectively known as the "Companies"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan became effective on January 1, 2018.

On December 2, 2024, Plan management approved the merger of this Plan into the Murgado Automotive Group 401(k) Plan (the "Surviving Plan" and f/k/a Miami Automotive Retail, Inc. 401(k) Plan), effective December 16, 2024 (or as soon as administratively feasible). As a result, all assets were transferred from the Plan into Murgado Automotive Group 401(k) Plan on December 16, 2024.

B) ELIGIBILITY

Employees are eligible to participate in the Plan, including any applicable matching and profit-sharing contribution, upon reaching the age of 18 and completing three months of service, as defined, prior to the entry date. The Plan entry date was the first day of the quarter after meeting the above requirements. Effective May 15, 2023, the entry date was amended to the first day of the next calendar month after meeting the above requirements.

C) CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax or after-tax (Roth option) annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contribution). Contributions are subject to certain limitations under the Internal Revenue Code (the "Code"). In accordance with the Code, the total maximum allowable contribution to the Plan directly from the participant was \$23,000 for 2024, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

C) CONTRIBUTIONS (CONTINUED)

The Companies may make annual discretionary contributions in amounts determined by each of the entities. During the period ended December 16, 2024, MAR and VW elected to match 10% of the participants' contributions up to a maximum amount of \$1,000 per year, while Jax elected to match 50% of the participants' contributions up to a maximum amount of \$500 per year. The MAR and VW match is funded annually and participants must be employed on December 31, 2024 to receive the match. Employer matching contributions were approximately \$3,000 for the period ended December 16, 2024, all pertaining to Jax. The Honda and VW match totaled approximately \$18,000 and was funded into the Surviving Plan on December 31, 2024.

D) INVESTMENT OPTIONS

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan document. Participants may change their allocations at their discretion.

E) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's deferral contribution, their respective employer's matching contribution, if any, and an allocation of the investment earnings, based upon each participant's election and charged with an allocation of administrative expenses. The benefit to which a participant is entitled upon withdrawal from the Plan, as defined above, is the vested benefit in the participant's account.

F) VESTING

Participants are always 100% vested in their contributions. The Plan includes a 3-year cliff vesting schedule for employer matching contributions and any other special contributions, applicable to all employees hired on or after July, 1, 2019. Participants hired prior to July 1, 2019 are always 100% vested in the employer matching contributions and any other special contributions made to the Plan as specified by the Plan document.

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

G) PAYMENT OF BENEFITS

The Plan provides for distribution of accumulated benefits upon death, disability, termination or retirement of participants. All distributions for reasons other than death are paid in either a lump-sum distribution or installment distribution. Upon death and prior to commencing distributions, the distribution of the participant's entire account will be made by December 31, of the fifth year from the date of death, unless an election is made, as defined.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

G) PAYMENT OF BENEFITS (CONTINUED)

The Plan also allows participants that qualify for financial hardship, as defined, to withdraw funds while still employed. The Plan also allows for in-service withdrawals for participants that have reached age 59.5. There is also a provision to automatically cash-out any terminated participant with a vested account balance less than \$5,000 subject to certain elections, as defined.

H) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months or 50% of the value of their vested account balance immediately before the request to borrow funds. The notes are secured by the vested balance in the participant's account and bear interest at a fixed rate similar to a bank's rate for a comparable personal loan. Participants may only have one loan outstanding at any one time. Loan repayments are made through payroll deductions and are credited to the participant's 401(k) account. The repayment period may not exceed five years.

I) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to offset expenses or reduce future employer contributions. During 2024, approximately \$1,700 in forfeitures were used to pay Plan expenses. There were no remaining forfeitures at December 16, 2024. At December 31, 2023, there was a remaining forfeiture balance of approximately \$800.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

B) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest is recorded in the period earned. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investments are self-directed by individual Plan participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

C) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 16, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

During 2024, approximately \$4,000 notes receivable from participants were recorded as benefit payments.

D) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

E) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

F) PAYMENT OF BENEFITS

Benefits are recorded when paid.

G) PLAN ADMINISTRATION AND FEES

The Plan agreement allows for the Companies to absorb a significant amount of the Plan's administrative expenses and are therefore excluded from these financial statements. During the period ended December 16, 2024, the Plan incurred approximately \$54,000 in administrative expenses.

H) RECENT ACCOUNTING PRONOUNCEMENTS

The Companies evaluate new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

I) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 6, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2023, Level 1 inputs were available and therefore used. As a result of the Plan merger (Note 1A), there were no investments in the Plan as of December 16, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company (“Nationwide”), a qualified institution and custodian, has certified that the following information included in the accompanying financial statements and supplemental schedule of assets held at end of year is complete and accurate as of December 16, 2024 and December 31, 2023 and for the period from January 1, 2024 to December 16, 2024:

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE 5 - TAX STATUS

The plan sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual funds managed by Nationwide Trust Company, the appointed custodian of the Plan's assets as of December 16, 2024 and December 31, 2023. Therefore, these transactions qualify as party-in-interest transactions. Expenses paid by the Plan to Nationwide totaled approximately \$11,000 during the period ended December 16, 2024.

In addition, the Plan had other party-in-interest expense transactions to various providers of approximately \$43,000 during the period ended December 16, 2024.

Some of the fees paid by the Plan are included in net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

In accordance with the Plan merger (Note 1A), the Plan will terminate after the merger is finalized and the participants will become 100% vested in their accounts.

NOTE 8 - FIDELITY BONDING

The Companies maintained a fidelity bond in the amount of \$293,012 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA. The policy has a provision whereby loss coverage is increased to the minimum required by ERISA up to the \$500,000 limit.

NOTE 9 - RELATED PARTY TRANSACTIONS – PROHIBITED TRANSACTION

During 2024 and 2023, the Companies did not remit certain employee's contributions in accordance with guidelines set forth by the United States Department of Labor ("DOL") and Employee Benefits Security Administration ("EBSA"). However, the contributions were remitted as soon as possible after the Companies identified them. The DOL considers this a prohibited transaction and may impose penalties on the Plan sponsor as a result of this transaction.

NOTE 10 - PLAN OPERATIONAL ERROR

During 2020, the plan sponsor did not remit certain contributions in accordance with Plan provisions, resulting in missed salary deferrals and corresponding matching contributions. The plan sponsor has elected to make qualified non-elective contributions and matching contributions for all participants that require corrective action from the Plan's inception, January 1, 2018. The qualified non-elective contributions have not been funded as of December 16, 2024. These financial statements do not include any adjustments that may be necessary as a result of these transactions.

NOTE 11 - EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants totaling \$13,000 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions as of December 31, 2023. The Plan distributed the excess contributions to the applicable participants in the subsequent Plan year.
