### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of True North Transportation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of True North Transportation 401(k) Plan 's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

## **Basis for Opinion**

**NOTE A - BENEFIT PLAN DESCRIPTION**

The following description of the True North Transportation ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. In order to be eligible to participate in the Plan, an employee must be employed in a position which is not covered by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining. All employees covered by the Plan as of October 18, 2023, the date of the most recent Plan amendment, become eligible to participate in the plan on the first day of each month coincident with or next following the date you attain age 21 and you complete 3 months of eligibility service, provided that you are an eligible employee at the end of that period.
2. *Contributions.* Participants may elect to contribute a specific percentage or dollar amount of their compensation, as defined in the Plan document, to the Plan. Participant contributions may not exceed the Internal Revenue Service annual limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans. Additional after-tax voluntary contributions are not allowed. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Company may contribute to the Plan an amount of matching contributions determined by the Company at its discretion. No matching contributions were made for 2024. Additional discretionary non-elective contributions may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations. There were \$9,931 of discretionary contributions contributed in 2024.
3. *Participant Accounts.* Each participant account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's account.
4. *Vesting.* Participants are immediately vested in their contributions and earnings thereon. Vesting in the Company's matching and discretionary contributions to their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.
5. *Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their account balance. A participant may not have more than one outstanding loan at any one time. The loans are secured by the balance in the participant's account. Interest on the loans is calculated at the prime lending rate quoted in the Wall Street Journal at the time the loan is issued plus 1%. Principal and interest is paid ratably through payroll deductions.
6. *Payment of Benefits.* On termination of service due to death, disability, termination or retirement, a participant may elect to receive either a lump-sum directly to them, a rollover to an IRA in an amount equal to the value of the participant's vested interest in his or her account, or installments over a period of not more than your assumed life expectancy (or you and your beneficiary's assumed life expectancies). If your vested benefit in the Plan does not exceed \$5,000, then your benefit must be distributed to you in a single lump-sum payment or rolled over into an IRA. All vested benefits of \$1,000 or less are distributed in a lump-sum.

7. *Plan Termination.* Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the affected participants' accounts shall become 100% vested and not be subject to forfeiture. The employer shall direct the distribution of the assets of the trust fund to participants in a manner which is consistent with and satisfies the provisions of the plan document.
8. *Forfeited Accounts.* Upon termination of employment, participants forfeit their non-vested balances. Forfeitures are used to reduce employer matching and non-elective contributions, or administrative expenses, as determined by the Company at its sole discretion. For the year ended December 31, 2024, forfeitures balances were \$1,228.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

1. *Basis of Accounting.* The financial statements of the Plan are prepared using the accrual basis of accounting.
2. *Payment of Benefits* – Benefits are recorded when paid.
3. *Use of Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
4. *Investment Valuation and Income Recognition.* The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

5. *Notes Receivable from Participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.
6. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

7. *Risk and Uncertainties.* The Plan invests in various investment securities. Investments in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
8. *Date of Management's Review of Subsequent Events.* The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE C – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the trustee of the Plan).

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and have the highest priority. **NOTE D – FAIR VALUE MEASUREMENTS (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE D – NONPARTICIPANT-DIRECTED INVESTMENTS**

The Plan does not have nonparticipant-directed investments.

**NOTE E – GROUP ANNUITY CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY**

In 2022, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by National, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE F – PLAN MERGER**

Effective January 1, 2024, the Transport 21, Inc. 401(k) Plan merged into the True North Transportation 401(k) Plan. The Plan approved an amendment to terminate, liquidate and convert assets to the investment vehicles held by True North Transportation 401(k) Plan. An aggregate of \$3,052,928 was rolled into the Plan during the year ended December 31, 2024, and is shown as Assets transferred to the Plan on the statement of changes in net assets available for benefits.

**NOTE G – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts managed by Principal Life Insurance Company, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$42,732 for the year ended December 31, 2024.

These transactions are exempt party-in-interest transactions under ERISA.

**NOTE F - TAX STATUS**

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed is in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan's tax counsel believe that the plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
