**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Jim Beam Brands Company Union 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE A - DESCRIPTION OF PLAN**

***General***

The Jim Beam Brands Company Union 401(k) Plan (the “Plan”) is designed to encourage and facilitate systematic retirement savings and investment by eligible union employees of Jim Beam Brands Co. and Cruzan Viril, Ltd., subsidiaries of Suntory Global Spirits, Inc. (formerly Beam Suntory Inc. prior to May 2024) (collectively the “Company”). The following provides a brief description of the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which is available from the Plan Administrator.

The Plan is a tax-qualified defined contribution retirement plan intended to comply with Section 401(k) of the Internal Revenue Code of 1986, as amended (the “Code”). The Plan is subject to various provisions of the Code and the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The assets of the Plan are held in the Jim Beam Brands Co Union 401(k) Plan Trust (the “Trust”). Fidelity Management Trust Company (“Fidelity” or the “Trustee”) serves as the trustee of the Trust.

The Plan covers non-salaried, union employees of the Company who are at least 18 years of age. In general, employees are eligible for benefits on the date of hire or transfer to the Company, except for certain collective bargaining employees for which the effective date is defined in the Plan document.

***Contributions***

Contributions are held by the Trustee and accumulated in individual participant accounts. Pursuant to the terms of the Plan, participants may make tax deferred contributions under Section 401(k) of the Code and catch-up contributions that may not exceed 50% of “eligible compensation” (as defined under the Plan), subject to lower limits for “highly compensated employees” (as defined under the Code) who participate in the Plan. Participants’ annual tax deferred contributions are limited by the Code to \$23,000 and \$22,500 in 2024 and 2023, respectively. In addition, during the year in which a participant attains age 50 and in subsequent years, the participant may elect additional, pretax “catch-up” contributions of up to \$7,500 in 2024 and 2023.

Participants that are eligible to make tax deferred contributions, may roll over balances from another eligible tax qualified retirement plan or individual retirement account into the Plan.

Eligible employees who have neither enrolled in the Plan nor affirmatively declined enrollment in the Plan become automatically enrolled in the Plan and are deemed to have elected to make tax deferred contributions equal to 7% of their eligible compensation. The automatic deferral election applies to all eligible employees unless otherwise elected by the participant. Participants can change their contribution rate at any time.

The Company provides a matching contribution and a non-elective employer contribution to participant accounts as defined by the Plan. The Company makes non-discretionary matching contributions to the accounts of eligible employees in an amount equal to 50% of deferral contributions not in excess of 14% of eligible compensation during each payroll period.

***Participant Accounts***

Participants may direct the investment of their accounts in the available investment funds under the Plan. If a participant does not make an investment election, it will be deemed that the age-appropriate Fidelity Freedom Fund (Target Date Fund) is selected.

Participant account balances are maintained to reflect each participant’s beneficial interest in each of the investment funds available under the Plan. Participant account balances are increased by Company and participant contributions (including rollovers from other plans) and decreased by the amount of withdrawals and distributions as well as certain fees charged to participants’ accounts. Income and losses on plan assets are allocated to participants’ accounts based on the ratio of each participant’s account balance invested in an investment fund to the total of all participants’ account balances invested in that fund as of the preceding valuation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting and Forfeitures***

Participants are immediately vested in their contributions and rollover contributions plus earnings on those contributions. Participants are vested in Company contributions and earnings as outlined below. If a participant becomes disabled or dies while employed by the Company, the participant becomes 100% vested in his or her total account balance.

Any amounts forfeited will be used to pay administrative expenses and then to reduce future employer contributions. As of December 31, 2024 and 2023, the forfeiture account balance totaled approximately \$14,000 and \$42, respectively. During 2024, approximately \$34,400 of forfeited non-vested accounts were used to pay plan expenses and no forfeitures were used to reduce employer contributions.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. The term of any loan shall not exceed five years, unless the loan is related to the purchase of the participant's principal residence for which the term is ten years. A participant may only have one loan outstanding at any given time. The loans are collateralized by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator based on prevailing interest rates. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Benefits are payable from a participant's account under the Plan's provisions upon a participant's death, retirement, permanent disability or termination of employment in a lump sum or in installment payments. The Plan also permits withdrawals by participants who have incurred a "hardship" as defined in the Plan or who have attained age 59½. Vested balances less than \$1,000 are distributed as a lump sum and do not require participant's consent.

***Transfers***

When an employee's coverage under a collective bargaining agreement changes, but the employee is continuing employment with the Company, a transfer occurs between the Plan and the Beam Suntory Retirement Savings Plan ("Savings Plan"), a separate plan sponsored by the Company for employees not covered under collective bargaining agreements. The change in coverage under a collective bargaining agreement also changes the employee's eligibility under the respective plan in which the employee is participating at the time of the change. The change in the participant's eligibility requires a transfer of the participant's account balance to the respective plan under which the participant is eligible after the change. There were no transfers between the plans during 2024.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of the Plan's financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets

available for Plan benefits at the date of the financial statements and the changes in net assets available for Plan benefits during the reporting period and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments***

The Plan's investments are reflected at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date in the principal or most advantageous market for the asset or liability. Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. See Note D for discussion of fair value measurements.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Investment Income (Loss)***

Security transactions are accounted for on the trade-date basis. Dividend income is accrued on the ex-dividend date. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

***Payment of Benefits***

Distributions and withdrawals are recorded when paid.

***Administrative Expenses***

Investment related expenses are included in net appreciation (depreciation) in fair value of investments recorded in the accompanying statement of changes in net assets available for benefits. All other expenses are paid by the Plan or the Company at the Company's discretion, except for individual participant transaction-based fees.

**NOTE C - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE D – FAIR VALUE MEASUREMENTS**

The Plan uses a three-tiered hierarchy of inputs to establish a classification of fair value measurements for disclosure purposes. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, including:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the assets or liabilities.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs are unobservable for the asset or liability (including the entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability) and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Plan Management uses the following methods and significant assumptions to estimate fair value of investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: are valued at the quoted net asset value of the shares held by the Plan at year end, which is obtained from an active market.

Collective trust fund: Valued at the net asset value (“NAV”) of units of each bank collective trust. The NAV, as provided by the trustee of each collective trust fund, is used as a practical expedient and is based on the fair value of the underlying investments held by the funds less their liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor generally reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Full redemption from these funds is permitted with 30-days’ notice. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.
