Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 401(k) Profit Sharing Plan of Family & Children's Center, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the 401(k) Profit Sharing Plan of Family & Children's Center, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Family & Children's Center, Inc. and its affiliates (the Organization) who have attained age 21. Employees are eligible to contribute on the first day of the month following employment. Organization contributions begin after the employee has completed one year of service, at least 1,000 hours of service, and attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may contribute the maximum percentage allowable, subject to certain limitations, to the extent such percentage does not result in their contributions exceeding the annual dollar limits established by law (generally \$23,000 and \$22,500 in 2024 and 2023, respectively) or the maximum annual additions limit (the lesser of 100% of compensation or \$69,000 in 2024 and \$66,000 in 2023 of both participant and Organization contributions). Participants may also contribute amounts representing eligible rollover contributions from other qualified plans. Participants may elect to make Roth contributions on an after-tax basis. The Plan also allows for catch-up contributions for those age 50 and over during the Plan year, subject to certain limitations. The Organization makes an employer-base contribution to the Plan, equal to 5% of eligible compensation as defined by the Plan and whether or not the participant has made contributions.

Participant Accounts:

Each participant's account is credited with the participant's contributions, allocations of the Organization's contributions, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Participant accounts are charged administrative expenses for specific participant transactions. The benefit to which a participant is entitled is the vested amount that can be distributed from the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers an interest accumulation account and pooled separate accounts as investment options for participants.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts, plus earnings thereon is based on years of continuous service. Participants hired before January 1, 1990 are vested 100% in the Organization's contribution portions. Participants hired on or after that date begin to vest after two years of service at a rate of 25% per year and are fully vested after five years of service.

Payment of Benefits:

On termination of service due to death, disability, separation, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. In-Service distributions and hardship withdrawals, as defined by the Plan, are not allowed from all types of contributions.

Forfeitures:

Unapplied forfeited non-vested accounts totaled \$-0- and \$1,200 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts of approximately \$3,100 and \$9,800, respectively, were used to reduce employer contributions.

Notes Receivable from Participants:

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a fixed rate determined at issuance based on the bank's prime rate. The effective interest rates were approximately 8.24% and 7.85% at December 31, 2024 and December 31, 2023, respectively. The notes are repaid ratably through payroll deductions over a period of one to five years, unless used for the purchase of a primary residence.

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at either December 31, 2024 or 2023. Notes receivable from participants that are in default as provided in the plan document are treated as deemed distributions for tax purposes and also reported as such on the Form 5500. Management has determined these notes in default as uncollectable. For the years ended December 31, 2024 and 2023, there were no notes receivable from participants in default that were deemed to be uncollectable and written off.

Administrative Expenses:

Certain administrative expenses of the Plan are paid directly by the Organization and excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date.

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level II – Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, other inputs that are observable, or can be corroborated by observable market data.

Level III – Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

Pooled Separate Accounts:

Value based on the underlying investments (primarily mutual funds). While the underlying asset values are based on quoted prices, the net asset value (NAV) of the separate accounts is not publicly quoted. The NAV is reported by the custodian as of the financial statement date based on recent transaction prices of the underlying funds. The separate accounts held by the Plan provide for redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

Mutual funds:

Investments in mutual funds are valued based on their publicly quoted net asset values (NAVs) as of the financial statement date. These funds are registered investment companies regulated by the

Securities and Exchange Commission (SEC). The NAVs are readily available and reflect the fair value of the shares held by the Plan.

Common collective trusts:

Common collective trusts (CITs) are pooled investment vehicles maintained by banks or trust companies and are not registered with the SEC. The Plan's investments in CITs are valued at the net asset value (NAV) provided by the trustee or custodian as of the financial statement date. The NAV is based on the fair value of the underlying assets held by the CIT.

Guaranteed Investment Contracts:

The Plan's investment in the guaranteed investment contracts, an investment option under the group annuity contract with Principal Life Insurance Company (Principal) after May 31, 2024, is considered to be fully-benefit responsive by the issuer due to certain characteristics of the contract. Fully-benefit responsive contracts held by a defined contribution plan are required to be reported at contract value. Contract value represents contributions made under the contract, plus interest at a specified rate determined periodically by Principal, minus withdrawals and charges as specified in the contract. The account does provide for a minimum guaranteed interest rate. The rate was 4.75% at December 31, 2024. These contracts have surrender charges if they are terminated by the contract holder or a plan terminates its interest in such contracts within certain time periods. If a contract is terminating and a surrender charge applies, the plan may no longer be deemed benefit-responsive, which could require the guaranteed investment contract to be reported at fair value.

Interest Accumulation Account:

The Plan's investment in the interest accumulation account, an investment option under the group annuity contract with Mutual of America Life Insurance Company (MOA) through May 31, 2024, is considered to be non-benefit responsive by the issuer due to certain characteristics of the contract. Non-benefit responsive contracts held by a defined contribution plan are required to be reported at fair value. However, the contract is reported at contract value, which approximates fair value. Contract value represents contributions made under the contract, plus interest at a specified rate determined periodically by MOA, minus withdrawals and charges as specified in the contract. MOA maintains contributions to the account in the general account of the insurance company. The contract does not provide for a defined maturity date, and participant withdrawals from the account are not subject to any market value adjustment. The account does not provide for a minimum guaranteed interest rate. The crediting interest rate was 1.60% at December 31, 2023.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchased and sales of investments are recorded on a trade date basis; interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold, as well as held, during the period.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded.

Payment of Benefits:

Benefits are recorded when paid.

Risks and Uncertainties:

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in their values will occur in the near term and such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in securities of U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those securities of comparable U.S. companies.

Subsequent Events:

The Plan's policy is to evaluate all events or transactions that occur from the year-end date through the date of the issuance of the Plan's financial statements. The Plan has evaluated the period from January 1, 2025 through October 8, 2025, the date the Plan's financial statements were available for issuance, for subsequent events requiring recognition or disclosure in the financial statements.

NOTE 5. PARTY-IN-INTEREST AND NONEXEMPT TRANSACTIONS

Certain Plan investments are investment funds managed by Principal or MOA (Custodians). The Custodians are trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan paid administrative fees of \$15,349 and \$806 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6. TRANSFER OF PLAN ASSETS TO ANOTHER PLAN

Effective April 1, 2024, Boys and Girls Club of Northern Indiana, Inc., an affiliate, established a new 401(k) plan. This new plan is a result of a plan split from the 401(k) Profit Sharing Plan of Family & Children's Center, Inc. and will operate under the Mutual of America Financial Group Non-Standardized Defined Contribution Pre-Approved Plan. The Boys and Girls Club of Northern Indiana, Inc. 401(k) Plan includes provisions for elective deferrals, Roth elective deferrals, employer matching contributions, employer nonelective contributions, and rollover contributions. The plan is designed to comply with all relevant legislative and regulatory requirements, ensuring that employees have access to retirement savings opportunities. The amounts transferred from the 401(k) Profit Sharing Plan of

Family & Children’s Center, Inc. on April 1, 2024 was \$424,832. Through April 1, 2024, employee and employer contributions from Boys and Girls Club of Northern Indiana, Inc. were approximately 67% of total contributions to the Plan. For the year ended December 31, 2023, employee and employer contributions from Boys and Girls Club were approximately 70% of total contributions to the Plan.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants’ accounts will become fully vested.

NOTE 8. INCOME TAX STATUS

The Prototype Plan received an opinion letter dated November 18, 2004, stating it is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has adopted the Mutual of America Life Insurance Company Prototype 401(k) Profit-Sharing Plan Basic Plan Document No. 01. The Plan has since been amended; however, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
